Senior Management Analyst Nancy Nelson introduced the item.

Interim Deputy Chief Tim Booth provided an overview of services provided by the East Vallejo Fire Protection District (EVFPD) during Quarter 2 of FY2025/26.

In response to a question from Chair Mashburn regarding any planned mitigations to help protect the public in the White Slough area where there is a large homeless encampment, Interim Deputy Chief Booth stated he is unaware of a plan at this time. He further stated some of the property owners placed much of the refuse that was on the property into a pile and set it on fire, which the EVFPD did respond to, but ultimately decided the best course of action was to allow it to burn itself out. Interim Deputy Chief Booth further stated, he is aware that there are safety issues in that area not only for the public but also for first responders.

Supervisor Mashburn stated he believes the County needs to focus on this area and if not full mitigation at least to have a plan in place should there be a catastrophic event that happens.

In response to Supervisor Mashburn's comments, Supervisor James stated there have been ongoing conversations between the Vallejo City Council, the Vallejo Sand and Wastewater District, and the County Street Intervention Outreach Team to come up with a plan to address the concerns and issues related to White Slough. Supervisor James further stated should the Board desire to take any action, it should first reach out to the Vallejo City Council and request that they take the lead but include the County in any actions taken.

In response to a question from Supervisor Williams regarding if there are safety concerns if Board Members want to take a tour of the area, Interim Deputy Chief Booth stated yes there are safety concerns, noting any Board Member wanting to do a tour should take protection with them.

In response to a question from Supervisor Williams regarding if mental health services have been offered to the inhabitants of the homeless encampment at White Slough, Supervisor James stated yes, a couple of weeks ago there was a collaborated effort between the Street Intervention Outreach Team, CANB, Caminar, and the County's Behavioral Health for homelessness team to visit the area and work with the inhabitants. Supervisor James further stated the Sheriff or Vallejo Police Department do accompany staff during visits.

Interim Chief Alfred Abruzzini provided an overview of services provided by the Vacaville Fire Protection District during Quarter 2 of FY2025/26.

In response to a question from Supervisor Mashburn regarding what "other responses" means, noting that the number of "other responses" is significantly more than the other districts, Interim Chief Abruzzini stated calls that deal with lift assistance in private homes and care facilities as well as fire alarms that are not related to an actual fire are placed in this category. Interim Chief Abruzzini further stated there is a larger population in Vacaville, therefore there is a larger amount of those types of calls.

In response to a question from Supervisor Williams regarding organization charts for the districts and the potential consolidation of the districts, Interim Chief Abruzzini stated he will provide Supervisor Williams with organization charts for each district and further stated staff is still working through the steps of consolidating the districts into one.

Supervisor James further commented that Sheriff services have begun in Vallejo, thanking the Board for their approval of this service and noting the added deputies will strengthen police coverage, improve response time, and enhance overall community safety. Supervisor James further stated she will be holding a series of community engagement meetings in the First District, noting the first one will be Thursday, January 29, 2026.

B) Supervisor Williams requested that this meeting of the Solano County Board of Supervisors be adjourned in memory of Sharon MaupinTonnesen. Supervisor Williams further stated she will be holding a town hall meeting on February 5, 2026 from 1:30 p.m. to 2:30 p.m. at Solano Community College in partnership with the Associated Student Government.

D) Supervisor Mashburn provided an update on actions of the Delta Counties Coalition (DCC) in relation to the California Forever request to designate multiple counties in the region as maritime industrial zones, noting that the DCC did not have anything to do with the request, nor were the other counties made aware of the request prior to the press release.
