Chair Vasquez invited members of the public to address the Board on matters not listed on the agenda but within the subject matter jurisdiction of the Board. The following comments were received:

A) Winona Matley spoke in support of the Board addressing the feral cat situation in Solano County, specifically Vallejo.

B) George Guynn, Jr. spoke in opposition to additional federal spending of tax dollars.

C) Charlotte Hill spoke in support of the Board addressing the feral cat situation in Vallejo.

D) Kristin Cisneros spoke about concerns over the current homeless situation in Fairfield, CA and the clearing out of homeless encampments.

E) Ebony Robinson spoke in support of Solano County providing more work at home availability for Solano County employees.

F) Nicole Garcia spoke in support of Solano County providing more work at home availability for Solano County employees.

Supervisor Hannigan spoke about a potential trap and release program the Sheriff's Director of Animal Care/Animal Control were considering. Supervisor Hannigan further stated the program would provide \$100 vouchers for neuter/spay of feral animals; however, Animal Care staff are looking for vets willing to provide the service for that price. Supervisor Hannigan requested staff from the Sheriff's office return with a report on the status of the program.

Chair Vasquez seconded Supervisor Hannigan's request, noting animal care/services is a partnership with the seven cities, and it is not solely the County's responsibility.

Principal Planner Matthew Walsh introduced the item.

Chair Vasquez provided an overview on the history of the County's involvement in the San Francisco Bay Conservation and Development Commission (BCDC) noting that rising sea levels will affect Solano County because both the Bay and the Delta are within its borders.

BCDC Executive Director Larry Goldzband thanked Chair Vasquez and Supervisor Sperring for their continued involvement in the BCDC.

BCDC Director of Planning Jessica Fain provided an overview of the San Francisco Bay Conservation and Development Commissions (BCDC) efforts to address sea level rise in the Bay Area.

Supervisor Sperring spoke in support of the recommended action, noting BCDC has worked to bring the various agencies from the Bay Area together to develop a regional strategy.

In response to a question from Supervisor Brown, Ms. Fain stated the State passed a historic climate resilience budget in the past year, noting they are working to obtain a portion of that funding.

In response to a question from Supervisor Brown regarding past discussions on funding, Mr. Goldzband recommended Solano County work with other Bay Area Counties and CSAC to bring forth a region wide proposal to the legislature.

In response to a question from Supervisor Hannigan, Ms. Fain stated BCDC has no specific plan to address this item with Solano County cities, noting BCDC would appreciate any additional support the County could provide for connecting with the cities.

In response to comments from Supervisor Hannigan, Mr. Goldzband recommended a presentation (from BCDC) be given to the Mayor's committee.

Chair Vasquez stated the presentation could be provided at a 4C's meeting, while also inviting City Council Members and staff.

Chair Vasquez invited members of the public to address the Board on this matter and the following comments were received:

A) George Guynn, Jr., spoke about issues within Suisun City regarding a section of the downtown area waterway that needs to be dredged regularly, noting it has not happened recently, nor has funding been allocated for it by the City of Suisun City Council.

Senior Management Analyst Matthew Davis provided an overview of the January 18, 2022 Legislative Committee meeting and recommended actions.

Supervisor Hannigan stated the Director of Health and Social Services Jerry Huber provided information that Napa County is in support of SB842, further stating this bill might provide coverage for the collection, cleaning, and redistribution of equipment by a local nonprofit or senior center.

State Legislative Advocate Karen Lange stated she will reach out to the entity that is currently running Napa County's program to inquire if they are looking to expand into other counties.

By consensus of the Board, it was decided to take a watch stance on SB842.

Mr. Davis provided an overview of the Water Resource Development Act of 2020 (WRDA 2020).

Supervisor Spering asked if the decision is to support the bill regardless of if the requested amendments are made.

Department of Resource Management staff, Misty Kaltreider, from the Water and Natural Resources section spoke in support of the item, noting Solano County is currently working with 15 other agencies to create a master plan for the region.

County Administrator Birgitta Corsello stated the Board has already supported this legislation because it was adopted in 2020; noting it is the amendments that are being proposed for support.

On motion of Supervisor Hannigan, seconded by Supervisor Spering, the Board approved a letter of support on the proposed amendments to the WRDA 2020 bill. So ordered by a 5-0 vote.

Mr. Davis provided an overview of the recommended action to approve the 2022 Legislative Committee meeting calendar.

On motion of Supervisor Hannigan, seconded by Supervisor Spering, the Board approved the 2022 Legislative Committee meeting calendar. So ordered by a 5-0 vote.

Federal legislative advocates Joe Krahn and Tom Joseph provided information on federal legislation of interest to the County.

In response to a question by Supervisor Spering, Mr. Krahn stated Congress had been in discussions on Medicare and Social Security solvency pre-inflation, noting he believes it will be addressed as part of an ongoing discussion in Washington around the proposed Build Back Better legislation.

Mr. Joseph stated at this time inflation is more of a political discussion than a policy discussion.

Supervisor Spering requested the legislative advocates speak with members of congress that inflation is a major concern for the population of Solano County.

State Legislative Advocate Karen Lange provided an update on information on state legislation of interest to the County.

In response to a question from Chair Vasquez, Ms. Lange stated she does not believe that when Proposition 47 was adopted with certain value limits, it was considered that there would be group thefts; however, because it was a

state proposition, it will have to be voted on by the people if it is changed.

Ms. Lange noted the Governor's office has made an announcement that they have reached a deal on another COVID relief program, which will most likely include more testing resources, more funding to deal with the most recent surge, reinstatement of 40 hours of paid time off for COVID related illness for employees who work for businesses that employ over twenty five people retroactive to January 1, 2022, and an inclusion of the net operating loss favorable tax treatment that businesses were seeking and a research and development tax credit.

In response to a question from Supervisor Brown, Ms. Lange stated the County would need to see reimbursement for the Special Vacancy Election for AD #11 through a budget trailer bill, noting however that Solano County is in good company since Los Angeles County, San Francisco County, and Shasta County are all holding special elections. Ms. Lange stated she will work on a letter requesting support for the reimbursement.

Chair Vasquez invited members of the public to address the Board on this matter. There was no public comment.

Legislative, Intergovernmental, and Public Affairs Officer Michelle Heppner introduced the item and recommended action.

Supervisor Mashburn thanked the Board for its consideration of the Rural County Representatives of California (RCRC) membership application, noting while the County has some suburban areas, it is largely rural in nature. Supervisor Mashburn further stated the County will benefit from having a united voice with both RCRC and the other rural counties to advocate for the issues that are significant to rural governments.

Supervisor Hannigan spoke in support of the membership and for the appointment of Chair Vasquez and Supervisor Mashburn as representatives

to the RCRC Board.

Registrar of Voters (ROV) and Chief Information Officer Tim Flanagan introduced the item and provided an overview of the expected changes for the upcoming 2022 election season.

In response to a question from Chair Vasquez, Mr. Flanagan stated the ROV office has the data to show which polling places are experiencing large in-person turnouts and which ones are not. Mr. Flanagan further stated if the Board were to direct ROV staff to move into a smaller footprint of in-person polling places, staff would use the data that it has to choose where to consolidate to minimize the impact to the voters, noting he would expect staff to provide a robust communication on the expected changes to those regions.

Assistant Registrar of Voters John Gardner provided an overview of the possible outcomes of a reduction in in-person polling locations.

In response to a question from Supervisor Hannigan, Mr. Gardner stated polling places are chosen to be as close to the neighborhood whenever possible, but sometimes staff is hindered by what locations they can use that meet state regulations.

In response to a question from Chair Vasquez, Mr. Gardner indicated there are a few in-person polling places in the unincorporated areas of the County in two of the options; however, there are not many voters assigned to those places.

Mr. Flannagan stated the County is required by law to have additional drop boxes open prior to the election and to have one permanently affixed drop box open 29 days prior to the election.

Chair Vasquez invited members of the public to address the Board on this

matter and the following comments were received:

A) George Guynn, Jr., commented on the expected cost for a special election and in support of a reduction in in-person polling places.

Supervisor Brown commented on the expected cost and voiced concerns over the loss of more in-person polling places. Supervisor Brown inquired if there could be a step down in the reduction of in-person polling places with the option to add more places in a later election if it is felt the step down was too drastic.

In response to Supervisor Brown's comments, Mr Gardner stated while the County can shrink and expand the polling places on an election by election basis, the County is limited in where it can set polling places based on availability of suitable locations.

In response to comments by Supervisor Brown, Mr. Flanagan stated they will develop a media strategy to address the changes once they have direction from Board; however, he expects staff will utilize every communication type possible to help the public avoid confusion.

Supervisor Hannigan made comments in support of a reduction of in-person polling places based on the data provided; however, she recommended taking baby steps with the reduction.

Supervisor Mashburn spoke in support of the reduction of in-person polling places and recommended those reductions take place over one election cycle in the year 2022 with a final reduction down to 50 polling places by November 2022.

Supervisor Mashburn made a motion to reduce in-person polling places to 70 for the June 2022 Primary Election and 50 in-person polling places for the November 2022 General Election.

In response to a question from Supervisor Mashburn, Mr. Flanagan stated staff could report back in 6 weeks after the June Primary Election on the outcome of the reduction in polling places before the November General Election.

Supervisor Spering spoke in support of a full reduction of in-person polling places, stating he would take the funds saved by the reduction in polling places and use it to educate the public.

In response to comments made by Supervisor Spering, Mr. Flanagan stated the Registrar of Voters office has robust security in place, noting a vote by mail envelope is uniquely coded to an individual voter and goes through vote by mail signature verification to ensure it is a valid ballot.

Supervisor Mashburn recommended the Board consider a step down in the reduction of in-person polling places between each election, starting with 80, then reducing to 70, and then finally 50 with a report from the Registrar of

Voters office on the impacts between each reduction.

Supervisor Sperring spoke in support of option e, recommending a reduction to 50 in- person polling places for all the elections.

Supervisor Brown spoke in opposition to option e, and recommended option c with a reduction to 80 in-person polling places, with a further reduction to 70 in-person polling places for the following election with a report from staff in July 2022 on the impacts of the reduction.

In response to a question from Supervisor Hannigan, Mr. Gardner stated roughly 20% of in-person polling places have a turnout of 100 people or less.

Chair Vasquez invited members of the public to address the Board on this matter. There was no public comment.

Chair Vasquez spoke in support of option c, with a reduction to 70 in-person polling places with a reduction to 50 in-person polling places in November 2022.

In response to a question from Supervisor Hannigan, Mr. Gardner stated he would recommend the number for the April 2022 Special Election and the June 2022 Primary Election be reduced to 70 and then following a report back on the impacts of the reductions to the Board in July 2022, a reduction to 50 in-person polling places in November 2022.

On motion of Supervisor Mashburn, seconded by Supervisor Hannigan the Board: 1) approved a reduction of in-person polling sites to 70 polling locations for the April 2022 Special Election, 70 in-person polling locations for the 2022 Primary Election, and a recommendation for a reduction to 50 locations for the 2022 General Election, with a report to the Board in July 2022 on the findings and impacts of the original reductions. So ordered by 5-0 vote

On motion of Supervisor Hannigan, seconded by Chair Vasquez the Board authorized an increase in appropriations for an amount not to exceed \$776,000 to conduct the Special Vacancy Primary Election for Assembly District 11 on Tuesday, April 5, 2022, So ordered by 5-0 vote.




