

## NOTICE OF PUBLIC HEARING TO INITIATE PROPERTY TAX LIEN PROCEEDINGS TO SECURE COLLECTION FOR UNPAID SERVICES OF GARBAGE, RECYCLABLES, AND ORGANICS IN UNINCORPORATED SOLANO COUNTY

Notice is hereby given that on July 22, 2025, the Solano County Board of Supervisors will meet in public session to conduct a noticed public hearing at 9:00 a.m., or as soon as possible as may be heard thereafter, in the Board of Supervisors Chamber located at 675 Texas Street, Fairfield CA, to initiate property tax lien proceedings to secure collection for unpaid services of garbage, recyclables, and organics in unincorporated Solano County. California Government Code section 25831 authorizes the Board of Supervisors to confirm the delinquent garbage accounts, constitute the delinquent amounts as special assessments, record liens against the affected real properties, and collect on the annual tax bill. The noticed public hearing allows property owners with delinquent accounts to object to, or protest, the delinquent amount(s). Phone: To submit comments verbally from your phone during the meeting, you may do so by dialing: 1 (415) 655-0001 and using Access Code 2632-043-6228 on your phone. No attendee ID number is required. Once entered in the meeting, you will be able to hear the meeting. Press \*3 to raise your hand when the public comment period is opened, and the Clerk will call on you to speak when it is time. The Board of Supervisors offers the opportunity to call in to this hearing as a courtesy to the public. If no member of the Board of Supervisors is attending the meeting via teleconference, and a technical error or outage occurs on the teleconference feed affecting the call in number, the Board of Supervisors will continue the hearing in public in the County Board of Supervisors' Chambers.

If you challenge the proposed consideration in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Board of Supervisors at, or prior to, the public hearing.
