Director of Resource Management James Bezek introduced the item.

Assistant Director of Resource Management Mathew Tuggle provided an overview of Traffic Order 438, which proposes establishing load limits on certain county roads to address increasing heavy truck traffic diverting from nearby highways. Mr. Tuggle stated trucks have been using local roads as shortcuts to avoid freeway congestion, resulting in pavement damage, safety concerns, and increased complaints from residents, cyclists, and maintenance crews. Mr. Tuggle further stated staff conducted engineering and traffic studies, including pavement condition reviews, accident data analysis, and roadway evaluations, to identify roads unsuitable for heavy truck

traffic, noting the proposed order would establish a seven-ton load limit on 18 identified roads, directing trucks to designated truck routes better designed to handle heavy vehicles while reducing damage and safety risks on smaller county roads.

In response to a question from Chair Brown regarding how the county will inform both residents and truck drivers about the new truck restrictions, including whether signage or other notices will indicate where trucks are prohibited and when residents should contact the California Highway Patrol if violations occur; Mr. Tuggle stated roads with load limits will have posted signage indicating the seven-ton restriction, with placards noting that agricultural trucks are exempt. Mr. Tuggle further stated complaints from residents can help trigger enforcement, and the California Highway Patrol will focus on trucks that attempt to bypass scales or violate the posted limits.

In response to a question from Supervisor Williams regarding installation of signage, Mr. Tuggle stated the load limits become enforceable once the traffic order is signed, though enforcement typically begins after signage is installed. He noted that sign installation may take about two months due to ordering and placement, and during that time the County will conduct outreach and notify partners such as the California Highway Patrol and the public through local organizations such as the Farm Bureau and the Sheriff's Department.

Chair Brown opened and closed the public hearing with no comments from the public.

In response to a question from Supervisor Mashburn regarding why certain eastern county roads, including McCormick Road near Rio Vista, were not included in the proposed load limit ordinance, Mr. Tuggle explained that staff focused on roads currently experiencing the most significant truck traffic. Mr. Tuggle further stated McCormick Road presents a unique situation because it is sometimes used as a relief route for Highway 12 and may ultimately need to function as a truck route once planned improvements are completed. Mr. Tuggle stated that additional load limits could be considered in the future as conditions change and as the County determines the long-term role of McCormick Road.
