## **RESOLUTION NO. 2025-**

## RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS RATIFYING THE CONTINUANCE OF THE LOCAL EMERGENCY DUE TO THE DECEMBER 2024 WINTER STORMS

**WHEREAS**, Government Code section 8630 and Solano County Code sections 7-12 (a) and (b) and 7-13 (a)(1), authorize the Solano County Administrator, acting as the Director of Emergency Services, to proclaim a local emergency as defined by Government Code section 8558, subdivision (c) when the Board of Supervisors is not in session; and

**WHEREAS**, on December 21, 2024, the Assistant County Administrator, Acting as the Director of Emergency Services, found that due to the December 2024 Winter Storms, which began on December 13, 2024, and King Tides, that conditions of extreme peril to life, property, and/or the environment existed in Solano County and proclaimed a local emergency; and

WHEREAS, at a special meeting on December 27, 2024, the Solano County Board of Supervisors confirmed and ratified the Proclamation of Local Emergency based on the conditions that continued to exist in Solano County under Government Code section 8630 and other applicable laws; and

**WHEREAS**, on February 25, 2025 and on April 22, 2025, the Solano County Board of Supervisors confirmed and continued the Proclamation of Local Emergency based on the conditions that continued to exist in Solano County under Government Code section 8630 and other applicable laws; and

WHEREAS, the recovery efforts are ongoing and therefore, warrant the continuation of the local emergency.

**NOW, THEREFORE, BE IT RESOLVED** the Solano County Board of Supervisors confirms the need to ratify the local emergency and continue the orders previously issued for the December 2024 Winter Storms; and

**BE IT FURTHER RESOLVED**, the Solano County Board of Supervisors shall review this confirmation of the Proclamation of Local Emergency within 60 days, to determine the need for continuing the local emergency or to proclaim the termination of the local emergency at the earliest possible date that conditions warrant.
