The Solano County Board of Supervisors met on the 10th day of February, 2026, in regular session in the Board of Supervisors' Chambers at the Solano County Government Center, 675 Texas Street, Fairfield, California at 9:01 A.M.

BOARD MEMBER COMMENTS AND REPORTS ON MEETINGS

Chair Brown invited members of the Board to make comments or reports on meetings. The following comments were received:

A) Supervisor Mashburn requested that this meeting of the Solano County Board of Supervisors be adjourned in memory of Diana Lee Gifford-Tuggle, Clifton Steven Santos, Dale James Fletcher, Ronald Wayne Burt, and Joe Martinez. Supervisor Mashburn further wished Supervisor John Vasquez a happy 75th birthday.

B) Supervisor James stated that the NAACP will host the Living Legends event on February 19, 2026 at 6:30 p.m., honoring six Vallejo residents, and announced an upcoming Shared Safety Vallejo Expungement Clinic and resource fair at the Veterans Memorial Building from 10:00 a.m. to 2:00 p.m., offering free legal services and second-chance employment opportunities. Supervisor James noted that this was the final scheduled meeting of the month due to upcoming travel with Supervisor Williams to Washington, D.C. for the NACo Legislative Conference to meet with federal representatives

regarding Solano County priorities. Supervisor James announced upcoming District 1 town halls in March, including one in North Vallejo and a Spanish-language town hall in support of the immigrant and Spanish-speaking community. In closing, Supervisor James acknowledged Black History Month, expressed appreciation for her unanimous election as Vice Chair as the first Black woman to hold the role, and shared personal remarks honoring her grandparents and her grandfather's birthday.

C) Supervisor Williams provided a report on a recent town hall meeting held February 5, 2026, at Solano Community College, hosted in collaboration with Solano Community College, Associated Students, and community partners. Supervisor Williams stated the town hall focused on immigration, health, and financial aid, and how immigration status impacts student access to services, with strong participation from the community. Supervisor Williams further stated attendance included more than 90 individuals in person and approximately 174 viewers online, providing an opportunity for youth and young adults to ask questions and receive information in a supportive environment. Supervisor Williams noted the event was streamed live on Facebook and remains available for public viewing, and she expressed appreciation to attendees and her staff for their efforts in making the event successful.

E) Chair Brown requested that this meeting of the Solano County Board of Supervisors be adjourned in memory of Beatrice Suarez.
