A) Supervisor James announced that her office will host a Spanish-language community service webinar featuring a panel on available resources and services regardless of immigration status. Supervisor James also provided clarification regarding the recent California State Association of Counties (CSAC) visit and tour in Solano County, explaining the planning process, attendees, and key discussion topics, which included workforce development, economic diversity, shipbuilding, and community safety. Supervisor James noted that scheduling conflicts limited the tour, though several key county sites were visited.

Supervisor James also reported meeting with local officials and community organizations to discuss potential impacts of a federal government shutdown on CalFresh recipients, citing a significant increase in food distribution needs countywide.

B) Supervisor Brown stated she voted.

C) Supervisor Williams reported hosting a town hall meeting focused on the "Big Beautiful Bill" and its impacts on County residents. Supervisor Williams stated multiple County departments participated to share information with the community, and her staff organized the event, including providing resources on local food access. Supervisor Williams announced that the next town hall will be held on November 18, 2025 at 5:30 p.m. at the Fairfield Civic Center Library, focusing on the bill's effects on health care and upcoming funding cuts, noting the event will include community partners, nonprofits, and County agencies, and is open to both the public and Board members.
