EXHIBIT A
SCOPE OF WORK

I. PROGRAM DESCRIPTION

Contractor will administer and provide timely and adequate Adult Residential Facility (ARF) licensing and program services at the Beck Diversion Project. Services will include intensive mental health treatment for justice-involved and participants experiencing homelessness in Solano County.

II. CONTRACTOR SHALL BE RESPONSIBLE FOR THE FOLLOWING:

1. PROGRAM SPECIFIC ACTIVITIES

Specific program activities include:

- A. Maintain Adult Residential Facility (ARF) licensure in good standing with the California Department of Social Services (CDSS), Community Care Licensing Division.
- B. Provide a safe and stable board and care atmosphere for up to thirty-two (32) adults at one time.
- C. Maintain Medi-Cal site certification through Solano County Behavioral Health Division.
- D. Provide services in accordance with all applicable licensing and certification regulations and standards, including on-site personnel 24 hours per day, 365 days per year.
- E. Using the Community Inclusion approach, proactively encourage and connect residents to the following opportunities, offering comprehensive wrap-around support to facilitate these linkages:
 - a. Education
 - b. Employment
 - c. Provide peer, family and/or community support and social activities
- F. Provide life skills education and Activities of Daily Living (ADL) training through both group and 1:1 format that may include but are not limited to personal hygiene and grooming, dressing, laundry, cooking, budgeting and shopping.
- G. Effectively interact with community agencies, other mental health programs and providers, natural support systems, and families to assist clients toward discharge and further independent living.
- H. Provide medication support services, as appropriate to licensing credential and scope of practice.
- I. Provide targeted case management to initiate linkage and referrals based on participant needs and case planning to community resources, including mental health providers, medical services, substance use services, temporary shelter or housing, etc. The service activities may also include but are not limited to, communication, coordination, and referral; monitoring service delivery to ensure patient access to service and the service delivery system; monitoring the member's progress; placement services and plan management
- J. Provide co-occurring Substance Use Disorder services in both individual and group formats. This can include, but is not limited to:
 - a. Use of Motivational Interviewing interventions
 - b. Facilitation of an evidence-based relapse prevention intervention, such as Seeking Safety groups.
 - c. Linkage of participants to outpatient substance use programs or withdrawal management programs, when appropriate.
 - d. Coordination of onsite Alcoholics Anonymous (AA) or Narcotics Anonymous (NA) meetings.

- e. Provide client psycho-education regarding the risks of opioid use; provide linkages to Medication Assisted Treatment (MAT) resources for clients with opioid or alcohol use disorders.
- f. Maintain a supply of Naloxone available on-site in all campus buildings to address the possibility of client opioid overdoses that occur while client is participating in the program.
- K. Crisis Intervention Services to include:
 - a. Collaboration with the County, local law enforcement, local emergency departments and the Crisis Stabilization Unit to provide continuity of care for participants experiencing a crisis.
 - b. Trained crisis intervention specialists conduct face-to-face crisis evaluations and interventions as needed to promote participant's ability to remain in the program before and after the crisis and support housing stability.
 - c. Utilizing de-escalation strategies to stabilize participants in crisis.
- L. Solano House Foundations Adult Residential Facility: Provide Medi-Cal eligible, Specialty mental health treatment services that incorporate the following:
 - a. Psychosocial rehabilitative models and cognitive-behavioral strategies;
 - b. Daily minimum service offerings which include two (2) to three (3) mental health groups and one (1) independent living skills activity, for example, psychoeducation, positive thinking, coping skills, sobriety, mindfulness, health, and nutrition, using resources, wellness plans, and communication skills;
 - c. Mental Health clinical counseling services as needed;
 - d. Include peer counselors as an important part of the milieu, as well as healthy meals, social engagement, and activities in the community.
 - i. Evidence-based practices aimed at facilitating exits to lower levels of care and reducing interface with the criminal justice system and other high-cost services. Permanent housing shall be defined as situations in which the participant holds a lease, rental agreement, or shared living arrangement in a residence which is not subject to time limits.
 - e. Offer participants individualized medication education, support and services in a collaborative manner with the goal of enabling clients to monitor their own medications.
 - f. Coordinate with the clients' psychiatry and primary care providers and assist the clients in following through with health care plans.
 - g. Communicate with participant's County mental health treatment staff at least monthly to update about the progress of each participant. Additionally, contractor shall perform quarterly interdisciplinary meetings to determine appropriate changes to the participant's treatment plan.
 - i. When emergent clinical concerns arise, initiate contact with participant's County mental health treatment staff (include the County team supervisor) for the purpose of collaborating on the development of a stabilization plan. County staff will initiate communication between the participants' psychiatric treatment provider as appropriate.
 - h. Offer treatment that may result in restoration of competency for individuals deemed Incompetent to Stand Trial (IST).
 - i. Use CARF approved assessment tool (for ages 18 and older) instrument with all participants at the required intervals of initial assessment and upon six (6) months of enrollment to determine treatment progress, areas of focus and support continued need for treatment or for treatment reduction or discharge.
- M. Solano House Endurance Adult Residential Facility: Supportive services, including group and participant activities, may be encouraged, but are not required prior to April 30, 2026. After April 30, 2026, Endurance clients may be required to participate in some form of

- outpatient or case management care. Contractor will offer and provide outpatient services as appropriate to Endurance clients who are not already connected to an outpatient treatment or case management program. Stage matched, motivational enhancement strategies will be used to help encourage individuals to engage in treatment, as needed.
- a. Prior to April 30, 2026, Participants in this program have an indefinite length of stay and their goal is ongoing housing stability, not graduation/exit.
 - i. For participants who become able and/or desiring to live in a more independent setting and who are not receiving mental health case management services, Contractor will assist with attempts to connect them to permanent housing.
 - b. Prior to April 30, 2026, Contractor will utilize the Housing First model set forth in California Welfare and Institutions Code Section 8255, including:
 - i. The immediate and primary focus is on helping participants quickly access and sustain housing followed by offering and/or linking to necessary services in the community to include mental and physical health, substance abuse, education, and employment.
 - ii. Services are informed by a harm-reduction philosophy that recognizes drug and alcohol use and addiction as a part of participants' lives, where tenants are engaged in nonjudgmental communication regarding drug and alcohol use, and where participants are offered education regarding how to avoid risky behaviors and engage in safer practices, as well as connected to evidence-based treatment if the participant so chooses.
 - iii. Services will reduce harm, and promote health, community and independence among tenants.
 - iv. Supportive services emphasize engagement and problem solving.
 - c. Assist participants with daily living skills (i.e. budgeting, maintaining clean bedrooms, conflict resolution, etc.), and linkage to other services, including mental health services, substance abuse treatment and alternative care.
 - d. For Endurance participants receiving outpatient services from Contractor, Contractor will use a CARF approved assessment tool (for ages 18 and older) instrument with participants at the required intervals of initial assessment and upon six (6) months of enrollment to determine treatment progress, areas of focus and support continued need for treatment or for treatment reduction or discharge.
- N. Ensure that all participants, in both Foundation and Endurance House, pay their monthly Room and Board tenancy fees.
- a. Coordinate with the Behavioral Health Patient Benefit Specialists (PBS) and/or the Employment and Eligibility (E&E) division to ensure that Endurance House participants who lack mental health case management services are fully connected to and guided through the process of securing eligible benefits, including General Assistance (GA) funding and/or Social Security disability insurance. Key activities include:
 - i. Tracking residents' benefit-related appointments and supporting residents with attending these appointments (e.g., offering appointment reminders);
 - ii. Accompanying and providing active support to residents during their GA interviews.
- O. Assisting residents understand, gather, and submit necessary documents for their benefit applications (e.g., birth certificates, social security card, etc.). Note that documents can be hand-submitted by walking the resident over to the E&E office, located on the Fairfield Health and Social Service campus. Provide early and consistent intervention with participants who are out of compliance with program rules or are exhibiting signs of unsafe behaviors in an effort to avoid escalating problems that lead to disruptions of the milieu and terminations in placement.

- P. In the event that a participant at risk of being asked to leave the program, Contractor shall notify the participant's mental health treatment team as well as the County Clinical Contract Manager or designee in order to try and stabilize the situation and avoid eviction.
- Q. Manage the following facility conditions:
 - a. When necessary, review outdoor security camera footage, which is locally stored for thirty (30) days.
 - b. Install and maintain wireless and internet, phone, network, and TV/cable services.
 - c. Locksmith/re-key participant's bedrooms and provide security badges (access control doors) to residents, clinical, and administrative staff as permissible.
 - i. Maintain documentation of security badge issuance
 - ii. Communicate with County Special Investigation Bureau (SIB) for security badge issuance, deactivation, and replenishment of supply.
 - iii. Replacement of lost/stolen badges will be at the actual expense of either the client or the specific staff member. Wear and tear or broken badges will be replaced at no charge (must have physical badge).
 - iv. Complete a County eSIR for any/all contractor staff or permanent residents lost/stolen badge.
 - d. Contractor is responsible for the day-to-day janitorial needs to ensure that the environment is clean and safe.
 - e. Install and Maintain fire suppression services for kitchen equipment.
 - f. Light maintenance, such as patching and paint touch-ups; routine cleaning/maintenance of the kitchen hoods; and monthly fire extinguisher inspections.
 - g. Notify County of any infrastructural and/or major facility maintenance needs.
 - i. Infrastructure is defined as the building structure including the major systems (e.g. electric, finishes, lighting, plumbing)
 - ii. Major maintenance is defined as any repair anticipated to cost more than \$1,000.
 - h. Contractor shall not add, modify or alter the existing building structure nor ground
 - i. County General Services Facility Staff will attend to work orders placed by level of criticality and resources available.

2. GENERAL ACTIVITIES

While providing the specific activities, Contractor agrees to:

- A. Provide mental health services that are strengths-based, person-centered, safe, effective, timely and equitable; supported by friends, family, and the community; with an emphasis on promoting whole health, wellness and recovery.
- B. Ensure that service frequency is individualized and based upon best practices related to the need of each participant and in accordance with the Solano County Behavioral Health Plan (BHP) level of care system.
- C. Make coordination of service care an integral part of service delivery which includes providing education and support to participants/family members as well as consulting with community partners including but not limited to: other behavioral health service providers, physical care providers, schools (if appropriate), etc.
- D. Maintain documentation/charting according to industry standards and strengths-based best practices. For all participants entered into the Solano County BHP electronic health record, Contractor shall adhere to documentation standards set forth by the BHP in accordance with Solano Behavioral Health trainings, practices and documentation manuals.
- E. Ensure that direct clinical services are provided by licensed, registered or waived clinicians or trained support counselors or peer specialists.
 - a. Assessment activities and mental health specialty treatment services.

- b. “Other Qualified Providers”, such as mental health specialist level staff or peer specialists, are authorized to bill for Medi-Cal reimbursable mental health services, such as targeted case management, rehabilitative services, collateral, or plan development
- c. If Contractor employs staff with less education than a BA in a mental health or social work field, and less experience than two (2) years in a mental health related field, the Contractor will provide and document training around any service activity for which the staff will be providing.
- F. Supervise unlicensed staff in accordance with Medi-Cal and the applicable California State Board guidelines and regulations.
- G. Utilize clinical outcome measures and level of care assignment tools prescribed by the County. Such measures and tools will remain in effect until County officially notifies Contractor of a change in practice. Contractor will work with County BHP Quality Improvement when implementing additional measures. County required measures include, but are not limited to:
 - a. Reaching Recovery, Recovery Needs Level 6.0 – Participants ages 21+.
 - b. Child and Adolescent Needs and Strengths (CANS) – Participants ages 18-20.
 - c. Additional or replacement measures as allowed and determined by the County BHP.
- H. Provide information (including brochures, postings in lobby, afterhours voicemail message, etc.) that communicates how mental health participants can access 24/7 services (e.g. crisis stabilization unit phone number, suicide prevention hotlines/text lines, and/or for full service partnership (FSP) program consumers the after-hours FSP warmline) when medically necessary.
- I. All media related to services provided through contract and provided to the public must include a reference to the Solano County Board of Supervisors, Health and Social Services and include the County logo.
- J. Representatives from the Contractor organization must make efforts to attend the monthly local Mental Health Advisory Board meeting, and participate in the community planning stakeholder meetings, including those for the BHSA annual update or Three-year plan, planning for housing services, suicide prevention planning, etc.

3. REFERRALS

- A. Target Population: Participants whose mental health condition was a contributor to behaviors that led to contact with the justice system and/or resulted in homelessness. Support individuals as they are released back into the community, when they are most likely to face housing issues and are at the highest risk of recidivism.
- B. Referral Sources:
 - a. **Solano House Foundations:** Referrals sources may include the crisis stabilization unit, Forensic Treatment Team, Full-Service Partnerships, inpatient hospital, Crisis Residential Treatment, Mental Health Rehabilitation Centers, the County jail, or other referral sources approved by the County.
 - i. Referrals shall be routed through the County Mental Health Forensic Housing Liaison; whose role includes verifying that eligibility criteria for Prop 47 are met.
 - a) Contractor shall strive to communicate by way of the Forensic Housing Liaison, who will act as the liaison to the referring party, when additional information or clarification about a referred individual is needed.
 - b) Foundations: all 16 beds will be bed-guarantees for clients meeting Prop 47 criteria through March 31, 2026.
 - c) Endurance: 6 of the 16 beds will be bed-guarantees for clients meeting Prop 47 criteria through March 31, 2026.
 - ii. Referrals from a Full Service Partnership (FSP) aside from those originating from the County Mental Health Sub Acute or Forensic Triage Team, will require

a Rental Subsidy Authorization request form be sent to institutioncareserv@solanocounty.gov for approval from the County.

- iii. **Timeliness:**
 - a) **Review of Referral Packet:** Upon receipt of a complete referral packet, containing all required documents/items from the referring party, Contractor shall have up to three (5) business days to thoroughly review the referrals and schedule the interview.
 - b. Contractor shall promptly communicate to the Forensic Housing Liaison any incomplete referral packets or missing required items. This proactive communication will facilitate the prompt provision of the needed information, minimizing any significant loss in time.
 - i. **Final Acceptance Decision:** Following the interview, Contractor shall make a final acceptance decision within twenty-four (24) business hours.
 - ii. **Offer of Admission Date:** Upon making the acceptance decision, Contractor shall promptly offer an admission date, striving to bring the client into the program within the next one (1) to three (3) business days (with the exception of potentially excluding Friday as an admission date – at the Contractor’s discretion).
 - c. If an accepted individual exhibits behavioral risk factors that Contractor believes can be mitigated with a safety plan upon admission, the creation of such a plan shall begin during intake as part of the initial treatment planning process. This process should not delay admission.
 - d. **Solano House Endurance:** Referrals must be received via the County’s Coordinated Entry system (CES), until April 30, 2026. After April 30, 2026, Program referral pattern is subject to change based upon operational need and funding source requirements. Contractor will collaborate with County to design new referral requirements.
 - e. CES staff utilize a countywide by-name list (BNL) of participants in the County currently experiencing homelessness. The BNL includes households that have completed Solano County’s standardized CES Assessment Tool (VI-SPDAT) and been entered into the County’s Homeless Management Information System (HMIS) for prioritizing and matching to specific housing resources. The BNL serves as a dynamic, always open registry of participants for this permanent supportive living program.
 - i. **Timeliness:**
 - a) Upon receiving the name of a referred individual from the CES provider, Contractor will promptly initiate contact attempts. Over a period of up to five (5-) to seven (7) business days, Contractor will make three (3) proactive attempts to reach out to the individual directly or their known case manager. Failure of the individual or case manager to respond to these attempts will result in automatic denial of the referral. Contractor will convey this disposition to Coordinated Entry and ensure the receipt of a subsequent referral.
 - b) When engaging with referred individuals from CES, Contractor will adhere to a Housing First approach, accepting referrals regardless of factors such as poor credit or zero income, lack of rental history, current substance use, or behaviors indicating a lack of "housing readiness.”
 - c) If a referred individual is not connected to a case management program, Contractor will actively work with the individual themselves to provide case management and other applicable outpatient services while assessing their suitability for an appropriate program. Contractor may request clinical documentation, such as psychosocial assessments, with the individual's consent. However, the absence of such documents will not impede Contractor's acceptance decision-making process.

- d) Efforts will be made to reach an acceptance decision for referred individuals within ten (10) to fifteen (15) business days of receiving their referrals. Once accepted, Contractor will diligently coordinate the admission process as promptly as possible.
 - e) For referred individuals without a case management provider, Contractor may provide these services directly while referring them to the County's homeless outreach service provider or other appropriate provider, to assist in obtaining necessary CCL intake documents (e.g., LIC602 form).
- C. Bed Availability Notifications:
- a. Provide notification as soon as possible to the County Mental Health Forensic Housing Liaison when an upcoming Foundation House bed vacancy is available or anticipated. Complete the Coordinated Entry System's Bed Tracker census for Endurance House on an ongoing weekly basis. Additionally, provide notification as soon as possible to the County Mental Health Forensic Housing Liaison when an upcoming Prop 47 bed at Endurance House is available or anticipated.

4. PERFORMANCE MEASURES

- A. Contractor shall meet the following performance measures:
- a. Foundation House
 - i. Serve at least sixteen (16) to twenty (20) participants per year.
 - ii. Transition 25% of participants to a lower level of care within nine (9) months and 75% within eighteen (18) months, with recommendations for step-downs offered by Contractor based on participants' clinical functioning and goals. No more than 20% of discharges will be to a locked setting, either hospital or incarceration.
 - b. Endurance House
 - i. Serve a minimum of sixteen (16) unduplicated participants in a fiscal year, without a cap on length of stay.
 - ii. For any Endurance participants receiving outpatient services provided by the Contractor, the Contractor will complete a Needs Level Assessment as specified above. Contractor will also administer a CARF approved assessment tool upon intake and after each twelve (12) months of residency. At least 75% of residents will show an improvement in one or more recovery score.
 - c. 70% of participants shall have applied for eligible benefits (e.g., GA, SSI, SSDI) within three (3) months of admission.
 - d. 70% of participants can be enrolled in health insurance (e.g., Medi-Cal or Medi-Care) within three (3) months of admission.

5. REPORTING REQUIREMENTS

- A. Contractor will submit semi-annual Narrative Reports, due by December 15th and June 15th, to the County on the available data addressing the following evaluation questions, with preliminary suggestions for improvements in implementing and improving services:
- a. Are services meeting participant's needs, and are participants satisfied with services?
 - b. Is there documentation of coordination and collaboration among partners to provide effective services in a cost-effective manner?
 - c. Have services mirrored the research-validated aspects of the models replicated (i.e. Thinking for a Change, WRAP, etc.)?
 - d. To what degree has progress been made toward the achievement of participant goals and program Performance Objectives as outlined above?

- B. Data collection will align with Prop 47 guidelines to ensure Contractor is effectively serving underserved and overrepresented populations within the justice system. The data collection will take place on a regular and ongoing basis in accordance with the Contractor's evaluation management plan.
 - a. Contractor will submit Performance Measure data, as outlined in Section II.4, to the County Contract Manager or Designee on a quarterly basis.
- C. Contractor will collect and enter reliable demographic data into Avatar to monitor and evaluate the impact of diversity and equity to inform service delivery. Data will be entered upon intake of residents as well as in real-time if/when updates are obtained from residents.
 - a. Contractor will submit a upon request, for the purpose of grant reporting, the following demographic data for participants served:
 - i. Age group
 - ii. Race
 - iii. Ethnicity
 - iv. Primary Languages
 - v. Sexual orientation
 - vi. Gender assigned sex at birth
 - vii. Current gender identity
 - viii. Disability status
 - ix. Veteran status
 - x. Employment status

6. CONTRACT MONITORING MEETINGS

Contractor shall ensure at least one member of the leadership team is available to participate with the County Clinical Contract Manager or designee in meetings for case conference reviews, to review the Scope of Work (SOW) and to discuss performance measures, fiscal expenditures, and clinical progress of program participants as appropriate per the contract. Meetings can be held in person or virtually. These meetings will take place two (2) to four (4) times per month.

7. PATIENT RIGHTS

- A. Patient rights shall be observed by Contractor as provided in Welfare and Institutions Code section 5325 and Title 9 of the California Code of Regulations, HITECH, and any other applicable statutes and regulations. County's Patients' Rights advocate will be given access to participants, and facility personnel to monitor Contractor's compliance with said statutes and regulation.
- B. Freedom of Choice: County shall inform participants receiving mental health services, including patients or guardians of children/adolescents, verbally or in writing that:
 - a. Acceptance and participation in the mental health system is voluntary and shall not be considered a prerequisite for access to other community services;
 - b. They retain the right to access other Medi-Cal or Short-Doyle/Medi-Cal reimbursable services and have the right to request a change of provider or staff persons.

8. CULTURAL & LINGUISTIC CONSIDERATIONS

Contractor shall ensure the delivery of culturally and linguistically appropriate services to participants by adhering to the following:

- A. Contractor shall provide services pursuant to this Contract in accordance with current State Statutory, regulatory and Policy provisions related to cultural and linguistic competence as defined in California State Department of Mental Health (DMH) Information Notice No: 97-

- 14, “Addendum for Implementation Plan for Phase II Consolidation of Medi-Cal Specialty Mental Health Services-Cultural Competence Plan Requirements,” and the Solano County Mental Health Plan (BHP) *AAA203 Ensuring and Providing Multi-Cultural and Multi-Lingual Mental Health Services Policy*. Specific statutory, regulatory and policy provisions are referenced in Attachment A of DMH Information Notice No: 97-14, which is incorporated by this reference.
- B. Agencies which provide mental health services to Medi-Cal participants under Contract with Solano County are required to participate as requested in the development and implementation of specific Solano County BHP Diversity and Equity Plan provisions. Accordingly, Contractor agrees at a minimum:
- a. Utilize the national Culturally and Linguistically Appropriate Services (CLAS) standards in Health Care under the QA/QI agency functions and policy making. For information on the CLAS standards please refer to the following link:

 - b. Contractor will use the agency Cultural Responsivity Plan developed previously to guide practices and policies in order to ensure culturally and linguistically appropriate service delivery.
 - i. The agency Cultural Responsivity Plan shall be reviewed and updated at least annually, and a copy submitted to County BHP Ethnic Services Coordinator or Quality Improvement as directed annually by December 31st. The Plan update shall include progress made on the previous goals and newly developed goals for the next year.
 - ii. Contractor will submit a revised plan if County determines the plan to be inadequate or not meeting fidelity to the CLAS standards.
 - c. Develop and assure compliance with administrative and human resource policy and procedural requirements to support the intentional outreach, hiring, and retention of a diverse workforce;
 - d. Provide culturally sensitive service provision and staff support/supervision, including assurance of language access through availability of bilingual staff or interpreters and culturally appropriate evaluation, diagnosis, treatment and referral services.
- C. Contractor will ensure agency representation for the County BHP Diversity and Equity Committee held monthly in order stay apprised of—and inform—strategies and initiatives related to equity and social justice as informed by the goals included in the County BHP Diversity and Equity Plan and Annual Updates.
- a. Assign an agency staff member designated to become an active committee member attending meetings consistently. Designee will be required to complete the *Diversity and Equity Committee Participation Agreement* form.
 - b. Make an effort to ensure that the designated representative can also participate in ad hoc sub-committee meetings scheduled as needed to work on specific initiatives related to goals in the BHP Diversity and Equity Plan.
 - c. Identify a back-up person to attend committee meetings in the absence of the designated person.
- D. Provision of Services in Preferred Language:
- a. Contractor shall provide services in the preferred language of the beneficiary and/or family member with the intent to provide linguistically appropriate mental health services per ACA 1557 45 CFR 92, nondiscrimination in healthcare programs. This may include American Sign Language (ASL). This can be accomplished by a bilingual clinician or the assistance of an interpreter. The interpreter may not be a family member unless the beneficiary or family expressly refuses the interpreter provided.

- b. Contractor may identify and contract with an external interpreter service vendor or may avail themselves to using the vendor provided and funded through Solano County Health and Social Services.
 - c. Contractor shall ensure that interpretation services utilized for communications or treatment purposes are provided by interpreters who receive regular cultural competence and linguistic appropriate training. Training specifically used in the mental health field is recommended.
 - d. Contractor shall ensure that all staff members are trained on how to access interpreter services used by the agency.
 - e. Contractor will provide informational materials as required by Section 9.G below, legal forms and clinical documents that the beneficiary or family member may review and/or sign shall be provided in the beneficiary/family member's preferred language whenever possible.
 - f. Contractor shall at a minimum provide translation of written informing materials and treatment plans in the County's threshold language of Spanish as needed for participants and/or family members.
- E. Cultural Humility Training:
- a. Contractor shall ensure that all staff members including direct service providers, medical staff, administrative/office support, reception staff, and leadership complete at least one training in humility and/or social justice per year.
 - i. On a monthly basis, Contractor shall provide County Quality Improvement with an updated list of all staff and indicate the most recent date of completing Solano BHP approved cultural humility and/or social justice training. Evidence, including sign in sheets, training syllabi, certificates of completion, and tracking sheets based on organizational charts, of Contractor staff receiving cultural humility training, should also be provided to County Quality Improvement at that time.
- F. Contractor will Participate in County and agency sponsored training programs to improve the quality of services to the diverse population in Solano County.

9. QUALITY ASSURANCE ACTIVITIES

- A. Regulation changes that occur during the life of this agreement:
- a. If/When Federal and/or State agencies officially communicate changes/additions to current regulations, County will communicate new expectations via County QI Information Notice, and such requirements will supersede contractual obligations delineated in this agreement.
- B. Medi-Cal Certification:
- a. If the Contractor has Medi-Cal claiming programs, then Contractor will meet and maintain standards outlined on the most up to date DHCS Certification Protocols, as well as any standards added by the County through the most recent County Behavioral Health Division policy.
 - b. Contractor shall inform County of any changes in Contractor status, including changes to ownership, site location, organizational and/or corporate structure, program scope and/or services provided, Clinical Head of Service.
 - c. Contractor will communicate any such changes within sixty (60) days to County Quality Improvement, utilizing the most up-to-date version of the *Solano County Behavioral Health Division Medi-Cal Certification Update Form* Staff Credentialing:
 - i. Contractor shall adhere to credentialing and re-credentialing requirements as stipulated in Department of Health Care Services MHSUDS Information Notice 18-019.

- ii. All Contractor staff providing services that are entered into the County billing and information system must have the staff names and other required information communicated to County Quality Improvement using County Staff Master form.
- iii. Contractor shall provide County BHP Quality Improvement with a monthly updated list of Contractor staff by the date provided by BHP Quality Improvement.
- iv. Contractor shall not employ or subcontract with any provider excluded from participation in Federal health care programs.
- v. Contractor shall notify County Quality Improvement when a staff provider will be terminating and shall demonstrate a good faith effort to notify in writing all participants who were actively receiving services of the termination within thirty (30) calendar days of receiving the termination notice from the staff.
- vi. Contractor shall work with County Provider Eligibility Coordinator to ensure that all licensed staff are accurately enrolled in the DHCS PAVE system.

C. Access:

- a. Contractor must have hours of operation during which services are provided to Medi-Cal participants that are no less than the hours of operation during which the provider offers services to non-Medi-Cal participants. If Contractor only serves Medi-Cal participants, Contractor must provide hours of operation comparable to the hours the Contractor makes available for Medi-Cal services that are not covered by the contract or another Mental Health Plan.
- b. Contractor must meet the state standards for timely access to care and services, taking into account the urgency of need for services. If there is a failure to comply with timely access requirements, corrective action can and will take place.
 - i. Contractor will ensure that upon receiving written referral or request for service, Contractor will contact beneficiary within one (1) to two (2) business days.
 - ii. For urgent service requests, Contractor will offer an assessment appointment that is forty-eight (48) hours from date of service request from Solano BHP.
 - iii. For routine service appointments, Contractor will offer an assessment appointment within DHCS timeliness requirements, which include:
 - 1) Routine Requests: ten (10) business days from the date service was requested from Solano BHP
 - 2) Urgent Care Requests for Services that do not require prior authorization: Must be provided within forty-eight (48) hours
 - 3) Crisis intervention
 - 4) Crisis Stabilization
 - 5) Mental Health Services
 - 6) Targeted Case Management
 - 7) Intensive Care Coordination
 - 8) Medication Support Services
 - iv. Urgent Care Requests for Services that require prior authorization: Must be provided within ninety-six (96) hours.
 - 1) Intensive Home-Based Services
 - 2) Day Treatment Intensive
 - 3) Day Rehabilitation
 - 4) Therapeutic Behavioral Services
 - 5) Therapeutic Foster Care

If Contractor provides psychiatric medication services, Psychiatry appointments (for both adult and children/youth) must be offered to Medi-Cal participants within fifteen (15) business days from the date the beneficiary or a provider acting on behalf of the beneficiary, requests a referral for a medically necessary service.

Appointment data must be recorded, tracked and submitted to the County Quality Improvement Unit monthly.

- c. In the event that this timeline cannot be met:
 - i. **Notification:** Contractor will notify the appointed County Contract Manager or the County designee within one (1) business day for Urgent referrals and within two (2) business days for Routine referrals.
 - ii. **NOABD:** For participants with Medi-Cal insurance who are not offered an assessment appointment within timeliness requirements listed above, a Notice of Adverse Benefit Determination (NOABD) will be completed and sent to the beneficiary and County Quality Improvement in accordance with Solano BHP guidelines.
 - d. The County will monitor timeliness for every Medi-Cal Behavioral Health program on a monthly basis, per County Behavioral Health Division policy AAA227 – Timely Access Tracking and Monitoring. Programs not meeting the standards 80% of the time for four (4) consecutive months will be placed on a Corrective Action Plan (CAP).
 - e. If Contractor acts as a “point of access” for Solano BHP, the Contractor will utilize the County’s electronic health record “Access Screening and Referral” form to screen all new participants requesting services directly from the Contractor.
 - f. Contractor will provide staff to work with County Quality Improvement to make multiple (no less than four) test calls for the County business and after-hours access telephone line, during one month per fiscal year (FY).
 - g. Contractor will monitor internally the Contractor’s timeliness in terms of responding to requests for service, as indicated above in the “Access” section of this contract. Contractor will review timeliness with County Contract Manager, or designee on a regular basis. Failure to demonstrate consistent adherence to these timeliness standards may result in an official Plan of Correction being issued to the Contractor.
 - h. Once Contractor initiates the Assessment process with the participant (Assessment Start Date), Contractor shall complete and finalize the Assessment for that participant as evidenced by provider signature, credential, date of service and date assessment was entered into the medical record, within twenty (20) business days of the Assessment Start Date.
 - i. Per CalAIM Documentation Redesign parameters, Contractor shall have the flexibility to initiate treatment services prior to the Assessment being completed and finalized, if the needs of the beneficiary require it and CalAIM Medical Necessity requirements are met. participant
 - ii. Contractor shall initiate non-urgent, non-psychiatric treatment services no later than ten (10) business days of the assessment completion date, and for Psychiatric treatment within fifteen (15) business days of assessment completion date.
 - i. Contractor shall abide by CalAIM Medical Necessity requirements that are listed in both DHCS *Behavioral Health Information Notice (BHIN) 21-073 Criteria for beneficiary access to Specialty Mental Health Services (SMHS), medical necessity and other coverage requirements*, as well as any additional clarification of those parameters provided by the County via QI Information Notice and/or formal training.
- D. CalAIM Documentation Redesign:
- a. Contractor shall abide by and agrees to amend current paper and/or electronic medical record documentation to the standards put forth by DHCS and the County regarding CalAIM Documentation Redesign, in conjunction with the statewide CalAIM initiative. County will provide contractor with updated requirements as they are made available via DHCS BHINs, County QI Information Notices, policy updates and/or training documentation.

- F. Medical Necessity
 - a. Also, per County Behavioral Health Division policy AAA219 – Authorization Standards, Contractor will demonstrate medical necessity via a County initiated Quality Review of a participant’s assessment and participant plan prior to providing the following services for which prior authorization is not permitted:
 - i. Crisis Intervention
 - ii. Crisis Stabilization
 - iii. MH Services
 - iv. Targeted Case Management (TCM)
 - v. Intensive Care Coordination (ICC)
 - vi. Medication Support Services
- E. Informing Materials
 - a. Informing materials include Solano County BHP Guide to Mental Health Services, Provider Directory, Problem Resolution forms, notices of service denial or termination.
 - b. Contractor shall ensure that informing materials are printable and given to those requesting services within five (5) business days in a minimum of 12-point font.
 - c. Contractor shall ensure that Informing Materials are made available in County threshold language of Spanish, and alternative formats (audio and large font).
 - d. Contractor shall provide written taglines communicating the availability of written translations or oral interpretation in specific other languages.
 - i. A hard-copy page of taglines in all prevalent non-English languages in the State of California, as provided by County BHP Quality Improvement, must be attached to all written materials provided to those requesting services.
 - ii. A hard-copy page of taglines must also be available in large print (font no smaller than 18 pt.) for those with visual impairments.
- F. Notice of Adverse Benefit Determination
 - a. Contractor shall provide a participant requesting services with a Notice of Adverse Benefit Determination (NOABD) [formerly referred to as NOA-A and NOA-E], per County BHP’s Policy and Procedure AAA201 Notices of Adverse Benefits Determination Requirements under the following circumstances:
 - i. The denial, limited authorization, or modification of a requested service, including determinations based on the type or level of service, based on the type or level of service requirements for medical necessity, appropriateness, setting, or effectiveness of a covered benefit;
 - ii. The failure to provide services in a timely manner (within ten (10) business days from point of access to initial assessment);
 - iii. The denial of a beneficiary’s request to dispute financial liability, including cost sharing and other beneficiary financial liabilities.
- G. Contractor shall maintain medical records in such a manner that all required documentation for every beneficiary is stored in a secure medical record. Additionally, documentation will be completed with an emphasis on both timeliness and clinical accuracy, in order to establish medical necessity for all specialty mental health services provided by the Contractor, as outlined in Solano County Behavioral Health Quality Improvement documentation trainings and manual.
 - a. Only one assessment and treatment plan covering the annual service period is necessary to justify medical necessity for services. If another program is the Primary Service Coordinator and has completed an assessment and treatment plan, Contractor will utilize the already completed documentation to establish medical necessity for treatment or complete a brief update to any area in need of supplemental information.
 - b. Required documentation includes, but is not limited to, the following:
 - i. Informing Materials

- ii. Clinical Behavioral Health Assessment
 - iii. Beneficiary Treatment Plan or Problem List
 - iv. Service Authorization (when/if preauthorization is required)
 - v. General Consent for Treatment
 - vi. Medication Consent
 - vii. Authorizations to Release Medical Records
 - viii. Acknowledgement of Receipt of Notice of Privacy Practices
 - ix. Notices of Action (if applicable, must be sent to Quality Improvement within five (5) business days)
- H. Quality Review of MH Assessments and Participant Plans:
- a. Contractor shall coordinate with County Quality Improvement, once the contractor has established medical necessity for a participant's care, to provide an Assessment, Beneficiary Treatment Plan, and any other relevant documents deemed necessary by County prior to providing planned services.
 - b. Contractor will respond to County Quality Improvement's request for clinically amended documentation and resubmit documentation within five (5) business days of receiving County's request in order to complete the Clinical Quality Review process.
- I. Problem Resolution
- a. Contractor shall adopt and implement the County Health and Social Services Department, Behavioral Health Division's Problem Resolution process.
 - i. The County Problem Resolution process includes Grievance, Appeal, and Expedited Appeals, as stipulated in County policy *ADM141 Beneficiary Problem Resolution Process – Grievances*, *ADM142 Beneficiary Problem Resolution Process – Appeals and Expedited Appeals*, *ADM132 Request to Change Service Provider*, *AAA210 Beneficiary Right of a Second Opinion* and *ADM136 Mental Health Services Act (MHSA) Issue Resolution Process*.
 - b. Contractor duties regarding Problem Resolution include, but are not limited to, the following:
 - i. Contractor shall post County notices and make available County forms and other materials informing participants of their right to file a grievance and appeal. Required materials include the following brochures: "Beneficiary Rights & Problem Resolution Guide" "Appeal Form", "Compliment/Suggestion Form", "Grievance Form", "Request to Change Service Provider", and the "MHSA Issue-Suggestion Form". Contractor shall aid participants in filing a grievance when requested and shall not retaliate in any manner against anyone who files a grievance.
 - ii. Contractor shall forward all Problem Resolution Process brochures written and completed by or on behalf of a beneficiary of the BHP to County Quality Improvement, immediately but no later than twenty-four (24) hours from receipt, whether or not Contractor has resolved the problem.
 - iii. Contractor shall provide "reasonable assistance" to participants completing problem resolution forms, such as providing interpreting services and free access to TTY/TTD services.
 - iv. Contractor shall communicate and collaborate directly with the County Quality Improvement Problem Resolution Coordinator to provide any additional information needed regarding any follow up actions to investigate/resolve the problem identified through the problem resolution process.
 - v. Contractor shall provide at no cost and sufficiently in advance of a resolution timeframe for appeals, information that the beneficiary may want to use to support the case, including parts of their medical records, other documents and records,

and any new or additional evidence considered, relied upon, or generated by the Plan in connection with the appeal of the adverse benefit determination.

- J. Serious Incident Reports (SIRs):
- a. Contractor will communicate the occurrence of serious incidents to the County by completing an official County Serious Incident Report form (see Exhibit D-4) following the process outlined in County policy *ADM-1.10 Serious Incident Reporting*, including but not limited to the following:
 - i. Contractor shall verbally notify County Quality Improvement immediately but no later than four (4) hours after a serious incident.
 - ii. Contractor shall submit the SIR electronically to County Quality Improvement within twenty-four (24) hours of the incident or sooner via Comply Track website.
 - iii. Contractor shall communicate directly with the County Quality Improvement designee to provide any additional information needed regarding the reported incident.
 - iv. Contractor and County Behavioral Health Administration/Quality Improvement shall discuss and develop recommendations to achieve more desired outcomes in the future. An Adverse Outcome meeting may be scheduled, in which the Contractor may need to attend, in order to discuss the SIR, interventions and recommendations for policy/program quality improvement.
 - v. Data breaches or security incidents are required to be reported to both County Quality Improvement and County Health and Social Service Compliance Unit concurrently immediately upon discovery and no later than twenty-four (24) hours.
- K. Contractor Quality Improvement Process:
- a. Contractor will establish and maintain an internal agency quality improvement and quality assurance process, including but not limited to the following:
 - i. Internal Quality Improvement Work Plan – The plan will set goals around Access, Timeliness, Quality and Outcomes for the Contractor and will be evaluated at least annually. A new plan will be created annually, and a copy submitted to County Quality Improvement by July 30th of each FY for the current FY. Contractor will submit a revised plan if County determines the plan to be inadequate.
 - ii. Internal review of Assessments– Contractor will internally review at least 25% of all Assessments. A quarterly report will be sent to County Quality Improvement.
 - iii. Internal review of provider progress notes – Contractor will internally review at least 10% of every provider’s progress notes. A quarterly report will be sent to County Quality Improvement.
 - iv. Monitoring safety and effectiveness of medication practices – If Contractor provides medication services, Contractor will establish official policy for monitoring medication practices, including operating a Medication Prescriber peer review process. Contractor policy will specifically address procedures Contractor utilizes to monitor prescribing to children and youth.
- L. Quality Improvement Committee:
- a. Contractor will provide a representative to participate in County quarterly Quality Improvement Committee (QIC).
 - b. If Contractor’s place of business is not located within Solano County boundaries, Contractor’s representative may request to participate remotely via conference call and/or web-based interface.
 - c. Contractor will provide data related to objectives/goals outlined in the County Quality Assessment and Performance Improvement Plan in a timely fashion prior to quarterly QIC meeting as requested by the County designee.
- M. Annual County review of Contractor service delivery site and chart audit:

- a. County will engage in a site and chart review annually, consistent with practices outlined in the most up-to-date version of the *County Mental Health Utilization Review Handbook and County Chart Audit tools which are consistent with DHCS Reasons for Recoupment*.
 - b. Contractor will provide all requested medical records and an adequate, private space in which for County staff to conduct the site review and chart audit.
 - c. If Contractor operates a fee-for-service program and the chart audit results in service disallowances, County will subtract the audit disallowance dollars from a future vendor claim, once County audit report is finalized.
 - d. County, State or Federal Officials have the right to audit for ten (10) years from any previous audit, therefore Contractor will retain records for ten (10) years from the completion of any audit.
- N. Fraud, Waste and Abuse:
- a. Contractor shall maintain policies and procedures designed to detect and prevent fraud, waste and abuse, and to promptly inform County Behavioral Health Administration and Quality Improvement when detected.
 - b. Contractor must have a mechanism in place to report to the County when it has received an overpayment, to return the overpayment to the County within forty-five (45) calendar days after the date the overpayment was identified, and to notify the BHP in writing of the reason for the overpayment.
 - c. At any time during normal business hours and as often as the County may deem necessary, Contractor shall make available to County, State or Federal officials for examination all of its records with respect to all matters covered by this Contract. Additionally, Contractor will permit County, State or Federal officials to audit, examine and make excerpts or transcripts from such records, and to make audits of all invoices, materials, payrolls, records of personnel, information regarding participants receiving services, and other data relating to all matters covered by this Contract.
- O. Service Verification:
- a. Contractor will submit an executed copy of Contractor Service Verification Policy once created and will provide County a copy of Contractor's revised policy any time policy is revised/updated.
 - b. Contractor policy will contain measures as strict or stricter than the current County policy *QI620 Service Verification Requirements*
 - c. Contractor will provide evidence of following policy to Quality Improvement Service Verification Coordinator at intervals during the FY as stipulated by County policy *QI620*.
- P. Conflict of Interest – Expanded Behavioral Health Contract Requirements:
- a. Contractor will abide by the requirements outlined in County policy *ADM146 Disclosure of Ownership, Control and Relationship Information of Contracted Agencies*, including but not limited to the following:
 - i. Contractor will disclose the name of any person who holds an interest of 5% or more of any mortgage, deed of trust, note or other obligation secured by the Contractor to the County
 - ii. Contractor will ensure all service providers receive a background check as a condition of employment as stringent as the County background policy requirements.
 - iii. Contractor will require any providers or any other person within the agency with at least a 5% ownership interest to submit a set of fingerprints for a background check.
 - iv. Contractor will terminate involvement with any person with a 5% ownership interest in the Contractor who has been convicted of a crime related to Medicare, Medicaid, or CFR title XXI within the last ten (10) years.

- Q. Contractor will ensure that all Contractor staff, including administrative, provider, and management staff, receive formal Compliance training on an annual basis.
- a. Contractor will provide evidence, including sign in sheets, training syllabi, certificates of completion, and tracking sheets based on organizational charts, of Contractor staff receiving compliance training to County Quality Improvement annually by July 15th each FY for the training the year prior.
- R. Performance Data:
- a. Contractor will provide County with any data required for meeting 1915b Waiver Special Terms and Conditions requirements communicated by California DHCS, within the timeline required by DHCS.
 - b. Contractor will provide County with data required by DHCS on a monthly basis, including but not limited to CANS, PSC-35, CSI Timeliness, etc.
- S. Utilization Management
- a. Contractor will work with the County Contract Manager to monitor the following Contractor efforts:
 - i. Expected capacity to serve Medi-Cal Eligible participants
 - ii. Expected service utilization
 - iii. Number and types of providers needed in terms of training, experience and specialization
 - iv. Number of Contractor providers not accepting new participants
 - v. Geographical location to participants in terms of distance, travel time, means of transportation typically used by participants, and physical access for disabled participants
 - vi. Contractor ability to communicate with limited English proficient participants in their preferred language
 - vii. Contractor's ability to ensure physical access, reasonable accommodations, culturally competent communications, accessible equipment for participants with physical or mental disabilities
 - viii. Available triage lines or screening systems
 - ix. Use of telemedicine or other technological solutions, if applicable
 - b. Additional areas of monitoring include:
 - i. Blocked billing due to missing treatment plans or MH diagnosis that results in lost revenue
- T. Performance Outcome Measures - Foundations House
- a. Contractor will utilize the Reaching Recovery Measure, or another set of measures approved by County Contract Manager and County Quality Improvement for adult participants ages 18 and older. Frequency of reevaluation is determined by County Quality Improvement.
 - i. Contractor will also be required to complete a Child Adolescent Needs & Strengths (CANS) measure with any young adults, ages 18-20.
 - ii. Contractor will also be required to request authorization from any 18-year-old participant to complete Pediatric Symptom Checklist (PSC-35) with the participant's identified parent/caregiver. PSC-35 shall only be initiated if participant authorizes the caregiver to participate in the treatment process.
 - b. Only one set of measures shall be completed at each required interval per beneficiary. The Primary Service Coordinator will administer the measures.
 - c. When acting as the Primary Service Coordinator, Contractor shall administer the CANS and PSC-35 measures at the required intervals of initial assessment, every 6-months thereafter, and at discharge from treatment.
 - d. Primary Service Coordinators and Treatment planning teams shall use Outcome measure data to determine treatment progress, areas of treatment focus, and level of care.

- e. Contractor shall manually data enter or submit a data upload of CANS and PSC-35 data monthly by the deadline established by County BHP Quality Improvement.
- U. Network Adequacy Certification
 - a. Contractor must submit network adequacy data to the County at a frequency (either annually, quarterly or monthly), in a manner and format determined by the County, by or before deadlines officially communicated to the Contractor by County Quality Improvement Unit.
 - b. Contractor will maintain and monitor a network of appropriate providers that is sufficient to provide adequate access to all services covered by this contract, per California MHSUDS Information Notice 18-011 (dated February 13, 2018).
- V. Provider Directory
 - a. Contractor will ensure that Contractor's Provider Directory captures various elements about their providers including their license number and type, NPI, language(s), cultural capabilities, specialty, services, if the provider is accepting new participants, and any group affiliations.
 - b. Contractor will also ensure that the Provider Directory captures basic information about the facility where the provider serves participants to include address, telephone number, email address, website URL, hours of operation, and whether the providers' facility is accessible to persons with disabilities.
 - c. Any changes to the Provider Directory must be reported to the County monthly per MHSUDS Info. Notice No. 18-020 (dated April 24, 2018) – Federal Provider Directory Requirements for Mental Health Plans (BHPs) and by deadlines established by the County.
- W. Physical Accessibility Requirements
 - a. Contractor must provide physical access, reasonable accommodations, and accessible equipment for Medi-Cal participants with physical or mental disabilities.
 - b. County Quality Improvement will provide Physical Accessibility ratings for Contractor's facilities/offices during Medi-Cal certification site visits. Contractor's facilities/offices will be rated as having "Basic" or "Limited" accessibility for seniors and persons with disabilities.
 - i. "Basic" access is granted when the facility/office demonstrates access for the members with disabilities to parking, interior and exterior building, elevator, treatment/interview rooms, and restrooms.
 - ii. "Limited" accessibility is granted when the facility/office demonstrates access for a member with a disability are missing or incomplete in one or more features for parking, building, elevator, treatment/interview rooms, and restrooms.
 - iii. If Contractor's facility/offices are given a "Limited" rating, a Plan of Correction will be issued.
 - c. If there is a change to the physical accessibility of the contracted agency/participant, it must be reported to the County via the County's BHP monthly Provider Directory update process.
- X. Language Line Utilization
 - a. If not using the County H&SS interpreter vendor, contracted agencies/participants must submit language line utilization data monthly detailing use of interpretation services for participants' face-to-face and telephonic encounters.
 - b. Language line utilization data submission should include (for each service encounter that required language line services):
 - i. the reporting period;
 - ii. the total number of encounters requiring language line services;
 - iii. the language utilized during the encounter requiring language line services;

- iv. the reason services were not provided by a bilingual provider/staff or via face-to-face interpretation.
- c. Language line utilization data must be submitted to and as requested by County BHP Quality Improvement, using the template provided by County BHP Quality Improvement and following the instructions contained on the reporting tool.

10. CONFIDENTIALITY OF MENTAL HEALTH RECORDS

- A. Contractor warrants that Contractor is knowledgeable of Welfare and Institutions Code section 5328 respecting confidentiality of records pursuant to 45 CFR Part 160 (HIPAA). County and Contractor shall maintain the confidentiality of any information regarding participants (or their families) receiving Contractor's services. Contractor may obtain such information from application forms, interviews, tests or reports from public agencies, counselors or any other source. Without the beneficiary's written permission, Contractor shall divulge such information only as necessary for purposes related to the performance or evaluation of services provided pursuant to this Contract, and then only to those persons having responsibilities under this Contract, including those furnishing services under Contractor through subcontracts.
- B. Contractor and staff will be responsible for only accessing beneficiary data from the County's electronic health record for participants for which they have open episodes of care and for which participant staff have a specific business purpose for accessing. All attempts to access beneficiary data that do not meet those requirements will be considered data breaches and Contractor is responsible for reporting such breaches to County Quality Improvement and HSS Department Compliance unit immediately or within four (4) hours of discovery.
- C. In the event of a breach or security incident by Contractor or Contractor's staff, any damages or expenses incurred shall be at Contractor's sole expense.

11. VEHICLE PURCHASING/LEASING

The Purchaser (Crestwood Behavioral Health, Inc. a Delaware for profit corporation) shall assume all responsibilities, liabilities, and costs associated with the ownership or lease contract, maintenance, and operation of the Vehicles.

- A. Vehicle Use and Maintenance
 - a. The Purchaser agrees to use the Vehicle(s) for the intended purposes and in compliance with all applicable laws, regulations, and restrictions.
 - b. The Purchaser shall be responsible for the routine maintenance, repairs, and servicing of the Vehicle(s) to ensure their safe and proper operation during the useful life of the Vehicle(s).
- B. Vehicle Insurance
 - a. The Automobile Liability policy shall remain in full force and effect for no less than two (2) years following expiration of this Contract.
- C. Expiration of Contract
 - a. Should this contract end before the vehicle lease term end:
 - i. Contractor shall be responsible for the vehicle(s) and all related costs thereafter.
 - ii. Contractor understands that County will only reimburse for vehicle(s) related expenses up to time of contract closeout and up to the amounts specified in the Budget Detail.
- D. Indemnification

- a. The Purchaser agrees to indemnify, defend, and hold the County harmless from and against any claims, damages, liabilities, losses, or expenses arising out of or in connection with the use, operation, or ownership of the Vehicles during the term of this Contract.

III. COUNTY RESPONSIBILITIES

County will:

- A. Provide the campus for Contractor to carry out its duties and meet its obligations under this Contract at 251, 261, and 271 S. Watney Way, Fairfield, CA 94533.
- B. Provide technical assistance in the form of phone consultations, site visits and meetings to provide clinical guidance and address challenges in the clinical program, implementation and/or performance of the SOW.
- C. Assign a Program Liaison to work closely with the program to support the participants being served and to monitor program capacity.
- D. Assist with maintaining occupancy through census monitoring and by providing referrals when vacancies become available. Referrals will be pre-screened and prioritized prior to sending for contractor's consideration.
- E. Promote collaboration and communication between contractor and participants' case management teams.
- F. Provide training and support for the following
 - a. Development of clinical skills through ProAct non-violence crisis intervention and Applied Suicide Intervention Skills Training (ASIST).
 - b. Navigation of Solano County Behavioral Health's continuum of care and orientation to the Mental Health Plan.
 - c. Use of the Netsmart Avatar electronic health record system.
- G. Assign a QI Liaison for technical assistance with billing Medi-cal.
- H. Provide feedback on performance measures objectives and fiscal expenditures in a timely manner to seek a proactive solution.
- I. Make available electronically all policies and procedures referenced herein and inform the Contractor as polices are reviewed and updated so that the Contractor is aware of changes.
- J. Develop reporting forms not otherwise detailed in this Contract in coordinator with Contractor.
- K. Through the General Services Department, provide building maintenance (grounds maintenance, electrical, HVAC, and plumbing), and annual certifications for the fire sprinklers and kitchen hood.
- L. If there is damage to the building the County Contract Manager or designee will submit requests to have General Services repair the damage. If there is a safety issue due to the damage reported every effort will be made to have the repair completed the same day.

EXHIBIT B
BUDGET DETAIL AND PAYMENT PROVISIONS

I. METHOD OF PAYMENT

- A. Upon submission of an invoice and a Solano County vendor claim by Contractor, and upon approval by County, County shall, in accordance with the "Contract Budget" attached to this Contract as Exhibit "B-1" and incorporated into this Contract by this reference, pay Contractor monthly in arrears for fees and expenses actually incurred the prior month, up to the maximum amount set forth in **Section 3 of the Standard Contract**. Monthly claims for payment should be submitted to County by the 25th day of the subsequent month.
- B. Claims submitted by Contractor must meet the criteria set forth in section I.E and be documented by a fiscal monitoring report (Exhibit B-3). **Each invoice must specify actual charges incurred.**
- C. Contractor must request prior written approval, which approval may be withheld at the sole and absolute discretion of County, for transfers between budget categories or the addition of line items within the operating expenses category, which are set forth in Exhibit B-1, when the cumulative amount of such transfers or additions exceed the lesser of \$50,000 or 10% of the total Contract budget for the fiscal year. County may authorize the proposed transfers between budget categories or the addition of line items within a budget category under this section, except for personnel, subcontractors, indirect costs and capital expenditures (equipment or real property), provided that such transfers or additions do not substantially change the scope of services to be provided under this Contract and do not increase the Contract amount. Requests for transfers between budget categories or addition of budget line items within a budget category over the aforementioned threshold must be presented to the County on the County's "Budget Modification Request Form". Budget modifications below the threshold must be presented on Exhibit B-3 Fiscal Monitoring Report and submitted with the monthly vendor claim and invoice. Contractor is limited to three budget modifications per fiscal year which must be completed by June 30th.
- D. Through Quality Assurance monitoring the County identifies issues with billing data or clinical documentation, the Contractor agrees to discuss disallowed costs with the County and develop a mutually agreed upon action plan to remediate billing data, and documentation issues or problems.
- E. The following criteria apply to Contract Budget submitted by Contractor under this Contract:
 - 1. Requests for payment of personnel costs must include positions, salary, and actual percentage of time for each position. If Contractor provides fringe benefits to part time employees, salary and fringe benefits must be pro-rated for non-full-time employees. Salaries are fixed compensation for services performed by staff who are directly employed by Contractor and who are paid on a regular basis. Employee benefits and employer payroll taxes include Contractor's contributions or expenses for social security, employee's life and health insurance plans, unemployment insurance, pension plans, and other similar expenses that are approved by County. These expenses are allowable when they are included and in accordance with Contractor's approved written policies and allocation plan.
 - 2. Salaries and benefits of personnel involved in more than one contract, grant, or project must be charged to each grant based on the actual percentage of time spent on each grant or project.

Timesheets and time studies for each employee whose time is charged to this Contract must be maintained by Contractor and available upon request by the County.

3. Allowable operating expenses are defined as necessary expenditures exclusive of personnel salaries, benefits, equipment or payments to subcontractors. The expenses must be to further the program objectives as defined in Exhibit A of this Contract and be incurred during the invoiced period. County reserves the right to make the final determination if an operating expense is allowable and necessary.
4. Indirect costs are shared costs that cannot be directly assigned to a particular activity but are necessary to the operation of the organization and the performance of the program. The costs of operating and maintaining facilities, accounting services and administrative salaries are examples of indirect costs. Contractor must use a negotiated indirect cost rate with a federal agency. A Contractor who does not have a negotiated indirect cost rate agreement may claim an indirect cost rate of up to 14.6% of modified total direct costs.
5. Regardless of whether Contractor claims indirect costs through a negotiated indirect cost rate, Direct Allocation Method or the 14.6% of modified total direct costs, Contractor must provide the County with a cost allocation plan that clearly differentiates between direct and indirect costs. Contractor ensures that the same costs that have been treated as indirect costs have not been claimed or budgeted as direct costs, and that similar types of costs in like circumstances have been accounted for consistently. Contractor will provide this plan to County upon request. In the event that Contractor is unable to provide County with an acceptable cost allocation plan, County may disallow any indirect cost billed amounts.

II. ACCOUNTING STANDARDS

- A. Contractor shall establish and maintain a system of accounts for budgeted funds that complies with generally accepted accounting principles and practices for organizations/governmental entities as described in Section 13.C of Exhibit C. Additionally, Contractor must submit claims for payment under this Contract using either a cost allocation method or a direct allocation method.
- B. Contractor's cost allocation method must be supported by a cost allocation plan with a quantifiable methodology validating the basis for paying such expenditures. The cost allocation plan should be prepared according to Department of Healthcare Services (DHCS) and cost report procedures.
- C. Contractor shall document all costs by maintaining complete and accurate records of all financial transactions associated with this Contract, including, but not limited to, invoices, time studies, and other official documentation that sufficiently support all charges under this Contract.

III. PERSONAL PROPERTY

Contractor shall develop and maintain a system to track the acquisition of tangible personal property purchased with County funds having a cost of at least \$1,500 and submit, upon County's request, an annual accounting of all such property purchased that includes information on cost and acquisition date. Contractor shall ensure adequate safeguards are in place to protect such assets and shall exercise reasonable care over such assets to protect against theft, damage or unauthorized use. Contractor shall, upon County's request, return such assets to the County upon Contract termination; unless the depreciated value of the asset is \$0, based on a straight-line method of depreciation (refer to CFR part 200.436).

IV. FINANCIAL STATEMENTS, AUDITS, FISCAL REPORTING:

- A. Contractor agrees to furnish annual audited financial statements to the County, which must be submitted within thirty (30) days of its publication. If Contractor is not required by federal and/or state regulations to have an independent audit of its annual financial statements, Contractor agrees to furnish unaudited financial statements by September 1.
- B. Contractor agrees to furnish all records and documents within a reasonable time, in the event that the County, State or Federal Government conducts an audit of the County and/or Contractor's services.
- C. County may request cost information from contractors if cost reporting is required by state or federal law, or if the County determines that cost information is beneficial to advance the goals of the California Advancing and Innovating Medi-Cal (CalAIM) Act. If requested, Contractor will submit the financial report and any requested supporting documentation by a deadline set by the County. The financial report must be complete, accurate and formatted within the guidelines provided by the Solano County Health and Social Services Department.

V. BILLING EXPECTATIONS

- A. Prior to submitting an invoice for services rendered under this Contract, Contractor must determine if there are any available revenues from all possible sources other than the County that can be claimed for reimbursement for treatment of services provided under this Contract and submit claims for funding accordingly. Such revenues shall include, but are not limited to, Short Doyle Medi-Cal, patient fees, patient insurance, Medicare and payments from other third-party payers. Contractor shall provide the County with the necessary payer financial information in a form and manner prescribed by the County so that all revenues can be claimed timely. Amounts of claims against other revenue sources which remain unpaid due to untimely, incomplete, or improper information received from the Contractor shall be recouped from the Contractor.
- B. Determination of patient eligibility for coverage under Medicare and other reimbursement programs is the responsibility of the Contractor. County does not assume responsibility for such determination.
- C. Contractor will enter services into Avatar, the County approved computerized billing system. County will provide Contractor access to Solano County's computerized billing system. Authorized billing codes in Exhibit B-3 will be used by the contractor.
- D. Contractor will submit adequate supporting documentation as to Medi-Cal services provided no later than sixty (60) days after the last day of the month in which those services were provided.
- E. County will reconcile supporting documentation with the services in Avatar. Documentation not accurately reconciled to services entered into Avatar will be returned to the Contractor for corrections to be resubmitted within thirty (30) days.
- F. Periodically, Contractor will meet with County to review Medi-Cal reimbursable units and any disallowances.

VI. OTHER REVENUE COLLECTION

Clients participating in this program may receive Supplemental Security Income (SSI) from the Social Security Administration and/or other sources of income. Contractor has the responsibility and shall demonstrate active efforts to assist in obtaining benefits and identifying any income clients may be receiving and collect reimbursement from clients as allowed. Any revenues collected shall be used to offset expected reimbursement from the County. Revenues received shall be reported to the County in a separate attachment to the monthly invoice that includes client's name, offsetting revenue source, and amount of revenue received.

Group Codes:

DHCS determined the average group to be 4.5 participants. This is the reimbursement rate divider and applies to all group CPT/service codes. The number of participants is no longer a factor in reimbursement as of July 1, 2023. As of July 1, 2024, the Group Therapy (90853) unit rate become 50 mins, with allowable add-on crosswalks of 15 min increments of T12021. H2017G (group rehab) remains claimable in 15 min increments. EX: H2017G (group rehab) for LPHA is \$17.47 per 15 minutes per participant (\$78.63/4.5).

Minimum Time Increments to Qualify as a Unit of Service:

All services provided should enter in the amount of time spent. With that in mind, Payment Reform reimbursement occurs on a per unit basis. Providers, County or Contractor, are only reimbursed for the unit(s) of service if the service duration exceeds the midpoint of the unit increment. This includes add on time for all applicable CPT codes.

- **Example #1:** Since a unit of service for TCM is 15 min, the service must be between 8-15 mins to qualify for 1 unit of service. If a service is 7 minutes or less, reimbursement is not eligible. If that same service lasted 49 mins, the provider would only be reimbursed for three 15 min units of service, or 45 total mins.
- **Example #2:** If using a cross-walked Add On code, this code is only claimable if the maximum time for the primary code is reached and the additional claimed time exceeds the halfway point of the add-on code. So, if claiming Individual Therapy, and the service duration was 72 min, the claim would include 60 mins for the maximum allowed for Individual Therapy, and 12 mins for T2021 (which would equate to one 15 min unit of T2021 since the minimum of 8 mins was reached).
- **Fraud, waste and abuse:** Providers should not inflate service time to claim for an additional unit(s) of service, as that is considered fraud.
- **Inadequate care:** Providers should also not end services prematurely when there is clinical need to avoid not being reimbursed for a unit of service.

Add on time allowed for CPT Codes:

- **90832 Individual Therapy** – Programs should enter 90832 for Individual therapy and a duration of service time. Solano’s EHR will crosswalk to 90834 or 90837 based on duration of service time

up to 60 minutes. If duration eclipses the max of 60 minutes, it will crosswalk to T2021 after 68 mins. Additional add-on claiming is reimbursable in 15-minute increments.

- Note: Once add on is utilized, claimed coding for this service will automatically change from 90837 to T2021 (Example: Submit claim with 90837 and 84-mins direct service duration – this will translate to six 15 min units of T2021)
- **90847 Family Therapy** – Programs should enter 90847 for Family therapy and a duration of service time. If duration eclipses the max of 50 minutes, it will crosswalk to T2021 after 58 mins. Additional add-on claiming is reimbursable in 15-minute increments.
 - Note: Once add on is utilized, claimed coding for this service will automatically change from 90847 to T2021 (Example: Submit claim with 90847 and 74-mins direct service duration – this will translate to five 15 min units of T2021)
- **90849 Family Group Therapy** – 43-84 mins to be claimable and then 15 min increments
- **90853 Group Therapy - Programs** should enter 90853 for Group therapy and a duration of service time. Will claim using Group Therapy rate. If duration eclipses the max of 50 minutes, it will crosswalk to T2021G after 58 mins.
 - Note: Once add on is utilized, claimed coding for this service will automatically change from 90853 to T2021 (Example: Submit claim with 90853 and 74-mins direct service duration – this will translate to five 15 min units of T2021)
- **96372 Injections (MD, PA, NP, RN)** – Programs should enter 96372 for Injections and a duration of service time. Payable at one 15-min unit. No add-ons available for this code

Lockout Codes:

- Per Medi-Cal Billing Manual, contractor shall coordinate care so that service codes that create a lockout are not provided on the same day.
- If provided on the same day, services may be subject to not being reimbursed or if already claimed, may be subject to recoupment.

Additional codes for consideration:

EXHIBIT C
GENERAL TERMS AND CONDITIONS

1. CLOSING OUT

A. County will pay Contractor's final request for payment providing Contractor has met all obligations required under this Contract or any other contract and/or obligation that Contractor may have with the County. If Contractor has failed to meet any outstanding obligation, County will withhold compensation due under this Contract from Contractor's final request for payment until Contractor satisfies such obligation(s). Contractor is responsible for County's receipt of a final request for payment thirty (30) days after expiration or earlier termination of this Contract.

B. A final undisputed invoice shall be submitted for payment no later than ninety (90) calendar days following the expiration or termination of this Contract, unless a later or alternate deadline is agreed to in writing by the County. The final invoice must be clearly marked "FINAL INVOICE", thus indicating that, upon full payment of such invoice, no further payments are due or outstanding under the Contract.

C. The County may, at its discretion, choose not to honor any delinquent final invoice if the Contractor fails to obtain prior written approval of an alternate final invoice submission deadline. Written County approval for an alternate final invoice submission deadline shall be sought from the County prior to the expiration or termination of this Contract.

2. TIME

Time is of the essence in all terms and conditions of this Contract.

3. TIME OF PERFORMANCE

Work will not begin, nor claims paid for services under this Contract until all Certificates of Insurance, business and professional licenses/certificates, IRS ID number, signed W-9 form, or other applicable licenses or certificates are on file with the County's Contract Manager.

4. TERMINATION

A. This Contract may be terminated by County or Contractor, at any time, with or without cause, upon 90 days' written notice from one to the other.

B. County may terminate this Contract immediately upon notice of Contractor's malfeasance.

C. Following termination, County will reimburse Contractor for all expenditures made in good faith that are unpaid at the time of termination not to exceed the maximum amount payable under this Contract unless Contractor is in default of this Contract.

5. SIGNATURE AUTHORITY

The parties executing this Contract certify that they have obtained all required approvals and have the proper authority to bind their respective entities to all certifications, terms, and conditions set forth in this Contract.

6. REPRESENTATIONS

A. County relies upon Contractor's professional ability and training as a material inducement to enter into this Contract. Contractor represents that Contractor will perform the work according to generally accepted professional practices and standards and the requirements of applicable federal, state

and local laws. County's acceptance of Contractor's work shall not constitute a waiver or release of Contractor from professional responsibility.

B. Contractor further represents that Contractor possesses current valid appropriate licensure, including, but not limited to, driver's license, professional license, certificate of tax-exempt status, or permits, required to perform the work under this Contract.

7. INSURANCE

A. Without limiting Contractor's obligation to indemnify County, Contractor must procure and maintain for the duration of the Contract insurance against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the work under this Contract and the results of that work by Contractor, Contractor's agents, representatives, employees or subcontractors.

B. Minimum Scope of Insurance
Coverage must be at least as broad as:

(1) Insurance Services Office Commercial General Liability coverage (occurrence Form CG 00 01).

(2) Insurance Services Office Form Number CA 00 01 covering Automobile Liability, Code 1 (any auto).

(3) Workers' Compensation insurance as required by the State of California and Employer's Liability Insurance.

C. Minimum Limits of Insurance

Contractor must maintain limits no less than:

D. Additional Insurance Coverage

To the extent coverage is applicable to Contractor's services under this Contract, Contractor must maintain the following insurance coverage:

- (2) Professional Liability: **\$2,000,000** combined single limit per claim and in the aggregate. The policy shall remain in full force and effect for no less than five (5) years following the completion of work under this Contract.

E. If Contractor maintains higher limits than the minimums shown above, County is entitled to coverage for the higher limits maintained by Contractor. Any insurance proceeds in excess of the specified limits and coverage required, which are applicable to a given loss, shall be available to the County, as an additional insured. No representation is made that the minimums shown above are sufficient to cover the indemnity or other obligations of the Contractor under this Contract.

F. Deductibles and Self-Insured Retentions

Any deductibles or self-insured retentions must be declared to and approved by County. At the option of County, either:

- (1) The insurer will reduce or eliminate such deductibles or self-insured retentions with respect to County, its officers, officials, agents, employees and volunteers; or
(2) Contractor must provide a financial guarantee satisfactory to County guaranteeing payment of losses and related investigations, claim administration, and defense expenses.

G. Other Insurance Provisions

(1) The General Liability and Automobile Liability policies must contain, or be endorsed to contain, the following provisions:

(a) The County of Solano, its officers, officials, agents, employees, and volunteers must be included as additional insureds with respect to liability arising out of automobiles owned, leased, hired or borrowed by or on behalf of Contractor; and with respect to liability arising out of work or operations performed by or on behalf of Contractor including materials, parts or equipment furnished in connection with such work or operations. General Liability coverage shall be provided in the form of an Additional Insured endorsement (CG 20 10 11 85 or both CG 20 10 and CG 20 37 if later ISO revisions are used or the equivalent) to Contractor's insurance policy, or as a separate owner's policy. The insurance afforded to the additional insureds shall be at least as broad as that afforded to the first named insured.

(b) For any claims related to work performed by or on behalf of Contractor under this Contract, Contractor's insurance coverage must be primary insurance with respect to the County of Solano, its officers, officials, agents, employees, and volunteers. Any insurance maintained by County, its officers, officials, agents, employees, or volunteers in excess of Contractor's insurance and shall not contribute to it.

(2) If Contractor's services are technologically related, Professional Liability coverage shall include, but not be limited to claims involving infringement of intellectual property, copyright, trademark, invasion of privacy violations, information theft, release of private information, extortion and network security. The policy shall provide coverage for breach response costs as well as regulatory fines and penalties as well as credit monitoring expenses with limits sufficient to respond to such obligations. The policy shall also include, or be endorsed to include, property damage liability coverage for damage to, alteration of, loss of, or destruction of electronic data and/or information "property" of the County in the care, custody, or control of the Contractor. If not covered under the Contractor's Professional Liability policy, such "property" coverage of the County may be endorsed onto the Contractor's Cyber Liability Policy.

(3) Should any of the above described policies be cancelled prior to the policies' expiration date, Contractor agrees that notice of cancellation will be delivered in accordance with the policy provisions.

H. Waiver of Subrogation

(1) Contractor agrees to waive subrogation which any insurer of Contractor may acquire from Contractor by virtue of the payment of any loss. Contractor agrees to obtain any endorsement that may be necessary to affect this waiver of subrogation.

(2) The Workers' Compensation policy must be endorsed with a waiver of subrogation in favor of County for all work performed by Contractor, its employees, agents and subcontractors.

I. Acceptability of Insurers

Insurance is to be placed with insurers with a current AM Best rating of no less than A:VII unless otherwise acceptable to County.

J. Verification of Coverage

(1) Contractor must furnish County with original certificates and endorsements effecting coverage required by this Contract.

(2) The endorsements should be on forms provided by County or, if on other than County's forms, must conform to County's requirements and be acceptable to County.

(3) County must receive and approve all certificates and endorsements before work commences.

(4) However, failure to provide the required certificates and endorsements shall not operate as a waiver of these insurance requirements.

(5) County reserves the right to require complete, certified copies of all required insurance policies, including endorsements affecting the coverage described above at any time.

8. BEST EFFORTS

Contractor represents that Contractor will at all times faithfully, industriously and to the best of its ability, experience and talent, perform to County's reasonable satisfaction.

9. DEFAULT

A. If Contractor defaults in Contractor's performance, County shall promptly notify Contractor in writing. If Contractor fails to cure a default within thirty (30) days after notification, or if the default requires more than thirty (30) days to cure and Contractor fails to commence to cure the default within thirty (30) days after notification, then Contractor's failure shall constitute cause for termination of this Contract.

B. If Contractor fails to cure default within the specified period of time, County may elect to cure the default and any expense incurred shall be payable by Contractor to County. The contract may be terminated at County's sole discretion.

C. If County serves Contractor with a notice of default and Contractor fails to cure the default, Contractor waives any further notice of termination of this Contract.

D. If this Contract is terminated because of Contractor's default, County shall be entitled to recover from Contractor all damages allowed by law.

10. INDEMNIFICATION

A. Contractor will indemnify, hold harmless and assume the defense of the County of Solano, its officers, employees, agents and elective and appointive boards from all claims, losses, damages, including property damages, personal injury, death and liability of every kind, directly or indirectly arising from Contractor's operations or from any persons directly or indirectly employed by, or acting as agent for, Contractor, excepting the negligence or willful misconduct of the County of Solano. This indemnification shall extend to claims, losses, damages, injury and liability for injuries occurring after completion of Contractor's services, as well as during the progress of rendering such services.

B. Acceptance of insurance required by this Contract does not relieve Contractor from liability under this indemnification clause. This indemnification clause shall apply to all damages or claims for damages suffered by Contractor's operations regardless of whether or not any insurance is applicable.

11. INDEPENDENT CONTRACTOR

A. Contractor is an independent contractor and not an agent, officer or employee of County. The parties mutually understand that this Contract is between two independent contractors and is not intended to and shall not be construed to create the relationship of agent, servant, employee, partnership, joint venture or association.

B. Contractor shall have no claim against County for employee rights or benefits including, but not limited to, seniority, vacation time, vacation pay, sick leave, personal time off, overtime, medical, dental or hospital benefits, retirement benefits, Social Security, disability, Workers' Compensation, unemployment insurance benefits, civil service protection, disability retirement benefits, paid holidays or other paid leaves of absence.

C. Contractor, and not County, is solely obligated to pay all taxes, deductions and other employer-related obligations with respect to Contractor's employees including, but not limited to, federal and state income taxes, withholding, Social Security, unemployment, disability insurance, Workers' Compensation and Medicare payments.

D. Contractor shall indemnify and hold County harmless from any liability which County may incur because of Contractor's failure to pay such obligations and County shall not be responsible for any employer-related costs not otherwise agreed to in advance between the County and Contractor.

E. As an independent contractor, Contractor is not subject to the direction and control of County except as to the final result contracted for under this Contract. County may not require Contractor to change Contractor's manner of doing business but may require redirection of efforts to fulfill this Contract.

F. Contractor may provide services to others during the same period Contractor provides service to County under this Contract.

G. Any third persons employed by Contractor shall be under Contractor's exclusive direction, supervision and control. Contractor shall determine all conditions of employment with respect to its employees including hours, wages, working conditions, discipline, hiring and discharging or any other condition of employment.

H. As an independent contractor, Contractor shall indemnify and hold County harmless from any claims that may be made against County based on any contention by a third party that an employer-employee relationship exists under this Contract.

I. Contractor, with full knowledge and understanding of the foregoing, freely, knowingly, willingly and voluntarily waives the right to assert any claim with respect to any right or benefit or term or condition of employment insofar as such claim may be related to or arise from compensation paid under this Contract.

12. RESPONSIBILITIES OF CONTRACTOR

A. The parties understand and agree that Contractor possesses the requisite skills necessary to perform the work under this Contract and County relies upon such skills. Contractor pledges to perform the work skillfully and professionally. County's acceptance of Contractor's work does not constitute a release of Contractor from professional responsibility.

B. Contractor verifies that Contractor has reviewed the scope of work to be performed under this Contract and agrees that in Contractor's professional judgment, the work can and shall be completed for costs within the maximum amount set forth in this Contract.

C. To fully comply with the terms and conditions of this Contract, Contractor shall:

(1) Establish and maintain a system of accounts for budgeted funds that complies with

generally accepted accounting principles for government agencies;

(2) Document all costs by maintaining complete and accurate records of all financial transactions associated with this Contract, including, but not limited to, invoices and other official documentation that sufficiently support all charges under this Contract;

(3) Submit monthly reimbursement claims for expenditures that directly relate to this Contract;

(4) Be liable for repayment of any disallowed costs identified through quarterly reports, audits, monitoring or other sources; and

(5) Retain financial, programmatic, client data and other service records for three (3) years from the date of the end of the contract award, for three (3) years from the date of termination, or as required by applicable law or regulation, whichever is later.

D. Submit verification of non-profit status, if a requirement for the award of this Contract.

E. Obtain a bond at Contractor's sole expense in an amount sufficient to cover start-up funds if any were provided to Contractor from County.

F. Provide culturally and linguistically competent and age-appropriate service, to the extent feasible.

13. COMPLIANCE WITH LAW

A. Contractor shall comply with all federal, state and local laws and regulations applicable to Contractor's performance, including, but not limited to, licensing, employment and purchasing practices, wages, hours and conditions of employment.

B. To the extent federal funds are used in whole or in part to fund this Contract, Contractor specifically agrees to comply with Executive Order 11246 entitled "Equal Employment Opportunity", as amended and supplemented in Department of Labor regulations; the Copeland "Anti-Kickback" Act (18 U.S.C. §874) and its implementing regulations (29 C.F.R. part 3); the Clean Air Act (42 U.S.C. §7401 et seq.); the Clean Water Act (33 U.S.C. §1251); and the Energy Policy and Conservation Act (Pub. L. 94-165).

C. Contractor represents that it will comply with the applicable cost principles and administrative requirements including claims for payment or reimbursement by County as set forth in 2 C.F.R. part 200, as currently enacted or as may be amended throughout the term of this Contract.

14. CONFIDENTIALITY

A. Contractor shall prevent unauthorized disclosure of confidential information including names and other client-identifying information, and mental health records (per Welfare & Institutions Code section 5328) except for statistical information not identifying a particular client receiving services under this Contract and use of confidential information shall be in accordance with Welfare & Institutions Code section 10850 and Division 19 of the California Department of Social Services Confidentiality, Fraud, Civil Rights, and State Hearings Manual of Policies and Procedures.

B. Contractor shall not use client specific information for any purpose other than carrying out Contractor's obligations under this Contract.

C. Contractor shall promptly transmit to County all requests for disclosure of confidential information.

D. Except as otherwise permitted by this Contract or authorized by law, Contractor shall not disclose any confidential information to anyone other than the State of California without prior written authorization from County.

E. For purposes of this section, identity shall include, but not be limited to, name, identifying number, symbol or other client identifying particulars, such as fingerprints, voice print or photograph. Client shall include individuals receiving services pursuant to this Contract.

15. CONFLICT OF INTEREST

A. Contractor represents that Contractor and/or Contractor's employees and/or their immediate families and/or Board of Directors and/or officers have no interest, including, but not limited to, other projects or independent contracts, and shall not acquire any interest, direct or indirect, including separate contracts for the work to be performed hereunder, which conflicts with the rendering of services under this Contract. Contractor shall employ or retain no such person while rendering services under this Contract. Services rendered by Contractor's associates or employees shall not relieve Contractor from personal responsibility under this clause. Contractor agrees to file a Statement of Economic Interest if specified in the applicable County department's Conflict of Interest policy or if required by Cal. Code Regs., tit. 2 §§ 18219, 18700.3, 18704, or 18734.

B. Contractor has an affirmative duty to disclose to County in writing the name(s) of any person(s) who have an actual, potential or apparent conflict of interest.

16. DRUG FREE WORKPLACE CERTIFICATION

By signing this Contract, Contractor certifies to the County that Contractor is knowledgeable of Government Code section 8350 et seq. and shall abide by and implement its statutory requirements to provide a drug-free workplace.

17. HEALTH AND SAFETY STANDARDS

Contractor shall abide by all health and safety standards set forth by the State of California and/or the County of Solano pursuant to the Injury and Illness Prevention Program. If applicable, Contractor must receive all health and safety information and training from County.

18. CHILD/ADULT ABUSE

If services pursuant to this Contract will be provided to children and/or elder adults, Contractor certifies that Contractor is knowledgeable of the Child Abuse and Neglect Reporting Act (Penal Code section 11164 et seq.) and the Elder Abuse and Dependent Adult Civil Protection Act (Welfare and Institutions Code section 15600 et seq.) requiring reporting of suspected abuse.

19. INSPECTION

Authorized representatives of County, the State of California and/or the federal government may inspect and/or audit Contractor's performance, place of business and/or records pertaining to this Contract.

20. NONDISCRIMINATION

A. In rendering services under this Contract, Contractor shall comply with all applicable federal, state and local laws, rules and regulations and shall not discriminate based on age, ancestry, color, gender, gender identity, marital status, medical condition, national origin, physical or mental disability, race, religion, sexual orientation, military status, or other protected status.

B. Further, Contractor shall not discriminate against its employees, which includes, but is not limited to, employment upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation and selection for training, including apprenticeship.

21. SUBCONTRACTOR AND ASSIGNMENT

- A. Services under this Contract are deemed to be personal services.
- B. Subject to any required state or federal approval, Contractor shall not subcontract any work under this Contract without the prior written consent of the County's Contract Manager or assign this Contract or monies due without the prior written approval of the County's applicable Department Head or his or her designee and the County Administrator.
- C. If County consents to the use of subcontractors, Contractor shall require and verify that its subcontractors (i) maintain insurance meeting all the requirements stated in Section 7 above; (ii) are not currently excluded, debarred, or otherwise ineligible to participate in a federally or state funded program; and (iii) satisfy all of Contractor's requirements under this Contract.
- D. Assignment by Contractor of any monies due shall not constitute an assignment of the Contract.

22. UNFORESEEN CIRCUMSTANCES

Contractor is not responsible for any delay caused by natural disaster, war, civil disturbance, labor dispute or other cause beyond Contractor's reasonable control, provided Contractor gives written notice to County of the cause of the delay within 10 days of the start of the delay.

23. OWNERSHIP OF DOCUMENTS

- A. County shall be the owner of and shall be entitled to possession of any computations, plans, correspondence or other pertinent data and information gathered by or computed by Contractor prior to termination of this Contract by County or upon completion of the work pursuant to this Contract.
- B. No material prepared in connection with the project shall be subject to copyright in the United States or in any other country.

24. NOTICE

- A. Any notice necessary to the performance of this Contract shall be given in writing by personal delivery or by prepaid first-class mail addressed as stated on the first page of this Contract.
- B. If notice is given by personal delivery, notice is effective as of the date of personal delivery. If notice is given by mail, notice is effective as of the day following the date of mailing or the date of delivery reflected upon a return receipt, whichever occurs first.

25. NONRENEWAL

Contractor acknowledges that there is no guarantee that County will renew Contractor's services under a new contract following expiration or termination of this Contract. Contractor waives all rights to notice of non-renewal of Contractor's services.

26. COUNTY'S OBLIGATION SUBJECT TO AVAILABILITY OF FUNDS

- A. The County's obligation under this Contract is subject to the availability of authorized funds. The County may terminate the Contract, or any part of the Contract work, without prejudice to any right or remedy of the County, for lack of appropriation of funds. If expected or actual funding is withdrawn, reduced or limited in any way prior to the expiration date set forth in this Contract, or any subsequent amendment, the County may, upon written Notice to the Contractor, terminate this Contract in whole or in part.
- B. Payment shall not exceed the amount allowable for appropriation by the Board of Supervisors. If the Contract is terminated for non-appropriation of funds:
 - (1) The County will be liable only for payment in accordance with the terms of this

Contract for services rendered prior to the effective date of termination; and

(2) The Contractor shall be released from any obligation to provide further services pursuant to this Contract that are affected by the termination.

C. Funding for this Contract beyond the current appropriation year is conditional upon appropriation by the Board of Supervisors of sufficient funds to support the activities described in this Contract. Should such an appropriation not be approved, this Contract will terminate at the close of the current appropriation year.

D. This Contract is void and unenforceable if all or parts of federal or state funds applicable to this Contract are not available to County. If applicable funding is reduced, County may either:

- (1) Cancel this Contract; or,
- (2) Offer a contract amendment reflecting the reduced funding.

27. CHANGES AND AMENDMENTS

A. County may request changes in Contractor's scope of services. Any mutually agreed upon changes, including any increase or decrease in the amount of Contractor's compensation, shall be effective when incorporated in written amendments to this Contract.

B. The party desiring the revision shall request amendments to the terms and conditions of this Contract in writing. Any adjustment to this Contract shall be effective only upon the parties' mutual execution of an amendment in writing.

C. No verbal agreements or conversations prior to execution of this Contract or requested amendment shall affect or modify any of the terms or conditions of this Contract unless reduced to writing according to the applicable provisions of this Contract.

28. CHOICE OF LAW

The parties have executed and delivered this Contract in the County of Solano, State of California. The laws of the State of California shall govern the validity, enforceability or interpretation of this Contract. Solano County shall be the venue for any action or proceeding that is not subject to the jurisdiction of a federal court, in law or equity that may be brought in connection with this Contract. The United States District Court for the Eastern District of California shall be the venue for any action or proceeding that is subject to the jurisdiction of a federal court.

29. HEALTH INSURANCE PORTABILITY AND ACCOUNTABILITY ACT

Contractor represents that it is knowledgeable of the Health Insurance Portability and Accountability Act of 1996 ("HIPAA") and its implementing regulations issued by the U.S. Department of Health and Human Services (45 C.F.R. parts 160-64) regarding the protection of health information obtained, created, or exchanged as a result of this Contract and shall abide by and implement its statutory requirements. State law may preempt HIPAA and Contractor must follow the most restrictive law, or both if applicable.

30. BACKGROUND SCREENING

A. If Contractor staff will have access to Personally Identifiable Information ("PII") and/or Protected Health Information ("PHI"), Contractor agrees to conduct a background screening of Contractor staff prior to granting access.

B. The background screening shall be commensurate with the risk and magnitude of harm the employee could cause. A more thorough screening shall be done for those employees who are authorized to bypass significant technical and operational security controls. County requires LiveScan, Office of Inspector General List of Excluded Individuals/Entities ("LEIE") and the General Services Administration

("GSA") Systems for Award Management ("SAM") screenings for all contractors and their workforce. In addition, contractors billing for Medi-Cal services must screen against the Department of Health Care Services Medi-Cal Suspended and Ineligible Provider List.

C. Contractor shall retain each of its staff members' background screening documentation for a period of three years following the conclusion of the employment relationship.

31. WAIVER

Any failure of a party to assert any right under this Contract shall not constitute a waiver or a termination of that right, under this Contract or any of its provisions.

32. CONFLICTS IN THE CONTRACT DOCUMENTS

The Contract documents are intended to be complementary and interpreted in harmony so as to avoid conflict. In the event of conflict in the Contract documents, the parties agree that the document providing the highest quality and level of service to the County shall supersede any inconsistent term in these documents.

33. FAITH BASED ORGANIZATIONS

A. Contractor agrees and acknowledges that County may make funds available for programs or services affiliated with religious organizations under the following conditions: (a) the funds are made available on an equal basis as for programs or services affiliated with non-religious organizations; (b) the program funded does not have the substantial effect of supporting religious activities; (c) the funding is indirect, remote, or incidental to the religious purpose of the organization; and (d) the organization complies with the terms and conditions of this Contract.

B. Contractor agrees and acknowledges that County may not make funds available for programs or services affiliated with a religious organization (a) that has denied or continues to deny access to services on the basis of any protected class; (b) will use the funds for a religious purpose; (c) will use the funds for a program or service that subjects its participants to religious education.

C. Contractor agrees and acknowledges that all recipients of funding from County must: (a) comply with all legal requirements and restrictions imposed upon government-funded activities set forth in Article IX, section 8 and Article XVI, section 5 of the California Constitution and in the First Amendment to the United States Constitution; and (b) segregate such funding from all funding used for religious purposes.

34. PRICING

Should Contractor, at any time during the term of this Contract, provide the same goods or services under similar quantity, terms and conditions to one or more counties in the State of California at prices below those set forth in this Contract, then the parties agree to amend this Contract so that such lower prices shall be extended immediately to County for all future services.

35. USE OF PROVISIONS, TERMS, CONDITIONS AND PRICING BY OTHER PUBLIC AGENCIES

Contractor and County agree that the terms of this Contract may be extended to any other public agency located in the State of California, as provided for in this section. Another public agency wishing to use the provisions, terms, and pricing of this Contract to contract for equipment and services comparable to those described in this Contract shall be responsible for entering into its own contract with Contractor, as well as providing for its own payment provisions, making all payments, and obtaining any certificates of insurance and bonds that may be required. County is not responsible for providing to any other public

agency any documentation relating this Contract or its implementation. Any public agency that uses provisions, terms, or pricing of this Contract shall by virtue of doing so be deemed to indemnify and hold harmless County from all claims, demands, or causes of actions of every kind arising directly or indirectly with the use of this Contract. County makes no guarantee of usage by other users of this Contract nor shall the County incur any financial responsibility in connection with any contracts entered into by another public agency. Such other public agency shall accept sole responsibility for placing orders and making payments to Contractor.

36. DEBARMENT AND SUSPENSION CERTIFICATION

A. By signing this Contract, Contractor certifies to the County that its officers, directors and employees (i) are not currently excluded, debarred, or otherwise ineligible to participate in a federally funded program or to be awarded a contract, subcontract or grant by the State; (ii) have not been convicted of a criminal offense related to the provision of federally funded items or services nor has been previously excluded, debarred, or otherwise declared ineligible to participate in any federally funded programs or to be awarded a contract, subcontract or grant by the State, and (iii) are not, to the best of its knowledge, under investigation or otherwise aware of any circumstances which may result in Contractor being excluded from participation in federally funded programs or from being awarded a contract, subcontract or grant by the State.

B. For purposes of this Contract, federally funded programs include, but are not limited to, any federal health program as defined in 42 USC § 1320a-7b(f) (the "Federal Healthcare Programs").

C. This certification shall be an ongoing certification during the term of this Contract and Contractor must immediately notify the County of any change in the status of the certification set forth in this section.

D. If services pursuant to this Contract involve federally funded programs, Contractor agrees to provide further certification of non-suspension with submission of each invoice. Failure to submit certification with invoices will result in a delay in County processing Contractor's payment.

37. EXECUTION IN COUNTERPARTS

This Contract may be executed in two or more counterparts, each of which together shall be deemed an original, but all of which together shall constitute one and the same instrument, it being understood that all parties need not sign the same counterpart. In the event that any signature is delivered by facsimile or electronic transmission (e.g., by e-mail delivery of a ".pdf" format data file), such signature shall create a valid and binding obligation of the party executing (or on whose behalf such signature is executed) with the same force and effect as if such facsimile or electronic signature page were an original signature.

38. LOCAL EMPLOYMENT POLICY

Solano County desires, whenever possible, to hire qualified local residents to work on County projects. A local resident is defined as a person who resides in, or a business that is located in, Solano County. The County encourages an active outreach program on the part of its contractors, consultants and agents. When local projects require subcontractors, Contractor shall solicit proposals for qualified local residents where possible.

39. ENTIRE CONTRACT

This Contract, including any exhibits referenced, constitutes the entire agreement between the parties and there are no inducements, promises, terms, conditions or obligations made or entered into by County or Contractor other than those contained in it.

EXHIBIT D
SPECIAL TERMS AND CONDITIONS

1. CONTRACT EXTENSION

Notwithstanding Sections 2 and 3 of the Standard Contract, and unless terminated by either party prior to contract termination date, at County's sole election, this Contract may be extended for up to ninety (90) days beyond the contract termination date to allow for continuation of services and sufficient time to complete a novation or renewal contract. In the event that this Contract is extended, compensation for the extension period shall not exceed \$685,933

2. HIPAA CONTRACTOR AGREEMENT

Contractor shall execute the Business Associate Agreement attached as Exhibit D-1.

3. NATIONAL VOTER REGISTRATION

Contractor represents that Contractor is knowledgeable of the National Voter Registration Act (NVRA) of 1993 in matters relating to providing voter registration services to any and all consumers who utilize public assistance and/or disability services in the County of Solano. Contractor and shall abide by its requirements.

EXHIBIT D-1

SOLANO COUNTY
HIPAA CONTRACTOR AGREEMENT

Crestwood Behavioral Health, Inc.

This Exhibit shall constitute the Business Associate Agreement (the “Agreement”) between the County of Solano (the “County”) and the Contractor or grant recipient (the “Contractor”) and applies to the functions Contractor will perform on behalf of the County (collectively, “Services”), that is identified in Exhibit A, Scope of Work.

- A County wishes to disclose certain information to Contractor pursuant to the terms of the Agreement, some of which may constitute Protected Health Information (“PHI”) (defined below).
- B County and its Contractor acknowledge that Contractor is subject to the Privacy and Security Rules (45 CFR parts 160 and 164) promulgated by the United States Department of Health and Human Services pursuant to the Health Insurance Portability and Accountability Act of 1996 (HIPAA), Public Law 104-191 as amended by the Health Information Technology for Economic and Clinical Health Act as set forth in Title XIII of Division A and Title IV of Division B of the American Recovery and Reinvestment Act of 2009 (“HITECH Act), in certain aspects of its operations performed on behalf of the County.
- C As part of the HIPAA Regulations, the Privacy Rule and the Security Rule (defined below) require County to enter into an Agreement containing specific requirements with Contractor prior to the disclosure of PHI, as set forth in, but not limited to, Title 45, sections 164.314(a), 164.502(e) and 164.504(e) of the Code of Federal Regulations (“C.F.R.”) and contained in this Agreement.

I. DEFINITIONS

Terms used, but not otherwise defined, in this Agreement shall have the same meaning as those terms in 45 CFR parts 160 and 164.

- 1. **Breach** means the same as defined under the HITECH Act [42 U.S.C. section 17921].
- 2. **Contractor** means the same as defined under the Privacy Rule, the Security rule, and the HITECH Act, including, but not limited to, 42 U.S.C. section 17938 and 45 C.F.R. § 160.103.
- 3. **Breach of the Security of the Information System** means the unauthorized acquisition, including, but not limited to, access to, use, disclosure, modification or destruction, of unencrypted computerized data that materially compromises the security, confidentiality, or integrity of personal information maintained by or on behalf of the County. Good faith acquisition of personal information by an employee or agent of the information holder for the purposes of the information holder is not a breach of the security of the system; provided, that the personal information is not used or subject to further unauthorized disclosure.
- 4. **Commercial Use** means obtaining protected health information with the intent to sell, transfer or use it for commercial, or personal gain, or malicious harm; sale to third party for consumption, resale, or processing for resale; application or conversion of data to make a profit or obtain a benefit contrary to the intent of this Agreement.

5. **Covered Entity means the same as defined** under the Privacy Rule and the Security rule, including, but not limited to, 45 C.F.R. § 160.103.
6. **Designated Record Set means the same as defined** in 45 C.F.R. § 164.501.
7. **Electronic Protected Health Information (ePHI) means the same as defined** in 45 C.F.R. § 160.103.
8. **Electronic Health Record means the same as defined** shall have the meaning given to such term in the HITECH Act, including, but not limited to, 42 U.S.C. § 17921.
9. **Encryption** means the process using publicly known algorithms to convert plain text and other data into a form intended to protect the data from being able to be converted back to the original plain text by known technological means.
10. **Health Care Operations means the same as defined** in 45 C.F.R. § 164.501.
11. **Individual means the same as defined** in 45 CFR § 160.103 and shall include a person who qualifies as a personal representative in accordance with 45 CFR § 164.502(g).
12. **Marketing means the same as defined** under 45 CFR § 164.501 and the act or process of promoting, selling, leasing or licensing any patient information or data for profit without the express written permission of County.
13. **Privacy Officer means the same as defined** in 45 C.F.R. § 164.530(a)(1). The Privacy Officer is the official designated by a County or Contractor to be responsible for compliance with HIPAA/HITECH regulations.
14. **Privacy Rule** means the Standards for Privacy of Individually Identifiable Health Information at 45 CFR parts 160 and 164, subparts A and E.
15. **Protected Health Information or PHI** means any information, whether oral or recorded in any form or medium: (i) that relates to the past, present or future physical or mental condition of an individual; the provision of health care to an individual; or the past, present or future payment for the provision of health care to an individual; and (ii) that identifies the individual or with respect to which there is a reasonable basis to believe the information can be used to identify the individual, and shall have the meaning given to such term under the Privacy Rule, including, but not limited to, 45 C.F.R. § 164.501. Protected Health Information includes Electronic Protected Health Information [45 C.F.R. §§ 160.103 and 164.501].
16. **Required by Law means the same as defined** in 45 CFR § 164.103.
17. **Security Rule** means the HIPAA Regulation that is codified at 45 C.F.R. parts 160 and 164, subparts A and C.
18. **Security Incident** means the attempted or successful unauthorized access, use, disclosure, modification, or destruction of information or interference with system operations in an information system.

19. **Security Event** means an immediately reportable subset of security incidents which incident would include:

- a. a suspected penetration of Contractor's information system of which the Contractor becomes aware of but for which it is not able to verify immediately upon becoming aware of the suspected incident that PHI was not accessed, stolen, used, disclosed, modified, or destroyed;
- b. any indication, evidence, or other security documentation that the Contractor's network resources, including, but not limited to, software, network routers, firewalls, database and application servers, intrusion detection systems or other security appliances, may have been damaged, modified, taken over by proxy, or otherwise compromised, for which Contractor cannot refute the indication of the time the Contractor became aware of such indication;
- c. a breach of the security of the Contractor's information system(s) by unauthorized acquisition, including, but not limited to, access to or use, disclosure, modification or destruction, of unencrypted computerized data and which incident materially compromises the security, confidentiality, or integrity of the PHI; and or,
- d. the unauthorized acquisition, including but not limited to access to or use, disclosure, modification or destruction, of unencrypted PHI or other confidential information of the County by an employee or authorized user of Contractor's system(s) which materially compromises the security, confidentiality, or integrity of PHI or other confidential information of the County.

If data acquired (including but not limited to access to or use, disclosure, modification or destruction of such data) is in encrypted format but the decryption key which would allow the decoding of the data is also taken, the parties shall treat the acquisition as a breach for purposes of determining appropriate response.

20. **Security Rule** means the Security Standards for the Protection of Electronic Protected Health Information at 45 CFR parts 160 and 164, subparts A and C.

21. **Unsecured PHI** means protected health information that is not rendered unusable, unreadable, or indecipherable to unauthorized individuals through the use of a technology or methodology specified by the Secretary. Unsecured PHI shall have the meaning given to such term under the HITECH Act and any guidance issued pursuant to such Act including, but not limited to, 42 U.S.C. section 17932(h).

II. OBLIGATIONS OF CONTRACTOR

1. Compliance with the Privacy Rule: Contractor agrees to fully comply with the requirements under the Privacy Rule applicable to "Business Associates" as defined in the Privacy Rule and not use or further disclose Protected Health Information other than as permitted or required by this agreement or as required by law.
2. Compliance with the Security Rule: Contractor agrees to fully comply with the requirements under the Security Rule applicable to "Business Associates" as defined in the Security Rule.
3. Compliance with the HITECH Act: Contractor hereby acknowledges and agrees it will comply with the HITECH provisions as proscribed in the HITECH Act.

III. USES AND DISCLOSURES

Contractor shall not use Protected Health Information except for the purpose of performing Contractor's obligations under the Contract and as permitted by the Contract and this Agreement. Further, Contractor shall not use Protected Health Information in any manner that would constitute a violation of the Privacy Rule or the HITECH Act if so used by County.

1. Contractor may use Protected Health Information:
 - a. For functions, activities, and services for or on the Covered Entities' behalf for purposes specified in the Contract and this Agreement.
 - b. As authorized for Contractor's management, administrative or legal responsibilities as a Contractor of the County. The uses and disclosures of PHI may not exceed the limitations applicable to the County;
 - c. As required by law.
 - d. To provide Data Aggregation services to the County as permitted by 45 CFR § 164.504(e)(2)(i)(B).
 - e. To report violations of law to appropriate Federal and State authorities, consistent with CFR § 164.502(j)(1).
2. Any use of Protected Health Information by Contractor, its agents, or subcontractors, other than those purposes of the Agreement, shall require the express written authorization by the County and a Business Associate Agreement or amendment as necessary.
3. Contractor shall not disclose Protected Health Information to a health plan for payment or health care operations if the patient has requested this restriction and has paid out of pocket in full for the health care item or service to which the Protected Health information relates.
4. Contractor shall not directly or indirectly receive remuneration in exchange for Protected Health Information, except with the prior written consent of County and as permitted by the HITECH Act, 42 U.S.C. section 17935(d)(2); however, this prohibition shall not affect payment by the County to Contractor for services provided pursuant to the Contract.
5. Contractor shall not use or disclose Protected Health Information for prohibited activities including, but not limited to, marketing or fundraising purposes.
6. Contractor agrees to adequately and properly maintain all Protected Health Information received from, or created, on behalf of County.
7. If Contractor discloses Protected Health Information to a third party, Contractor must obtain, prior to making any such disclosure, i) reasonable written assurances from such third party that such Protected Health Information will be held confidential as provided pursuant to this Agreement and only disclosed as required by law or for the purposes for which it was disclosed to such third party, and (ii) a *written* agreement from such third party to immediately notify Contractor of any breaches of confidentiality of the Protected Health Information, to the extent it has obtained knowledge of

such breach [42 U.S.C. section 17932; 45 C.F.R. §§ 164.504(e)(2)(i), 164.504(e)(2)(i)(B), 164.504(e)(2)(ii)(A) and 164.504(e)(4)(ii)].

IV. MINIMUM NECESSARY

Contractor (and its agents or subcontractors) shall request, use and disclose only the minimum amount of Protected Health necessary to accomplish the purpose of the request, use or disclosure. [42 U.S.C. section 17935(b); 45 C.F.R. § 164.514(d)(3)]. Contractor understands and agrees that the definition of “minimum necessary” is in flux and shall keep itself informed of guidance issued by the Secretary with respect to what constitutes “minimum necessary.”

V. APPROPRIATE SAFEGUARDS

1. Contractor shall implement appropriate safeguards as are necessary to prevent the use or disclosure of Protected Health Information otherwise than as permitted by this Agreement, including, but not limited to, administrative, physical and technical safeguards that reasonably and appropriately protect the confidentiality, integrity and availability of the Protected Health Information in accordance with 45 C.F.R. §§ 164.308, 164.310, and 164.312. [45 C.F.R. § 164.504(e)(2)(ii)(B); 45 C.F.R. § 164.308(b)]. Contractor shall comply with the policies and procedures and documentation requirements of the HIPAA Security Rule, including, but not limited to, 45 C.F.R. § 164.316. [42 U.S.C. section 17931].
2. Contractor agrees to comply with Subpart 45 CFR part 164 with respect to Electronic Protected Health Information (ePHI). Contractor must secure all Electronic Protected Health Information by technological means that render such information unusable, unreadable, or indecipherable to unauthorized individuals and in accordance with the National Institute of Standards Technology (NIST) Standards and Federal Information Processing Standards (FIPS) as applicable.
3. Contractor agrees that destruction of Protected Health Information on paper, film, or other hard copy media must involve either crosscut shredding or otherwise destroying the Protected Health Information so that it cannot be read or reconstructed.
4. Should any employee or subcontractor of Contractor have direct, authorized access to computer systems of the County that contain Protected Health Information, Contractor shall immediately notify County of any change of such personnel (e.g. employee or subcontractor termination or change in assignment where such access is no longer necessary) in order for County to disable previously authorized access.

VI. AGENT AND SUBCONTRACTOR’S OF CONTRACTOR

1. Contractor shall ensure that any agents and subcontractors to whom it provides Protected Health Information, agree in writing to the same restrictions and conditions that apply to Contractor with respect to such PHI and implement the safeguards required with respect to Electronic PHI [45 C.F.R. § 164.504(e)(2)(ii)(D) and 45 C.F.R. § 164.308(b)].
2. Contractor shall implement and maintain sanctions against agents and subcontractors that violate such restrictions and conditions and shall mitigate the effects of any such violation (see 45 C.F.R. §§ 164.530(f) and 164.530(e)(I)).

VII. ACCESS TO PROTECTED HEALTH INFORMATION

1. If Contractor receives Protected Health Information from the County in a Designated Record Set, Contractor agrees to provide access to Protected Health Information in a Designated Record Set to the County in order to meet its requirements under 45 C.F.R. § 164.524.
2. Contractor shall make Protected Health Information maintained by Contractor or its agents or subcontractors in Designated Record Sets available to County for inspection and copying within five (5) days of a request by County to enable County to fulfill its obligations under state law, [Health and Safety Code section 123110] the Privacy Rule, including, but not limited to, 45 C.F.R. § 164.524 [45 C.F.R. § 164.504(e)(2)(ii)(E)]. If Contractor maintains an Electronic Health Record, Contractor shall provide such information in electronic format to enable County to fulfill its obligations under the HITECH Act, including, but not limited to, 42 U.S.C. section 17935(e).
3. If Contractor receives a request from an Individual for a copy of the individual's Protected Health Information, and the Protected Health Information is in the sole possession of the Contractor, Contractor will provide the requested copies to the individual in a timely manner. If Contractor receives a request for Protected Health Information not in its possession and in the possession of the County, or receives a request to exercise other individual rights as set forth in the Privacy Rule, Contractor shall promptly forward the request to the County. Contractor shall then assist County as necessary in responding to the request in a timely manner. If a Contractor provides copies of Protected Health Information to the individual, it may charge a reasonable fee for the copies as the regulations shall permit.
4. Contractor shall provide copies of HIPAA Privacy and Security Training records and HIPAA policies and procedures within five (5) calendar days upon request from the County.

VIII. AMENDMENT OF PROTECTED HEALTH INFORMATION

Upon receipt of notice from County, Contractor shall promptly amend or permit the County access to amend any portion of Protected Health Information in the designated record set which Contractor created for or received from the County so that the County may meet its amendment obligations under 45 CFR § 164.526. If any individual requests an amendment of Protected Information directly from Contractor or its agents or subcontractors, Contractor must notify the County in writing within five (5) days of the request. Any approval or denial of amendment of Protected Information maintained by Contractor or its agents or subcontractors shall be the responsibility of the County [45 C.F.R. § 164.504(e)(2)(ii)(F)].

IX. ACCOUNTING OF DISCLOSURES

1. At the request of the County, and in the time and manner designed by the County, Contractor and its agents or subcontractors shall make available to the County, the information required to provide an accounting of disclosures to enable the County to fulfill its obligations under the Privacy Rule, including, but not limited to, 45 C.F.R. § 164.528, and the HITECH Act, including but not limited to 42 U.S.C. § 17935. Contractor agrees to implement a process that allows for an accounting to be collected and maintained by the Contractor and its agents or subcontractors for at least six (6) years prior to the request. However, accounting of disclosures from an Electronic Health Record for treatment, payment or health care operations purposes are required to be collected and maintained for only three (3) years prior to the request, and only to the extent that Contractor maintains an electronic health record and is subject to this requirement.
2. At a minimum, the information collected and maintained shall include: (i) the date of disclosure; (ii) the name of the entity or person who received Protected Health Information and, if known, the address of the entity or person; (iii) a brief description of Protected Information disclosed; and (iv) a brief statement of purpose of the disclosure that reasonably informs the individual of the basis for the disclosure, or a copy of the individual's authorization, or a copy of the written request for disclosure.

3. In the event that the request for an accounting is delivered directly to Contractor or its agents or subcontractors, Contractor shall forward within five (5) calendar days a written copy of the request to the County. It shall be the County's responsibility to prepare and deliver any such accounting requested. Contractor shall not disclose any Protected Information except as set forth in this Agreement [45 C.F.R. §§ 164.504(e)(2)(ii)(G) and 165.528]. The provisions of this paragraph shall survive the termination of this Agreement.

X. GOVERNMENTAL ACCESS TO RECORDS

Contractor shall make its internal practices, books and records relating to its use and disclosure of the protected health information it creates for or receives from the County, available to the County and to the Secretary of the U.S. Department of Health and Human for purposes of determining Contractor's compliance with the Privacy rule [45 C.F.R. § 164.504(e)(2)(ii)(H)]. Contractor shall provide to the County a copy of any Protected Health Information that Contractor provides to the Secretary concurrently with providing such Protected Information to the Secretary.

XI. CERTIFICATION

To the extent that the County determines that such examination is necessary to comply with the Contractor's legal obligations pursuant to HIPAA relating to certification of its security practices, County, or its authorized agents or contractors may, at the County's expense, examine Contractor's facilities, systems, procedures and records as may be necessary for such agents or contractors to certify to County the extent to which Contractor's security safeguards comply with HIPAA Regulations, the HITECH Act, or this Agreement.

XII. BREACH OF UNSECURED PROTECTED HEALTH INFORMATION

1. In the case of a breach of unsecured Protected Health Information, Contractor shall comply with the applicable provisions of 42 U.S.C. § 17932 and 45 C.F.R. part 164, subpart D, including but not limited to 45 C.F.R. § 164.410.
2. Contractor agrees to notify County of any access, use or disclosure of Protected Health Information not permitted or provided for by this Agreement of which it becomes aware, including any breach as required in 45 C.F.R. § 164.410. or security incident immediately upon discovery by telephone at 707-784-3198 and hss-compliance@solanocounty.gov or through the online reporting portal at <https://solanocounty.cqs.symplr.com/Portal> and will include, to the extent possible, the identification of each Individual whose unsecured Protect Health Information has been, or is reasonably believed by the Contractor to have been accessed, acquired, used, or disclosed, a description of the Protected Health Information involved, the nature of the unauthorized access, use or disclosure, the date of the occurrence, and a description of any remedial action taken or proposed to be taken by Contractor. Contractor will also provide to County any other available information that the County requests.
3. A breach or unauthorized access, use or disclosure shall be treated as discovered by the Contractor on the first day on which such unauthorized access, use, or disclosure is known, or should reasonably have been known, to the Contractor or to any person, other than the individual committing the unauthorized disclosure, that is an employee, officer, subcontractor, agent or other representative of the Contractor.

4. Contractor shall mitigate, to the extent practicable, any harmful effect that results from a breach, security incident, or unauthorized access, use or disclosure of unsecured Protected Health Information by Contractor or its employees, officers, subcontractors, agents or representatives.
5. Following a breach, security incident, or any unauthorized access, use or disclosure of unsecured Protected Health Information, Contractor agrees to take any and all corrective action necessary to prevent recurrence, to document any such action, and to make all documentation available to the County.
6. Except as provided by law, Contractor agrees that it will not inform any third party of a breach or unauthorized access, use or disclosure of Unsecured Protected Health Information without obtaining the County's prior written consent. County hereby reserves the sole right to determine whether and how such notice is to be provided to any individuals, regulatory agencies, or others as may be required by law, regulation or contract terms, as well as the contents of such notice. When applicable law requires the breach to be reported to a federal or state agency or that notice be given to media outlets, Contractor shall cooperate with and coordinate with County to ensure such reporting is in compliance with applicable law and to prevent duplicate reporting, and to determine responsibilities for reporting.
7. Contractor acknowledges that it is required to comply with the referenced rules and regulations and that Contractor (including its subcontractors) may be held liable and subject to penalties for failure to comply.
8. In meeting its obligations under this Agreement, it is understood that Contractor is not acting as the County's agent. In performance of the work, duties, and obligations and in the exercise of the rights granted under this Agreement, it is understood and agreed that Contractor is at all times acting an independent contractor in providing services pursuant to this Agreement and Exhibit A, Scope of Work.

XIII. TERMINATION OF AGREEMENT

1. Upon termination of this Agreement for any reason, Contractor shall return or destroy, at County's sole discretion, all other Protected Health Information received from the County, or created or received by Contractor on behalf of the County.
2. Contractor will retain no copies of Protected Health Information in possession of subcontractors or agents of Contractor.
3. Contractor shall provide the County notification of the conditions that make return or destruction not feasible, in the event that Contractor determines that returning or destroying the PHI is not feasible. If the County agrees that the return of the Protected Health Information is not feasible, Contractor shall extend the protections of this Agreement to such Protected Health Information and limit further use and disclosures of such Protected Health Information for so long as the Contractor or any of its agents or subcontractor maintains such information.
4. Contractor agrees to amend this Exhibit as necessary to comply with any newly enacted or issued state or federal law, rule, regulation or policy, or any judicial or administrative decision affecting the use or disclosure of Protected Health Information.
5. Contractor agrees to retain records, minus any Protected Health Information required to be returned by the above section, for a period of at least 7 years following termination of the Agreement. The

determining date for retention of records shall be the last date of encounter, transaction, event, or creation of the record.

XIV. QUALIFIED SERVICE ORGANIZATION

To the extent that Contractor is also considered a Qualified Service Organization (“QSO”), with access to protected substance abuse treatment information, this Agreement shall be considered a Qualified Services Organization Agreement as required by 42 C.F.R. Part 2, and Contractor agrees to the following:

1. In receiving, storing, processing or otherwise dealing with any protected substance abuse information from County, Contractor is fully bound by the provisions of the federal regulations governing confidentiality of alcohol and drug abuse patient records, 42. C.F.R. Part 2.
2. If necessary, Contractor will resist in judicial proceedings any efforts to obtain access to protected substance abuse information, including patient identifying information related to substance use disorder diagnosis, treatment, or referral for treatment, except and unless access is expressly permitted under 42 C.F.R. Part 2. (See 42 C.F.R. § 2.12(c)(4).)
