*The Solano County Board of Supervisors met on the 2nd day of December, 2025 in regular session in the Board of Supervisors' Chambers at the Solano County Government Center, 675 Texas Street, Fairfield, California at 9:06 A.M.*

## PUBLIC COMMENT ON CONSENT CALENDAR

*Chair Mashburn invited members of the public to address the Board on items listed on the Consent Calendar. The following comments were received:*

*A) James Pierson commented on Consent Calendar Item 6 and expressed support for the Board assuming control of the emergency medical services authority, but raised concerns that the current RFP process does not allow bidders to acknowledge addendums.*

*County Counsel Carrie Blacklock explained that formal written addendums requiring proposer acknowledgment are intended for substantive changes to an RFP, which is not the case here. Ms. Blacklock further stated the only change being made is a name change to inform the public the County will be the contracting agency. Ms. Blacklock stated there are no changes in terms, conditions, or obligations and there will be no affect to the fairness or integrity of the RFP process.*

*Supervisor Williams commented on Consent Calendar Item 6 and requested clarification on the name change and the potential impact it may have on the RFP process, specifically with the State of California.*

*Ms. Blacklock stated that staff has already consulted with the state, which requested to be formally notified by addendum to the RFP once the designation has been officially made.*
