RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS HONORING ANGELITA VALLEJO-FELIX, SENIOR DEPUTY PROBATION OFFICER UPON HER RETIREMENT FROM THE SOLANO COUNTY PROBATION DEPARTMENT WITH 30 YEARS OF DEDICATED SERVICE

WHEREAS, Angelita Vallejo-Felix began her employment with Solano County in the Public Health Department on December 4, 1995. Angelita joined the Probation Department as a Deputy Probation Officer on May 13, 2001, and was promoted to Senior Deputy Probation Officer on June 19, 2005; and

WHEREAS, Angelita provided over three decades of service to the Solano County community and was influential in many ways and through different assignments within the Department, applying professional skills and a compassionate approach to the supervision, support, and guidance of probation clients; and

WHEREAS, during her career, Angelita worked with clients in both the Juvenile and Adult Divisions in Juvenile Sex Offender, Placement and Intake, Domestic Violence, Post-Release Community Supervision, Intensive/General Supervision, the Center for Positive Change, Offender Link/Placement, and the Adult Court Units. Her years of work with at-risk youth involved providing support, supervision, and a caring disposition. Her work with adult clients proceeded no differently, as she continued to exemplify what it is to show care, all while working collaboratively and building effective relationships with law enforcement agencies and community partners throughout the County; and

WHEREAS, Angelita was instrumental in the development of the Probation Enforcement & Search Team, the Probation Department's Field Officer and Firearms Training, and the Post-Release Community Supervision/Realignment Unit. She played an important role in the Department's Employee Development Program, was a Department Training Instructor and Group Facilitator, and contributed to the development and implementation of evidence-based practices and cognitive behavior therapy groups. Seeing value in wellness and in acknowledging others, Angelita served as a Department Wellness Ambassador and was a member of the awards committee; and

WHEREAS, while assigned to the Adult Court Investigations Unit, Angelita conducted thorough investigations, prepared detailed reports, and completed accurate assessments used to provide the Court with suitable recommendations to assist in making informed sentencing decisions. Angelita ended her career with Probation in a pivotal role in the Department's New Hire Training and Development Program. She participated in training new staff in the Adult Court Investigations Unit, where her expertise was invaluable and integral to the program's success; and

WHEREAS, Angelita has impacted the lives of many throughout her Probation career in her role as a Probation Officer, colleague, and trainer. The absence of her expertise and dedication to public safety will be felt, but her impact will endure through the practices, values, and connections she helped cultivate throughout her time with Probation.

NOW, THEREFORE BE IT RESOLVED, that the Solano County Board of Supervisors hereby honors and recognizes Angelita Vallejo-Felix for her 30 years of dedicated service to the citizens of Solano County, and wishes her success in her future endeavors and a long, happy, and well-deserved retirement.
