

SECOND AMENDMENT TO STANDARD CONTRACT BETWEEN COUNTY OF SOLANO

and ALLISON INLOW, DVM

This Second Amendment to County of Solano Standard Agreement ("Second Amendment") is made on July 31, 2024, between the **County of Solano**, a political subdivision of the State of California, ("County"), and **ALLISON INLOW, DVM** ("Contract Employee").

1. Recitals

- A. The parties entered into a contract dated April 1, 2024 (the "Contract"), as amended by the First Amendment dated June 30, 2024 (together the "Contract") in which the Contract Employee agreed to provide on-site animal shelter veterinary services to all animals received and/or residing at Solano County Animal Care.
- B. The County now needs to increase the amount and extend the term of the Contract.
- C. This Second Amendment represents an increase of \$309,886 and 11-month extension of the Contract.
- D. The parties agree to amend the Contract as set forth below.

2. Agreement

A. Term of Contract

Section 2 of the Standard Contract is deleted in its entirety and replaced with:

The term of this Contract is April 1, 2024 to June 30, 2025

B. Amount of Contract

Section 3 of the Standard Contract is deleted in its entirety and replaced with:

The maximum amount of this Contract is \$366,941

C. Exhibit B. Budget Detail and Payment Provisions

Subsection A.1 *Hourly Rate* is deleted in its entirety and replaced with:

The hourly rate of \$125.00 for a total of 1,928 hours to be worked for a maximum of \$241,000 for April 1, 2024 to June 30, 2025. It is anticipated that the Contract Employee will typically work no more than 32 hours per week.

Subsection A.2 *Employer-paid payroll related costs* is amended as follows:

CalPERS(total hourly rate amount x 31.60%)	\$59,408
FICA costs (total hourly rate amount x 6.20%)	\$14,942
Medicare costs (total hourly rate amount x 1.45%)	\$3,495
Pension Obligation Bonds(total hourly rate amount x 15.64%)	\$29,403

To the extent Contract Employee works over 30 hours a week: Affordable Health Care (80% of current rate for full-time regular position) \$18,693

3. Effectiveness of Contract

Except as set forth in this Second Amendment, all other terms and conditions specified in the Contract remain in full force and effect.
