Chief Executive Officer for the California State Association of Counties (CSAC) Graham Knaus provided an overview of the mission and operations of CSAC. Mr. Knaus further provided information on the ways in which CSAC can partner with and support Solano County.

Supervisor Brown commented in support of a continuation of CSAC weekly webinars.

Supervisor Williams thanked Mr. Knaus for the presentation and advocacy that CSAC does on behalf of all California counties and stated she has enjoyed taking CSAC certification classes.

Supervisor James thanked Mr. Knaus for the presentation and stated she is excited for the upcoming tour of Solano County.

Chair Mashburn thanked Mr. Knaus for the presentation. Chair Mashburn commented on the need for CSAC to represent the County's needs in relation to water, including the Delta Conveyance Project and the Healthy Rivers and Landscapes Project. Chair Mashburn further commented on the need for CSAC to address the push from the State of California to usurp local authority on land use decisions.

In response to Chair Mashburn's comments, Mr. Knaus stated he will follow up on the Healthy Rivers and Landscapes project. Mr. Knaus further stated Chair Mashburn's comments are correct, noting there is a national movement to remove local authority and put it in the hands of state governments, noting it is a substantial issue. Mr. Knaus further stated CSAC is aware of the issues, and they have been communicating to the State legislature that adopted policies must incorporate local government flexibility to enable local governments to respond to their communities or those policies will fail.

Supervisor Williams stated she will have her staff follow up with Mr. Knaus with regard to the Health Rivers and Landscapes Project.

Chair Mashburn invited members of the public to address the Board on this matter. There was no public comment.

Chief Information Officer Tim Flanagan introduced the item and provided an overview of the current progress of previously approved ARPA and State funded broadband and digital equity programs.

In response to a question from Supervisor Brown regarding the loss of federal funding for digital equity programs and if the County can do anything about the loss, Mr. Flanagan stated he can only impact things locally, not at the federal level.

In response to a question from Supervisor Williams regarding the \$13,201,420 that the California Public Utilities Commission (CPUC) has not yet distributed to Solano County, IT Infrastructure and Operations Manager Stewart Bruce stated the Governor of California withheld the funding due to State budget shortfalls. Mr. Bruce further stated the CPUC has not released additional opportunities to apply for funding, and are only releasing already approved funding to counties that had not previously received funding.

In response to Mr. Bruce's comments, Supervisor Williams stated staff will need to follow up with the County's state legislators regarding the unreleased funding.

Chair Mashburn invited members of the public to address the Board on this matter. There was no public comment.

Principal Management Analyst Megan Richards introduced the item and provided an overview of the progress of previously approved ARPA funded projects.

In response to a question from Supervisor Vasquez regarding if the build out of the P25 Radio System project in Benicia and Vallejo has been completed, Ms. Richards stated it has not been completed as of yet; however, it is expected to be complete in spring of 2026.

In response to a question from Supervisor Williams regarding funding of the P25 Radio System Project, Chief Information Officer Tim Flanagan provided an overview of the progress of the countywide P25 Radio System Project.

Chair Mashburn invited members of the public to address the Board on this matter. There was no public comment.

Chair Mashburn further stated however, those were the feelings that were expressed by the Sheriff's Deputies during the negotiations; therefore, while he apologizes for personally offending Council Member Lediju, he can not retract the statements he made.
