**RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS APPROVING  
TENTATIVE AGREEMENT WITH THE CORRECTIONAL OFFICERS, SOLANO  
COUNTY SHERIFF'S CUSTODY ASSOCIATION (UNIT 13) AND DELEGATING  
AUTHORITY TO THE COUNTY ADMINISTRATIVE OFFICER OR DIRECTOR OF  
HUMAN RESOURCES TO EXECUTE THE SUCCESSOR MEMORANDUM OF  
UNDERSTANDING**

**WHEREAS**, the County of Solano ("County") and the Correctional Officers, Solano County Sheriff's Custody Association ("Correctional Officers"), representing Unit 13, are parties to a Memorandum of Understanding ("MOU") governing wages, hours, and other terms and conditions of employment; and

**WHEREAS**, the County and Correctional Officers have negotiated in good faith and reached a Tentative Agreement on December 31, 2025 for a successor MOU for Unit 13, with a term beginning January 13, 2026 and expiring October 28, 2028; and

**WHEREAS**, the Tentative Agreement has been ratified by the membership of the Correctional Officers, Solano County Sheriff's Custody Association, Unit 13; and

**WHEREAS**, the parties are in the process of finalizing the written successor MOU consistent with the ratified Tentative Agreement; and

**WHEREAS**, it is in the best interest of the County to approve the Tentative Agreement and authorize execution of the successor MOU once finalized, provided it is consistent with the agreement approved by the Board;

**NOW, THEREFORE BE IT RESOLVED**, that the Solano County Board of Supervisors hereby:

1. Approves the Tentative Agreement between the County and the Correctional Officers, Solano County Sheriff's Custody Association, representing Unit 13, as ratified by the bargaining unit membership on December 31, 2025, for the term January 13, 2026 through October 28, 2028; and
2. Delegates authority to the County Administrative Officer or Director of Human Resources to execute the successor Memorandum of Understanding and to make technical, non-substantive adjustments, with the Correctional Officers, Solano County Sheriff's Custody Association, Unit 13, once finalized, provided that the final document is consistent with the Tentative Agreement approved by this Board; and
3. Authorizes the implementation of the terms of the Tentative Agreement in accordance with applicable County policies.
