Deputy Director of Health and Social Services for Behavioral Health Sandra Sinz introduced the item and provided an overview of AB 1769.

Public Health Officer Dr. Bela Matyas provided information on mental health care options that the legislation would allow the department to provide.

Chairwoman Hannigan invited members of the public to address the Board on this matter and the following comments were received:

A) Sue Moore, Fairfield, commented in support of the legislation.

B) Linda Privatte, Vacaville, commented in support of the legislation.

C) Patty Phillips, Vacaville, commented in support of the legislation.

D) Jodi Smith, Fairfield, commented on concerns about her experience with mental health services.

Supervisor Brown advised that the Mental Health Advisory Board was in support of the legislation.

In response to comments from Chairwoman Hannigan, Ms. Sinz provided information on where the proposed facility would be built on the Beck Campus. Dr. Matyas advised that it would be next to the existing lab building.

County Administrator Birgitta Corsello provided information on the long term planning for the Beck Campus and noted that Santa Clara, Contra Costa and Sacramento counties were also looking at building facilities for mental health beds. She noted that there would be room for an expanded or new crisis center, additional mental health capacity and advised that the concept would be a cluster of several buildings instead of multi-story buildings.

Chairwoman Hannigan noted that the funding would come from the State's General Fund.

In response to questions from Supervisor Thomson, Dr. Matyas advised that the legislation was being heard in the Assembly Health Committee that day.

Supervisor Thomson noted that there was an aggressive timeline for building the facility and asked about certification.

Ms. Sinz noted that official certification of the building would happen after it was completed and advised that staff could have conversations with the Community Care licensing about the concept to make sure things were on the right track.

Supervisor Thomson noted that the legislation required funding to be available for four years.

Ms. Sinz advised that the County would need to move quickly due to the timeline.

In response to comments from Supervisor Vasquez, Ms. Sinz provided a history of the interest and conversations that led to the introduction of the legislation.

Ms. Corsello noted that there was a loss and changes recently for shelters in the County and provided information on discussions that had taken place in regards to the proposed facility and legislation.

Chairwoman Hannigan commented in support of the legislation.

Supervisor Spering commented in support of the legislation and recommended continuing to look at the needs with other neighboring counties and to look at how to jointly support a regional facility like this.

On motion of Supervisor Spering, seconded by Supervisor Brown, the Board approved a support position on AB1769 (Frazier) which requests \$14 million in State General Fund to construct a mental health residential program on the Beck campus in Fairfield on the site designated for a mental health facility in the master plan. Napa-Solano Area Agency on Aging Administrator/Executive Director Joyce Goodwin introduced the item.

Napa-Solano Area Agency on Aging (AAA) Project Manager Elaine Clark provided an overview of the AAA programs and funding.

Chairwoman Hannigan commented in support of the work being done on the programs. She then commented on membership, noting that one candidate for appointment to the AAA Advisory Board was also already a member of the Senior Coalition.

Ms. Goodwin noted that there were three individuals on the Senior Coalition that were being proposed for appointment to the AAA Advisory Council.

In response to a question from Chairwoman Hannigan, Public Health Officer Dr. Bela Matyas noted that it was at the Board's discretion on the appointments. He advised that the proposed individuals were interested in the appointment. Ms. Clark advised that the application for the AAA Advisory Council did ask for background but not whether the individual was already serving on a senior board in the County.

Chairwoman Hannigan advised that she was not in support of having an individual serving on both the Senior Coalition and the AAA Oversight Board.

In response to a question from Supervisor Vasquez, Ms. Goodwin noted that the individual could be asked to choose. Ms. Corsello noted that this was a policy decision by the Board.

Supervisor Vasquez advised that the individual should apply for the one they wanted to sit on and asked if there were other individuals that applied but weren't being recommended.

Dr. Matyas advised that the Senior Coalition had supplied its recommended appointments for the coalition. He noted that there were others that had applied for the AAA Advisory Board. He advised that the Board's options would be to delay the appointments and request that the individuals choose which board they'd like to serve on or the Board could approve the appointments now with a proviso that an individual could only serve on one.

In response to a comment from Supervisor Vasquez, Dr. Matyas advised that not approving any appointments today would set things back.

Chairwomen Hannigan suggested not approving the individuals that would be appointed to both boards and for staff to contact them to see which board they wanted to serve on.

Dr. Matyas advised that staff could conduct either option and then report back to the Board on where the gaps were.

Supervisor Brown noted time constraints with the state and commented on the need to get the appointments in place for the AAA Advisory Council. She suggested that the recommended individuals be appointed and to let the individuals decide which board they wished to serve on. She noted that the gaps could then be filled afterwards.

Dr. Matyas advised that five appointments needed to be made in order to keep things moving forward.

Chairwoman Hannigan commented in support of the suggestion.

Supervisor Spering asked if there was any advantage to having an individual serve on both boards.

Dr. Matyas advised that the missions of the two boards were different and provided additional information on the benefits of having participation in both boards.

Supervisor Spering commented on the benefits of having a dually appointed individual and noted that he was supportive of approving the appointments and letting the individuals choose which board to serve on.

Supervisor Vasquez commented in support of appointing the five individuals today and letting the other three individuals reapply for the position on the board they wanted to serve on.

Chairwoman Hannigan invited members of the public to address the Board on this matter and the following comments were received:

A) Steve Sillen, Fairfield, advised that there were only two members that would be on both boards as he was on the AAA Oversight Board and not the AAA Advisory Council, and then commented in support of having someone sit on both the Senior Coalition and the AAA Advisory Council.

B) Brenda Crawford, Senior Coalition, commented in support of serving on both committees and of LGBT programs for seniors.

Chairwoman Hannigan noted that having dual appointments was a matter of broader representation.

C) Lauren Rolfe, Senior Coalition, commented in support of serving on both boards.

Chairwoman Hannigan noted that there were more applicants wanting to serve than there were positions.

In response to a question from Supervisor Vasquez, Dr. Matyas noted that responsibility of contracts for the AAA and the Senior Coalition fell under the Department of Health and Social Services.

County Administrator Birgitta Corsello noted past concerns about the AAA and its relationship with the community. She advised that everything had been redesigned and that it was important to get things squared away to begin addressing the state and federal requirements to start a needs assessment.

Chairwoman Hannigan suggested separating the vote in order to vote separately on the recommended action items.

Supervisor Brown and Supervisor Spering commented in agreement to separating the items.

In response to a question from Supervisor Spering, Napa-Solano Area Agency on Aging Administrator/Executive Director Joyce Goodwin advised that the Board member's appointments on Items 25 and 26 to the Senior Coalition were separate from this item. Public Health Officer Dr. Bela Matyas also commented on the appointments to the Senior Coalition.

County Administrator Birgitta Corsello advised that Items 25 and 26 were bundled with the rest of the items about the Senior Coalition. She advised that it was at the discretion of the Board on how to proceed.

Supervisor Spering asked if there was any action on Item 24 that would preclude the appointments on Items 25 and 26.

Ms. Corsello advised that it depended on the direction of the Board as to the membership makeup of the Senior Coalition.

Public Health Officer Dr. Bela Matyas provided an overview of the Senior Coalition.

Chairwoman Hannigan invited members of the public to address the Board on this matter and the following comments were received:

A) Father Robert T. Fuentes, Chair of the Senior Coalition, commented on the work done by individuals on the Senior Coalition over the past year, in support of individuals serving on more than one committee and noted that the bylaws of the Senior Coalition included a seat for someone that was on the AAA Advisory Council.

Chairwoman Hannigan commented on Item 23 appointments and advised that it would be up to Dr. Matyas to follow up on the duplication of appointments between the AAA and Senior Coalition.

Ms. Corsello advised that she wasn't sure that there needed to be 27 positions on the Senior Coalition and provided information on current activities and efforts taking place.

Chairwoman Hannigan advised that there were vacancies on the Senior Coalition and provided information on senior activities around the County.

Supervisor Vasquez thanked Father Fuentes for his efforts and commented on the need for the Board's Senior Issues Committee to meet with the Senior Coalition to look at the gaps and how to blend services and eliminate overlap in order to come back with a new set of plans for the coalition. He advised that he was not supportive of increasing the contract for the Senior Coalition's coordinator.

Supervisor Thomson advised that there usually wasn't an issue with having too many volunteers and noted that he was encouraged by all the volunteers on the Senior Coalition. He then commented on the coordinator's contract and the previous year's Centenarian Celebration. He noted that the prior contractor for the coalition coordinator did have an increase in their contract, that it was a good investment and was a far less amount than the last contractor.

Ms. Corsello provided information on the joint efforts to put on the annual Centenarian Celebration event, noting that there were some issues with quality control and that there was a lot of support for the event from other people other than the contracted individual. She noted that majority of the contract had been spent in the first three months.

Dr. Matyas noted that the structure of the contract was for time and service. He advised that the contracted individual did spend more time than anticipated in prepping for the Centenarian Celebration event and for meetings of subcommittees. He noted that there had been a transition from the prior individual's contract and that the new individual had to learn a lot and should be more experienced as time goes by. He advised that closer monitoring of the contract would have helped and that he expected to be fully within contract next year.

Supervisor Vasquez noted that this was the second Centenarian Celebration event that this person was involved with.

Dr. Matyas advised that the event was included in this current year, but not in the prior partial year contract.

Supervisor Vasquez commented on issues with the event two years prior and noted that his office had to fix many issues.

In response to a question from Chairwoman Hannigan, Dr. Matyas advised that it was not possible for the individual to participate in the event two years ago as they didn't come on board until late in the year.

Supervisor Spering requested to hear from the coordinator as to what had happened. Father Fuentes advised that she was out of town.

Supervisor Spering requested that the appointments and contract be voted on separately.

On motion of Supervisor Thomson, seconded by Supervisor Brown, the Board directed that the original purpose and mission of the Senior Coalition of Solano County be worked on by the Senior Issues Committee with the Senior Coalition; and Appointed Rev. Robert T. Fuentes, Cindi Royval-Unger, Jenalee Dawson, Laurie Hartmann, Lauren Rolfe, Louise Joyce, Karen Mickens, Wallace Pearce, Debbie McQuilkin and Jessica Duplantis to the Solano County Senior Coalition for 2 year terms to expire on April 23, 2021. So ordered by 5-0 vote.

On motion of Supervisor Thomson, seconded by Supervisor Brown, the Board approved the request from the Senior Coalition for \$9,620 in County General Fund for FY2018/19 through June 30, 2019 to increase the Senior Coalition Contractor agreement. Supervisor Vasquez voted no. So ordered by 4-1 vote.

On motion of Supervisor Sperring, seconded by Supervisor Brown, the Board approved the appointment of Barbara King to the Senior Coalition of Solano County, representing District 3, for a 2 year term to expire on April 23, 2021. So ordered by 5-0 vote.
