

# Resolution No. 2025-194

## RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS DESIGNATING THE WEEK OF SEPTEMBER 7-13, 2025 AS NATIONAL SUICIDE PREVENTION WEEK IN SOLANO COUNTY

**WHEREAS**, suicides are the 11<sup>th</sup> leading cause of death in the United States; and

**WHEREAS**, in 2023, there were an estimated 1.5 million suicide attempts in the United States and over 49,000 Americans died by suicide according to the American Foundation for Suicide Prevention; and

**WHEREAS**, in 2024, there were 53 suicide deaths in Solano County; and, in the first six months of 2025, there have been 25 suicide deaths, which is six less than this same time last year; and

**WHEREAS**, nationally 39% of LGBTQ+ young people seriously considered attempting suicide in the past year, and over half of transgender and nonbinary youth seriously considered suicide, according to the Trevor Project; and

**WHEREAS**, the stigma associated with behavioral health conditions, societal norms, and fears work against suicide prevention by discouraging persons at risk from seeking life-saving help, and by further traumatizing those who have attempted suicide and those who have lost loved ones to suicide; and

**WHEREAS**, suicide is a preventable national, State, and local public health concern, and no single suicide prevention program or effort will be appropriate for all populations or communities; and

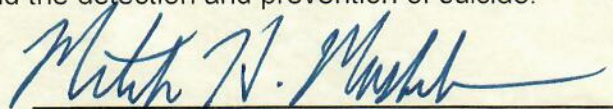
**WHEREAS**, the community can promote awareness, and efforts should be made to develop and implement strategies to increase access to quality mental health and substance use treatment, and suicide prevention services; and

**WHEREAS**, Solano County Behavioral Health in partnership with the Solano County Suicide Prevention and Overdose Coalition and the community, continues to strive to impact change by saving lives and envisioning a suicide-free community achieved through education and training, stigma reduction efforts, collaboration with partners, and the provision of resources to combat suicide; and

**WHEREAS**, Solano County Behavioral Health invites the community to attend the American Foundation for Suicide Prevention's International Survivors of Suicide Loss Day, a virtual event in which survivors of suicide loss come together to find connection, understand and hope through their shared experience on Saturday, November 22, 2025.

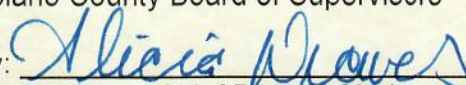
