



## Fourth Amendment to Master Services and Purchasing Agreement

This Fourth Amendment ("Amendment") is between Axon Enterprise, Inc., a Delaware corporation ("Axon"), and the County of Solano ("Agency"). This Amendment is effective as of June 30, 2024 ("Effective Date"). Axon and Agency are each a "Party" and collectively "Parties".

Axon and Agency are parties to a Master Services and Purchasing Agreement with an effective date of 24 March 2021 ("Agreement"). On December 6, 2021, the parties approved the First Amendment to the Agreement to add Axon Fleet, Interview Room cameras and associated services to the Agreement; on June 30, 2022, the parties approved the Second Amendment to the Agreement to incorporate certain changes to reflect Agency's desire to add additional equipment and associated services and set up additional interview rooms; and on November 20, 2023, the parties approved the Third Amendment to the Agreement to add the products and services purchased under the Rio Vista Police Department Agreement.


The Parties now wish to incorporate certain changes into the Agreement to add additional equipment and services, reduce the number of interview rooms by one, and to reflect changes in payment tables:

The Parties therefore agree as follows:

1. Add and incorporate Attachment A – Q-585764-45455.965AL amending Q-328962 to downsell the number of interview rooms from four to three.
2. Add and incorporate Attachment B – Q-549600-45485.742KP to add 12 additional in-car camera systems (five 2-camera systems and seven 5-camera systems) and Axon Air.
3. Add and incorporate Attachment C – Q-570069-45462.970KP to add 24 additional body worn cameras and 21 additional TASER devices.
4. Add and incorporate Attachment D – to amend the following quotes:  
Q-284893 / Q-289909 / Q-370697 / Q-383167 / Q-523835
5. All other terms and conditions of the Agreement, as previously amended, shall remain unchanged and in full force and effect.
