## 1. PROBLEM STATEMENT

### **Describe the city, county, or jurisdiction this grant will impact.**

The Solano County District Attorney Bureau of Forensic Services (BFS) is a local government laboratory that provides forensic services and assistance to the law enforcement agencies of Solano County. Solano County consists of seven cities (Benicia, Dixon, Fairfield, Rio Vista, Suisun City, Vacaville, and Vallejo) and unincorporated areas that span over 913 total square miles with a population of approximately 450,000. The rate of population growth has nearly doubled between 2010 and 2020 compared to 2000 to 2010. Solano County relies on property taxes and State and federal funding to provide services to a high density area with 489 persons per square mile.

### **Describe the problem(s) to be addressed, supported by current and relevant crash data. (most recent calendar year data/stats).**

Solano County had 1,460 DUI arrests in 2022 according to the most current statistics by the California Office of Traffic Safety (OTS). The alcohol unit in BFS maintains ten evidential breath testing instruments which are placed in law enforcement agencies throughout the county including Solano County Office of the Sheriff and California Highway Patrol (CHP) Solano division. BFS also provides blood testing in alcohol and toxicology for DUI/DUID cases. In all disciplines, BFS has seen an increase in request for testing in DUI/DUID cases over the last two years. The number of breath tests administered in 2023 were 910 compared to 1107 in 2024. The number of requests for blood alcohol analysis in 2023 was 843 compared to 966 in 2024. The number of requests for toxicology screening in 2023 was 261 compared to 334 in 2024 and the number of requests for toxicology confirmation increased from 275 in 2023 to 351 in 2024.

### **Define the target population the grant intends to serve and how they are affected by the problem(s).**

BFS is a small forensic laboratory with limited resources that will improve alcohol and drug testing capabilities to better serve law enforcement agencies of Solano County. BFS laboratory began forensic testing in 2012 and is currently accredited to ISO/IEC 17075 standards by the ANSI-ASQ National Accreditation Board (ANAB) in the disciplines of seized drug analysis and human performance toxicology testing. In the last five years obtained a headspace gas chromatograph with flame ionization detector and mass spectrometer (GC-FID/MS), a quadrupole time of flight mass spectrometer (QTOF), and a liquid chromatograph with tandem mass spectrometer (LC-MS/MS). The laboratory is currently in the validation phase for the QTOF and LC-MS/MS therefore due to limited testing capabilities with current instrumentation, testing of major drug classes such as benzodiazepines and fentanyl and nitazenes continue to be out-sourced to another laboratory.

BFS will purchase a column switching kit and consumable testing supplies that will enhance and support the testing capabilities of the GC-FID/MS, QTOF, and LC-MS/MS. In addition, the laboratory is aiming to add breath calibration testing to its accreditation scope in order to meet recommended standards set forth by the Academy Standards board.

**OTHER DIRECT COSTS**

Column Switching Kit -

Kit to maximize efficiency for QTOF and LC-MS/MS. The column switching kit will allow the laboratory to utilize two different liquid chromatograph column types on the same instrument within an analytical sequence. Most drugs can be analyzed utilizing a single column type, such as phenyl-hexyl, while cannabinoids are best analyzed on a different column type such as biphenyl. Having a switching kit will allow the laboratory to flip between the two columns without physically changing the connection, allowing for overnight analysis of both drug types and also reduces the chances for leaks or other maintenance issues.

Consumable Testing Supplies - Costs include columns, vials, caps, tubes, tips, column guards, columns, chemicals, reagents, drug/alcohol/reference standards, and mouthpieces. Other items may be purchased with approval from OTS.

Additional items for purchase include a dry gas enclosure to allow for larger gas tank capability for breath instrument.
