

**FIRST AMENDMENT TO STANDARD CONTRACT
BETWEEN COUNTY OF SOLANO and FOOD IS FREE BAY AREA**

This first amendment ("First Amendment") is entered into as of the 30th day of November 2025, between the COUNTY OF SOLANO, a political subdivision of the State of California ("County") and FOOD IS FREE BAY AREA, ("Contractor").

1. Recitals

- A. The parties entered into a contract dated June 2, 2025 (the "Contract"), in which Contractor agreed to provide cash/material aid for seniors in Solano County.
- B. The County now needs to adjust the budget and scope of work of the Contract.
- C. This First Amendment represents an increase of \$71,419 to the Contract.
- D. The parties agree to amend the Contract as set forth below.

2. Agreement.

A. Amount of Contract

Section 3 is amended as follows: "The maximum amount of this Contract is \$111,419."

B. Scope of Work

Exhibit A, Section 5 is deleted and replaced with the following:

5. Units of Service Requirements for Contracted Services:

5.1 Service: 24,000 Units providing up to 40,500 meals

5.2 Unduplicated Seniors: 800

5.3 Units of service will be reviewed monthly by AAA staff. If at the end of the first quarter, the units of service are not within 10% of the planned number, a corrective action plan will be requested of the subcontractor. If at the end of the second quarter, the units of service are still not within 10% of the planned year-to-date number, the County retains the right to reallocate the funds for the contracted service.

C. Budget.

Exhibits B-1 and B-1.1 are deleted in their entirety and replaced with the attached Budget incorporated into this First Amendment as Exhibits B-2 and B-2.1.

3. Effectiveness of Contract.

Except as set forth in this First Amendment, all other terms and conditions specified in the Contract remain in full force and effect.
