## RESOLUTION OF THE BOARD OF SUPERVISORS RECOGNIZING THE MONTH OF MARCH 2026 AS SOCIAL WORK MONTH IN SOLANO COUNTY

**WHEREAS**, March is designated nationwide as Social Work Month and remains a significant opportunity to acknowledge Solano County's Social Workers for their invaluable contribution in helping individuals, families, children, and the elderly in need of care and protection; and

**WHEREAS**, Social Workers follow a Code of Ethics that calls on them to stand for equity in every community, uphold human dignity, and fight injustice;

**WHEREAS**, the Social Workers in Child Welfare Services serve clients in Emergency Response, Family Maintenance, Family Reunification, Permanency Planning, Adoptions, and Supportive Transition programs, working to support child safety, well-being, and permanence; and

**WHEREAS**, the Social Workers in Older and Disabled Adult Services assist elderly and disabled clients in the In-Home Supportive Services and Adult Protective Services programs, support caregiver needs through Public Authority, protect gravely disabled persons in the Public Guardian, and provide services through the Napa/Solano Area Agency on Aging to promote safety and well-being in the community; and

**WHEREAS**, the Social Workers in Employment and Eligibility Services work with adults to build and stabilize strong and financially independent families that nurture and support their children; and

**WHEREAS**, the Social Workers in Public Health in the Maternal Child and Adolescent Health Services program work to encourage healthy bonds between mothers and children, help women obtain early and continuous prenatal care, link mothers with health insurance and pediatric appointments for their infants, and assist clients in achieving higher education through completion of their high school education/GED and/or college; and

**WHEREAS**, the Social Workers in Probation assist youth in out-of-home care, where staff work with the providers to ensure that transitional independent living plan goals are met, and resources are being offered and utilized; and

**WHEREAS**, the Social Workers in the Public Defender's Office assist indigent clients in accessing programs and obtaining services and housing to help reduce recidivism; and

**WHEREAS**, Social workers provide a 24-hour safety net for the protection of children, people with disabilities, and the elderly, and provide services designed to improve and stabilize the lives of their clients; and

**WHEREAS**, this year's Social Work Theme, "Social Work: Uplift. Defend. Transform." celebrates the powerful, behind-the-scenes role social workers play every day, connecting people, systems, and solutions.

**NOW, THEREFORE BE IT RESOLVED**, that the Solano County Board of Supervisors hereby recognizes the month of March 2026 as Social Work Month in Solano County to commend the efforts of these dedicated County employees in the performance of their duties and assignments.
