**RESOLUTION RECOMMENDING ADOPTION OF THE MITIGATED NEGATIVE  
DECLARATION FOR THE ROCKVILLE TRAILS PRESERVE PROJECT, AND  
APPROVAL OF GENERAL PLAN AMENDMENT G-15-01, REZONING Z-15-01, AND  
POLICY PLAN OVERLAY PP-15-01, TO THE SOLANO COUNTY BOARD OF  
SUPERVISORS**

**WHEREAS**, the Solano County Planning Commission, after proper notice, conducted a public hearing on June 1, 2017, related to the Rockville Trails Preserve Project, including the draft Mitigated Negative Declaration prepared for the project, proposed General Plan Amendment G-15-01, Rezoning Z-15-01, and Policy Plan Overlay PP-15-01; and

**WHEREAS**, after considering the draft Mitigated Negative Declaration, any comments received during the public review process on that document, and all public testimony offered at the hearing, the County Planning Commission has determined that there is no substantial evidence that the Rockville Trails Preserve project will have a significant effect on the environment, and that the draft Mitigated Negative Declaration reflects the County of Solano's independent judgment and analysis; and

**WHEREAS**, after public testimony and due deliberation, the County Planning Commission has determined that the proposed amendment to the Solano County General Plan is appropriate and desirable; and

**WHEREAS**, after public testimony and due deliberation, the County Planning Commission has determined that the proposed rezoning is appropriate and desirable, and will be consistent with the General Plan, as amended; and

**WHEREAS**, after public testimony and due deliberation, the County Planning Commission has determined that the proposed policy plan overlay is appropriate and desirable, and will be consistent with the General Plan and underlying zoning, as amended.

**RESOLVED**, that the Solano County Planning Commission does hereby recommend adoption of the draft Mitigated Negative Declaration, approval of the proposed amendment to the Solano County General Plan, approval of the proposed rezoning, and approval of the proposed policy plan overlay.
