**RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS
APPROVING TRAFFIC ORDER 438 ESTABLISHING A 7-TON WEIGHT LIMIT FOR
COMMERCIAL TRUCKS ON VARIOUS ROADS**

WHEREAS, Chapter 17 of the Solano County Code sets forth the requirements for the establishment of traffic orders; and

WHEREAS, engineering and traffic surveys have been conducted on Byrnes Road, Halley Road, Hawkins Road, Lake Herman Road, North Meridian Road, Pitt School Road, Sievers Road, Stevenson Bridge Road, Sweeney Road, Weber Road, Maple Road, Poplar Road, Walnut Road, and Willow Road; and

WHEREAS, based on said surveys and conforming to accepted principles and practices of traffic engineering, the Director of Resource Management has made Traffic Order 438, establishing a 7-ton gross vehicle weight limit for through-going commercial trucks on Byrnes Road, Halley Road, Hawkins Road, Lake Herman Road, North Meridian Road, Pitt School Road, Sievers Road, Stevenson Bridge Road, Sweeney Road, Weber Road, Maple Road, Poplar Road, Walnut Road, and Willow Road with agricultural vehicles exempted; and

WHEREAS, as a right-to-farm County, this traffic order is not intended to apply to agricultural vehicles, defined as the following: a vehicle used exclusively for agricultural operations or incidental to or in conjunction with agricultural operations, including manure spreaders, feed mixers, bale processors, water trucks, vehicles delivering fertilizer or pesticides to a farm or to transport unprocessed agricultural products to the first point of processing; and

WHEREAS, said traffic order does not become effective until adopted by resolution of the Board of Supervisors.

RESOLVED, Traffic Order 438 is adopted pursuant to the provisions of Chapter 17 of the Solano Code establishing a 7-ton weight limit for through-going commercial trucks with the exception of agricultural vehicles on the following County roads:

- 1) Boyce Road - Wolfskill Road to Putah Creek Road;
- 2) Byrnes Road - Hawkins Road to Weber Road;
- 3) Gaddini Road – Wolfskill Road to Putah Creek Road;
- 4) Halley Road - Sweeney Road to Wolfskill Road;
- 5) Hawkins Road - 0.50 miles east of Leisure Town Road to State Route 113;
- 6) Lake Herman Road - 0.65 miles east of Columbus Parkway to the city limit line for the City of Benicia;
- 7) Maple Road – 0.16 miles east of Leisure Town Road to 0.5 miles east of Willow Road;
- 8) North Meridian Road - Dixon Avenue West to Sweeney Road;

- 9) Pitt School Road - Hawkins Road to Porter Road;
- 10) Poplar Road – 0.16 miles east of Leisure Town Road to 0.5 miles east of Willow Road;
- 11) Putah Creek Road – Gaddini Road to Stevenson Bridge Road;
- 12) Sievers Road - Halley Road to Pedrick Road;
- 13) Stevenson Bridge Road - Putah Creek Road to Sievers Road;
- 14) Sweeney Road - Tubbs Road to North Meridian Road;
- 15) Weber Road – 0.1 miles east of Byrnes Road to Pitt School Road;
- 16) Walnut Road - Orange Drive to 0.4 miles east of Willow Road;
- 17) Willow Road - Maple Road to 0.3 miles north of Walnut Road; and
- 18) Wolfskill Road – Winters Road to Halley Road.

RESOLVED, the Board of Supervisors authorizes the Director of Resource Management to place appropriate signs at the affected locations.
