

**SECOND AMENDMENT TO STANDARD CONTRACT
BETWEEN COUNTY OF SOLANO AND MISSION SOLANO**

This Second Amendment ("Second Amendment") is made on April 2, 2013, between the COUNTY OF SOLANO, a political subdivision of the State of California ("County") and Mission Solano ("Contractor").

1. Recitals

- A. The parties entered into a contract dated July 1, 2012 (the "Contract"), in which Contractor agreed to provide comprehensive re-entry services for female inmates returning to the community through the Second Chance Act Grant.
- B. The County amended the Contract ("First Amendment") dated December 27, 2012 to increase the Contract amount and to extend the term of the Contract.
- C. The County now needs to modify the Budget and extend the term of the Contract.
- D. This Second Amendment represents an increase of \$49,872 of the Contract.
- E. The parties agree to amend the Contract as set forth below.

2. Agreement

A. Term of Contract

Section 2 is deleted in its entirety and replaced with: "The term of this Contract is July 1, 2012 to October 31, 2013."

B. Amount of Contract

Section 3 is deleted in its entirety and replaced with: "The maximum amount of this Contract is \$254,426."

C. Budget

Exhibit B-3 is deleted in its entirety and replaced with the Budget attached to and incorporated by this reference as Exhibit B-4.


3. Effectiveness of Contract

Except as set forth in this Second Amendment, all other terms and conditions specified in the Contract remain in full force and effect.

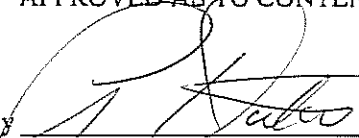
