

**SECOND AMENDMENT TO STANDARD CONTRACT
BETWEEN COUNTY OF SOLANO and CATALIS COURTS & LAND RECORDS**

This SECOND Amendment (“Second Amendment”) is made on July 1, 2025, between the COUNTY OF SOLANO, a political subdivision of the State of California (“County”) and Catalis Courts & Land Records, LLC (“Contractor”).

1. Recitals

- A. The parties entered into a contract dated July 1, 2023 (the “Contract”), in which Contractor agreed to provide hosting, data storage, support, and maintenance of Ce Assessments software.
- B. On July 1, 2024, the parties amended the Contract (“First Amendment”) to extend the term and increase compensation.
- C. The parties now wish to amend the Contract to extend the term and increase total compensation.
- D. This Second Amendment represents a twelve (12) month extension of the contract to allow for continued services through June 30, 2026 and a \$66,402.74 increase in total compensation.
- E. The parties agree to amend the Contract as set forth below.

2. Agreement

A. Term of Contract.

B. Amount of Contract.

The maximum amount of this Contract is: \$188,145.03.
