RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS HONORING THURMAN ROBBSON, IT ANALYST IV, UPON HIS RETIREMENT FROM THE DEPARTMENT OF INFORMATION TECHNOLOGY, WITH OVER 21 YEARS OF DEDICATED PUBLIC SERVICE TO SOLANO COUNTY

WHEREAS, Thurman Robbson began his public-sector career over 21 years ago; and

WHEREAS, Thurman Robbson began his distinguished career as an Information Technology Specialist II for the Health and Social Services Department on January 24, 2003, where he joined the application team to support the Child Welfare Services Case Management System (CWS/CMS); and

WHEREAS, in 2005, Mr. Robbson joined the implementation team to replace the legacy Welfare Case Data System (CDS) with the CalWIN system, which supports the administration of welfare programs in California and case management functions for employment services. In this capacity, Mr. Robbson provided ongoing system, security and decision support services; and

WHEREAS, Mr. Robbson was promoted to Programmer in the Department of Information Technology in June 2007 where he was the lead security and report developer for the CalWIN support team. He developed many management reports to support the employment and eligibility business operations and several specifically for the timely monitoring of Work Participation Rates (WPR) for the department; and

WHEREAS, Mr. Robbson was promoted to Systems Analyst (Senior) in the Department of Information Technology in October 2016 where he joined the Family Health Services NextGen support team, providing application support, reporting services, and interoperability support; and

WHEREAS, Mr. Robbson was reclassified as Information Technology Analyst IV in the Department of Information Technology in December 2017. In this capacity, he worked with the Public Health Lab to implement and support their new Laboratory Information Management System (LIMS), Orchard Harvest, Copia, and Laboratory Billing System. He also implemented the interoperability between NextGen, Harvest, and the Population and Public Health Hub; and

WHEREAS, Mr. Robbson retired on November 1, 2024, after 21 years of service and during his tenure Mr. Robbson consistently demonstrated a high level of service and dedication where his impact will continue to be felt for many years.

NOW, THEREFORE BE IT RESOLVED, that the Solano County Board of Supervisors hereby recognizes Thurman Robbson for over 21 years of dedicated and loyal service to Solano County and wishes him well in his retirement and future endeavors. He will be missed.


