RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS ADOPTING A LIST OF PROJECTS FOR FISCAL YEAR 2024/25 **FUNDED BY THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017**

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions, with reporting requirements each fiscal year, to ensure the residents of Solano County are updated on the status and funding of projects in the community; and

WHEREAS. Solano County must adopt by resolution a list of projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, Solano County must prioritize maintenance and safety in selecting the list of projects to receive RMRA funding; and

WHEREAS, Solano County used a Pavement Management System to develop the SB 1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meets the community's priorities for transportation investment; and

WHEREAS, Solano County will receive an estimated \$9,184,000 in RMRA funding in FY2024/25; and

WHEREAS, receiving RMRA funding will enable Solano County to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and

WHEREAS, the SB 1 project list in Solano County's Public Works Capital Improvement Plan (Exhibit A) provides an overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety and complete streets, while considering cutting-edge technology, materials and practices.

NOW, THEREFORE BE IT RESOLVED, the Solano County Board of Supervisors affirms that the proposed SB 1 projects in the Capital Improvement Plan (Exhibit A) will be funded in-part or solely by Road Maintenance and Rehabilitation Account revenues for FY2024/25.
