RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS RECOGNIZING 2013 AS YEAR OF THE CHILD AND APRIL 2013 AS CHILDREN'S MONTH

WHEREAS, California is home to 9.5 million children, from infants and toddlers to school-agers and teens; and

WHEREAS, these children are the future of our state, with our investment in our children of today representing our investment in the working people, community leaders, parents and problem-solvers of tomorrow; and

WHEREAS, it is therefore, imperative that the elected officials, community leaders and policymakers of today prioritize California's children and consider the impact of each decision they make on all of our children today, tomorrow, and in the future; and

WHEREAS, the President of the California State Association of Counties has challenged his colleagues to ask "How are the children?" and to always consider what is best for the children and to continue focusing on the children until we can say with confidence, "All the children are well;" and

WHEREAS, Solano community partners including the Children's Network, Travis Air Force Base, Child Care Planning Council, Child Abuse Prevention Council, Solano Family and Children's Services, First 5 Solano, Health and Social Services Department, Office of Family Violence Prevention, Solano County Library, and others have joined together to expand awareness of young children's issues by promoting "April Children's Month" through public education and community events.

NOW, THEREFORE, BE IT RESOLVED, that the Solano County Board of Supervisors joins the California State Association of Counties with elected officials across the state, First 5 commissions, California State Preschools and Head Start programs and their many community partners in recognizing the critical importance of placing children at the core of our plans, at the heart of our purpose and at the top of every agenda in recognizing 2013 as Year of the Child.

BE IT FURTHER RESOLVED, that the Solano County Board of Supervisors hereby recognizes April 2013 as Children's Month and encourages all residents to work to support the healthy growth and development of children and youth in Solano County.
