**NOTICE OF PUBLIC HEARING
(Board of Supervisors)**

NOTICE IS HEREBY GIVEN that the Solano County Board of Supervisors will hold a PUBLIC HEARING to consider Minor Subdivision application MS-25-01 By Darlene Foon Lum, Trustee of the Darlene F. Lum Trust date April 3, 2024, and Charles F. Lum Family Limited Partnership to subdivide a 41.17-acre property under Land Conservation Contract No. 1199 into two parcels of 21.15 and 20.02 acres, located along Rockville Road, one-mile west of the City of Fairfield, within the Suisun Valley Agriculture "A-SV-20" zoning district, APN's 0027-030-150 and 0027-251-280; the project is exempt from the California Environmental Quality Act (CEQA) pursuant to §15061(b)(3) of the CEQA Guidelines because it has been determined that implementation of the proposed project would not have the potential to cause a significant effect on the environment.
