## RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS RECOGNIZING PATRICIA ZUÑIGA-GERHARDT, ADMINISTRATIVE SECRETARY, UPON HER RETIREMENT FROM THE DEPARTMENT OF HEALTH AND SOCIAL SERVICES, FAMILY HEALTH SERVICES DIVISION, WITH 25 YEARS OF DEDICATED PUBLIC SERVICE TO SOLANO COUNTY

**WHEREAS**, Patricia Zuñiga-Gerhardt began her career with Solano County on December 7, 1998, as a Library Aid for the John F. Kennedy Library located in Vallejo; and

**WHEREAS**, in 1999, Mrs. Zuñiga-Gerhardt was promoted to Library Assistant, and in 2006, to Library Assistant (Senior), where she provided guidance in support of library operations, assisted patrons in choosing and locating reading materials, answered reference questions, participated in program planning, and gathered statistical information; and

**WHEREAS**, in 2007, Ms. Zuñiga-Gerhardt accepted a position with the Department of Health and Social Services, Public Health Division, as an Office Assistant II where she worked in the Public Health Nursing and Tuberculosis Program, and in 2013, she transferred to the Child Welfare Services Division; and

**WHEREAS**, in 2017, Mrs. Zuñiga-Gerhardt transferred to Family Health Services; and in 2018, she was reclassified from Office Assistant II to Administrative Secretary; and

**WHEREAS**, Ms. Zuñiga-Gerhardt provided administrative support to the daily operations of the Chief Medical Officer and served as the clerk to the Community Healthcare Board; and


