

**THIRD AMENDMENT TO STANDARD CONTRACT
BETWEEN COUNTY OF SOLANO AND YOUTH AND FAMILY SERVICES**

This Third Amendment ("Third Amendment") is made on April 2, 2013, between the COUNTY OF SOLANO, a political subdivision of the State of California ("County") and Youth and Family Service ("Contractor").

1. Recitals

- A. The parties entered into a contract dated January 1, 2012 (the "Contract"), in which Contractor agreed to provide Jail/Prison re-entry case management services.
- B. The County amended the Contract ("First Amendment") dated September 4, 2012 to extend the term of the Contract.
- C. The County amended the Contract ("Second Amendment") dated November 20, 2012 to increase the amount of the Contract.
- D. The County now needs to modify the Budget and extend the term of the Contract.
- E. This Third Amendment represents an increase of \$61,158 of the Contract.
- F. The parties agree to amend the Contract as set forth below.

2. Agreement

A. Term of Contract

Section 2 is deleted in its entirety and replaced with: "The term of this Contract is January 1, 2012 to October 31, 2013."

B. Amount of Contract

Section 3 is deleted in its entirety and replaced with: "The maximum amount of this Contract is \$286,763."

C. Budget

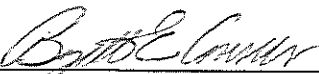

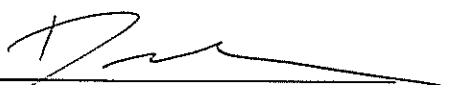

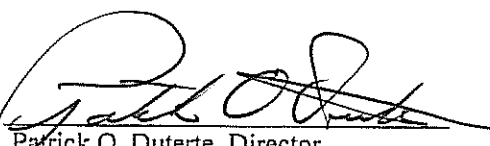
