RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS RECOGNIZING CHRISTINA J. STIMMANN, BEHAVIORAL HEALTH ADMINISTRATOR, UPON HER RETIREMENT FROM THE HEALTH AND SOCIAL SERVICES DEPARTMENT, BEHAVIORAL HEALTH DIVISION, WITH MORE THAN 22 YEARS OF DEDICATED SERVICE TO SOLANO COUNTY

WHEREAS, in 2002, Ms. Stimmann interned with Solano County Health and Social Services in the Child Welfare Services Division, as part of the Title IV-E Master of Social Work program; and

WHEREAS, in 2003, Ms. Stimmann was hired by Health and Social Services as a Child Welfare Services Social Worker III in the Emergency Response unit and later transferred to the District Attorney's Office of Family Violence Prevention, where she acted as the Senior Investigative Social Worker. In 2008, Ms. Stimmann returned to Child Welfare Services and was promoted to Social Services Supervisor where she revamped the appeals process for relative placement assessments and the parent-child visitation practices in the Out-of-Home Services unit; and

WHEREAS, in 2011, Ms. Stimmann was promoted to Assistant Coordinator of the Office of Family Violence Prevention in the District Attorney's Office, where she played a key role in launching the Solano Family Justice Center – a collaborative initiative co-locating services for victims of domestic violence, sexual assault, and elder abuse; and

WHEREAS, Ms. Stimmann successfully passed the Board of Behavioral Sciences clinical exams to become a Licensed Clinical Social Worker and transitioned into direct clinical work in 2012 as a licensed Mental Health Clinician with the Health and Social Services, Public Health division. She provided behavioral health treatment to adults with serious mental illness at the Fairfield Integrated Care Clinic and delivered comprehensive screening, assessment, and therapy to patients of all ages at the Vallejo Family Health Services Clinic; and

WHEREAS, in 2015, Ms. Stimmann was promoted to Mental Health Clinical Supervisor in the Behavioral Health division, overseeing clinicians providing recovery-focused treatment for adults. During that time, she implemented Eye Movement Desensitization and Reprocessing as an evidence-based trauma treatment. In 2019, Ms. Stimmann continued her career progression, promoting to Mental Health Services Manager, and in 2023, she was reclassified to Mental Health Services Manager, Senior. Her leadership strengthened service coordination across high-risk programs for both adults and children, ensuring adherence to ethical and legal standards in crisis care; and

WHEREAS, Ms. Stimmann advanced to Behavioral Health Administrator in 2023. In this role, she significantly influenced the strategic direction of the adult services system of care by applying her comprehensive subject matter knowledge and visionary leadership to improve program development, enhance regulatory compliance, foster cross-sector collaborations, and service delivery integration.

NOW, THEREFORE BE IT RESOLVED, that the Solano County Board of Supervisors does hereby recognize Christina J. Stimmann, LCSW, MHSA, for her more than 22 years of dedicated and excellent public service to the residents of Solano County and wishes her well in her retirement.
