#### Wildfire Prevention vs Wildfire Resilience

### Wildfire Prevention: Stop fires before they start

- Fuel management (e.g. defensible space)
- Fire prevention infrastructure (e.g. firebreaks, controlled burns)
- Public education and outreach to raise awareness of fire safety
- Preventative fire bans or restrictions during high-risk periods

## Wildfire Resilience: Stay strong when it happens and come back stronger

- Building code modifications
   (e.g. fire-resistant building
   materials, hazard severity zones)
- Landscape and home hardening (e.g. fire-resistant roof, improved water infrastructure)
- Community lead engagement (e.g. Firewise, Fire Safe Councils)
- Recovery planning to help communities rebuild after a fire; while ensuring they are better prepared for future events



#### Wildfire Prevention & Resilience Through Collaboration

- Our goal: Reduce wildfire risk and create a culture of readiness across the county.
- > How to get there: Work together using a whole community approach.

  - Local Fire Safe Councils

  - Solano Fire Safe Council

#### **Funding Sources Overview**

➤ In an effort to build and sustain core initiatives, attempts have been made to maximize funding opportunities that support the purpose and goals of the program.

#### > PSPS/CRC Grant Program

- FY19 Public Safety Power Shutoff (PSPS)
- FY20 Community Power Resiliency (CRC) (formally PSPS)

#### > CAL FIRE Fire Prevention Grant Program

- FY21 CAL FIRE Fire Prevention Grant Program
- FY22 CAL FIRE Fire Prevention Grant Program (not awarded)
- FY22 CAL FIRE Fire Prevention Grant Program (Cordelia FPD awarded for continued shaded fuel break work)
- FY23 CAL FIRE Fire Prevention Grant Program (Solano & Yolo RCDs awarded for fuels reduction projects)

- > 2019 California Earmark (secured by Senator Dodd)
- > General funds are used as minimally as possible, typically for items we are unable to fund with grants.



Allocated funding: \$463,843

Status: Completed

#### 2019 Public Safety Power Shutoff (PSPS) Funding

- > Purchase of portable generators (\$62,794)
- Installation of generator connections at Lake Solano (\$3,225)
- ➤ Purchase of uninterruptable power supply (UPS) (\$119,764) for the County's Criminal Justice Data Center
- Purchase of multi-band portable radios for the Solano County Sheriff's Office (\$78,060)
- ➤ Pass-thru funds to the Food Bank of Contra Costa and Solano County to fund an installed generator (\$200,000)



Allocated funding: \$231,921

#### **2020 Community Power Resiliency Program Funding**

➤ Funds were used as a credit toward the purchase of mobile and portable radios for the fire protection districts in support of the interoperability project. The balance of this radio project was funded through the 2019 California Earmark.



Allocated funding: \$1,095,120

Status: Completed

#### 2021 CAL FIRE Fire Prevention Grant Program

- ➤ Community Wildfire Protection Plan (CWPP) via contractor (\$214,894)
- > Zonehaven Evacuation Software Procurement (\$314,756)
- ➤ Contract with Solano RCD (\$222,412)
- ➤ Developed a *Solano Fire Preparedness Guide* mailer (\$5,625)
- ➤ Local cost share of \$195,120 met with in-kind match using staff time
- ➤ Unspent funds of \$142,313 due to several projects coming in under budget. We were not approved for a grant extension.



Allocated funding: \$175,000

Status: Completed

#### **2021 County Coordinator Grant Program**

Funds were used to hire a consulting firm to support the County Administrator's Office and OES in launching the Solano Fire Safe Council and to provide technical assistance identifying mapping of priority locations for fuel break installations, as well as to assist in grant application development for conducting this work.



Allocated funding: \$200,000

Status: Completed





- ➤ Living with Wildland Fires Handbook (\$64,495):
  - Finalized from Solano RCD draft and translated into Spanish and Tagalog
- ➤ Know Your Zone Mailer Campaign (\$38,520):
  - Countywide outreach
- ➤ Fire Safe Council Pop-Ups (\$2,627):
  - Funded a pop-up and accessories to support community events
- ➤ New Program Coordinator (\$49,509):
  - OES hired an Emergency Services Coordinator II (ESC) as the Wildfire Prevention and Resilience Program coordinator.
  - Position delayed, resulting in \$44,849 of unused grant funds returned to the State.
