MANAGER, SENIOR, UPON HER RETIREMENT FROM THE DEPARTMENT OF HEALTH
AND SOCIAL SERVICES, BEHAVIORAL HEALTH DIVISION, WITH
28 YEARS OF DEDICATED PUBLIC SERVICE TO SOLANO COUNTY

**WHEREAS,** Dr. Rozzana Verder-Aliga, EdD, LMFT, is an alumnus of the American School of Professional Psychology, Argosy University, San Francisco Bay Area, with a Doctor of Education in Counseling Psychology; and she holds a Master of Arts in Counseling from the University of San Francisco, and a bachelor's degree in music education from the University of the Philippines; and

**WHEREAS,** Dr. Verder-Aliga began her career with Solano County Health and Social Services, Behavioral Health Division, on December 4, 1995 as a Mental Health Clinician where she provided screening, assessments, case management, individual and group therapy to adult consumers, and performed outreach activities to Filipino speaking providers, consumers and families; and

**WHEREAS**, in 1997 Dr. Verder-Aliga was promoted to Mental Health Program Supervisor responsible for administrative and clinical oversight of clinicians who were providing intensive psychotherapy to youth faced with behavioral health challenges, generational trauma and poverty, and, in 2000, she promoted to Mental Health Services Manager; and

WHEREAS, Dr. Verder-Aliga promoted again in 2009 to Mental Health Services Manager, Senior, where she served both children and adults, responsible for the Vallejo Outpatient children's clinic, the Cornerstone Day Treatment program, the Successful Mental Health and Addiction Recovery Treatment (SMART) program and the three largest adult outpatient Integrated Care Clinics in Solano; and

**WHEREAS**, during her tenure, Dr. Verder-Aliga has been very active in her community in a variety of roles, demonstrating her love for public service and civic duty; and

**WHEREAS,** Dr. Verder-Aliga's strength and dedication inspired staff to perform above and beyond expected limits, and her immigrant background supported her efforts to facilitate outreach services to all underserved communities with a particular focus on the Filipino community throughout her career. She has been an exemplary public servant for the last 28 years and has carried out her duties with integrity and grace, her colleagues are appreciative of all the support she has provided over the years, Solano County has been enriched by her career tenure and she will be truly missed.
