## NOTICE OF PUBLIC HEARING

**NOTICE IS GIVEN** that the Solano County Board of Supervisors will hold a public hearing to take public input and provide direction to staff on:

Whether the County should consider developing an ordinance to amend Chapter 28 (Zoning Regulations) to allow for cultivation of marijuana for personal use indoors in all zones that allow a residence as a primary use; to consider allowing commercial cultivation indoors up to 10,000 sq. ft.; to consider non-volatile-solvent marijuana manufacturing, and marijuana testing laboratories in the manufacturing and industrial zones; and prohibiting all other commercial marijuana activities in the unincorporated county.

The purpose of the meeting is to receive input from the public on commercial marijuana activity and personal cultivation. The Board shall also discuss whether staff should be directed to draft an amendment to bring the County's zoning regulations for personal cultivation in conformance with the Medical Cannabis Regulation and Safety Act (MCRSA), as well as the Adult Use of Marijuana Act (AUMA) in the event it is voted into law on November 8, 2016. The Board will also consider whether to direct staff to explore a zoning amendment to allow a small number of commerical marijuana activities in the industrial and manufacturing zones, ban in all zones indoor cultivation over 10,000 sq. ft., as well as outdoor cultivation, marijuana transport providers, marijuana retailers, marijuana distibution facilities, solvent-based marijuana manufacturing, and marijuana microbusinesses.

Any person wishing to comment on the project and/or review the information contained within the project file may do so at the Solano County Department of Resource Management, Planning Division, County Administration Center, 675 Texas Street, Suite 5500, Fairfield.

Any person challenging the proposed consideration in court may be limited to raising only those issues raised at the public hearing described in this notice, or in written correspondence delivered to the Board of Supervisors at, or prior to, the public hearing.

The hearing will be held in the Board of Supervisors Chambers, County Administration Center, 1<sup>st</sup> Floor, 675 Texas Street, Fairfield on Tuesday, November 1, 2016. Resource Management items are scheduled to be heard by the Board at 2:00 p.m. Interested persons may appear and be heard.
