Agricultural Commissioner/Sealer of Weights and Measures Ed King introduced the item and provided an overview of the 2023 Crop and Livestock Report.

Supervisor Vasquez commented on the need for the County to create infrastructure and protection of Solano County's agricultural assets.

Supervisor Vasquez requested the Board provide direction to the CAO for the use of staff time to work on the creation of agricultural infrastructure.

All Board members commented in support of Supervisor Vasquez's request.

In response to a question by Supervisor Hannigan regarding possible deterrents to the geese migration and its effects on crops, Mr. King stated growers have tried just about everything, but their efforts have had a negligible effect, noting farmers are trying to do their best.

Supervisor Hannigan commented on the need to protect agricultural resources from urban sprawl.

Supervisor Brown thanked Supervisor Vasquez for bringing up the Board's strategic plan as it relates to agriculture and feeding Solano County's citizens.

Chair Mashburn thanked Mr. King and his staff for their hard work and stated his appreciation for the continued hard work of the agricultural community. Chair Mashburn further stated the Board will continue to work to protect Solano County's vital agricultural production.

In response to a question by Supervisor Williams regarding the reduction in indoor nursery production, Mr. King stated it is more of a year over year fluctuation, than an actual issue, noting there is no one thing in particular to blame for the reduction.


*B) Supervisor Williams stated she was recently appointed to the NACo Healthy Counties Advisory Board.*

*E) Chair Mashburn reminded everyone that tonight is National Night Out.*


