**RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS AUTHORIZING  
THE AGRICULTURAL COMMISSIONER/SEALER OF WEIGHTS AND MEASURES TO EXECUTE  
COOPERATIVE AGREEMENTS AND AN AMENDMENT WITH  
THE CALIFORNIA DEPARTMENT OF FOOD AND AGRICULTURE FOR  
FISCAL YEARS 2025/26, 2026/27 AND 2027/28**

**Whereas**, the Solano County Board of Supervisors recognizes that the Agriculture Department receives revenue agreements from the California Department of Food and Agriculture throughout the fiscal year; and

**Whereas**, it is a general requirement that certain contracts or agreements entered into by the Solano County Agricultural Commissioner's Office be signed by the Chair or an authorized designee of the Board of Supervisors; and

**Whereas**, the State of California requires a resolution authorizing revenue contract approval and authorizing the Agricultural Commissioner/Sealer of Weights and Measures to execute revenue agreements and any resulting amendments.

**Resolved**, the Solano County Board of Supervisors authorizes the Solano County Agricultural Commissioner/Sealer of Weights and Measures to execute the seven revenue agreements and one first amendment listed below, once received, and any amendments to these revenue agreements during Fiscal Years 2025/26, 2026/27, and FY2027/28 up to a total of 15% over the approved amount, on behalf of Solano County. A copy of the executed agreements shall be filed with the Clerk of the Solano County Board of Supervisors.
