

**RESOLUTION NO. 2025-**

**RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS ELECTING TO  
IMPOSE A MOTOR VEHICLE REGISTRATION OF \$2 AND A COMMERCIAL VEHICLE  
FEE OF \$4 UNDER VEHICLE CODE SECTION 9250.19**

**WHEREAS**, Vehicle Code section 9250.19 previously authorized a county, upon the adoption of a resolution by its board of supervisors, to impose a fee of \$1 on all motor vehicles, and an additional service fee of \$2 on commercial motor vehicles of 10,001 pounds or more, which are paid at the time of registration or renewal of registration of every vehicle registered to an address within that county, except those expressly exempted from payment of registration fees; and

**WHEREAS**, on December 9, 1997, the Solano County Board of Supervisors adopted Resolution No. 97-300 that authorized the collection of the fees authorized by Vehicle Code section 9250.19; and

**WHEREAS**, effective August 25, 2014, AB 2393 revised Vehicle Code section 9250.19 to authorize every county to increase its motor vehicle fee from \$1 to \$2, and its commercial vehicle service fee from \$2 to \$4, upon adoption of a resolution by its board of supervisors, with the fees paid at the time of registration or renewal of registration of every vehicle registered to an address within that county, except those expressly exempted from payment of registration fees; and

**WHEREAS**, the additional funds allocated under Section 9250.19 shall be used to exclusively fund the fingerprint identification program; and

**WHEREAS**, the fees, effective October 1, 2025, allocated to a county under Section 9250.19 shall be distributed to the Solano County Automated Identification Fund administered by the Sheriff's Office; and

**WHEREAS**, the Remote Access Network (RAN) board concurs with the recommendation to increase the motor vehicle fee from \$1 to \$2, and the commercial vehicle service fee from \$2 to \$4.

**NOW, THEREFORE, BE IT RESOLVED**, the Solano County Board of Supervisors impose a \$2 fee on all motor vehicles and a \$4 fee on all commercial vehicle services, to be paid at the time of registration or renewal of registration of a vehicle registered to an address within Solano County, except those expressly exempted from payment of registration fees.

**BE IT FURTHER RESOLVED**, this Resolution will take effect on October 1, 2025.
