The applicant, Westervelt Ecological Services, is applying for a Use Permit to create a Mitigation Bank, known as the Cache Slough Mitigation Bank, located northeast of Rio Vista. The specific location coordinates are latitude: 38.182510, and longitude: -121.675647. The project spans a total of 370.59 acres and encompasses multiple phases including levee breaches to restore tidal inundation, earthmoving for marsh and seasonal wetland creation, channel and pond construction, and the installation of infrastructure to facilitate cattle grazing. This letter serves as a formal invitation to Yocha Dehe Wintun Nation (Tribe) to consult with the Solano County Department of Resource Management (County) under California Assembly Bill 52 (AB 52), pursuant to California Public Resources Code (PRC) Section 21080.3.1, on the proposed Cache Slough Mitigation Bank Project (Project), in Solano County (see enclosed Figures 1 and 2).

The County is the lead agency for Project review under the California Environmental Quality Act. The Project would re-establish approximately 300 acres of tidal freshwater wetland and floodplain-associated vegetation communities within the interior of the Project Area, which reflect the landcover depicted on historical aerial imagery and topographic maps of the area. To accomplish this, a series of open water features, including tidal and subtidal channels, would be excavated throughout the Project Area. These channels would be sized to accommodate water flows associated with daily tidal fluctuations to prevent scour velocities and avoid tidal muting. The onsite channels would connect directly to Cache Slough/Sacramento River via an opening under State Route 84 (e.g., free span bridge). The direct hydraulic connection to tidal waters would be engineered to best allow full ecological functions and species access to the interior of the site and to minimize erosion.

As part of the cultural resources review of the Project under CEQA, the County would like to provide the Tribe with an opportunity to communicate concerns you might have regarding historical resources or tribal cultural resources, as defined in PRC Section 21074, important to your community that could be impacted by the Project. The County requests your participation in the identification and protection of historical resources and tribal cultural resources that could be impacted by the Project, with the understanding that you or other members of your community might possess specialized knowledge of the area. We understand that the locations of these resources are sensitive and resource locations would not be disclosed in public documents and would be kept confidential as provided for under California Government Code

Westervelt Ecological Services is applying for a Use Permit to create a Mitigation Bank (Cache Slough Mitigation Bank), located North East of Rio Vista (lat: 38.182510, long: -121.675647), with a total of 370.59 acres. Please find the attached map showing the location of the project for your reference.

Below is a summary of the archaeological and architectural resources inventory conducted by Environmental Science Associates (ESA):

Project Background:

Environmental Science Associates (ESA) conducted an archaeological and architectural resources inventory for the Project (Hoffman et al. 2023) to support compliance with the National Environmental Policy Act (NEPA), Section 106 of the National Historic Preservation Act of 1966 (Section 106), and the California Environmental Quality Act (CEQA). ESA's study included the following:

A records search of the California Historical Resources Information System

Research on existing cultural resources literature

Intensive-level and reconnaissance-level field surveys of the entire Area of Potential Effects (APE), including with Native American representatives

Correspondence with the California Native American Heritage Commission

Significance evaluations for cultural resources identified in the APE

ESA's study identified five previously recorded cultural resources within the APE:

Archaeological resource P-48-000950 (submerged object, possible shipwreck)

Architectural resources:

P-48-001027 (water conveyance system)

P-48-002018 (Solano County Levee 38)

P-48-002019 (Solano County Levee 28)

Tribal cultural landscape P-34-005225 (Lower Sacramento River)

During the field surveys conducted for the Project, three of these resources (P-48-001027, P-48-002018, P-48-002019) were observed in the APE. P-48-001027, P-48-002018, and P-48-002019 were all previously determined not eligible for the National Register of Historic Places (National Register) and recommended not eligible for the California Register of Historical Resources (California Register). P-34-005225 was previously recommended National Register- and California Register-eligible, and this study recommends assuming it National Register- and California Register-eligible for the purposes of the Project. There do not appear to be any contributing elements of P-34-005225 within the APE, which is supported by the Section 106 consultation for the Little Egbert Tract Geotechnical Explorations Project that encompassed the current APE. ESA's study recommended assuming P-48-000950 National Register- and California Register-eligible for the purposes of the Project, unless additional data is obtained that would allow for evaluation of the resource's significance.
