**WHEREAS,** in June 2008, Mr. Alberto helped implement the division's first customer call center, the Benefits Action Center, where he proudly and effectively supervised the bilingual unit; and

**WHEREAS,** Mr. Alberto's program expertise, professionalism, and compassion have served countless Solano County residents and earned him the Employee of The Year recognition in 1997 as well as the admiration and respect of those who have had the privilege of working with him.
