RESOLUTION OF THE BOARD OF SUPERVISORS OF SOLANO COUNTY ADOPTING FIRE PROTECTION DISTRICT IMPACT FEES ON BEHALF OF CORDELIA FIRE PROTECTION DISTRICT, DIXON FIRE PROTECTION DISTRICT, SUISUN FIRE PROTECTION DISTRICT, AND VACAVILLE FIRE PROTECTION DISTRICT

Whereas, pursuant to Article XVI of Chapter 11 of the Solano County Code, fire protection district impact fees may be imposed on all new non-exempt construction in the County of Solano; and

Whereas, under the provisions of Government Code section 66000 et seq., the Solano County Board of Supervisors has held a public hearing to consider adopting updated fire protection district impact fees and imposing the amounts collected within the Cordelia Fire Protection District, Dixon Fire Protection District, Suisun Fire Protection District, and Vacaville Fire Protection District ("Districts"); and

Whereas, the Solano County Board of Supervisors adopts each District's respective Fire Impact Fee which is increased in accordance with Solano County code 11-640 based on the percentage in the Engineering News Record California Construction Cost Index, and which amounts shall be subject to annual review and adjustment, after a noticed public hearing, by resolution adopted by this Board.

Whereas, the annual change in the California Construction Cost Index (CCCI) from December 2023 to December 2023 is 2.3%.

Resolved, the Solano County Board of Supervisors adopts fire protection district impact fees on behalf of the Cordelia Fire Protection District, Dixon Fire Protection District, Suisun Fire Protection District, and Vacaville Fire Protection District to be collected as follows:
