**RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS APPROVING  
THE FINAL MAP FOR THE MORGAN SUBDIVISION – PHASE 2 (S-18-02)**

**Whereas**, the Solano County Board of Supervisors, on May 12, 2020 through Resolution No. 2020-87 conditionally approved the Tentative Final Map under application S-18-02. Said Tentative Final Map proposed three phases to ultimately subdivide approximately 310 acres of the Lands of Morgan into 19 individual lots ranging from 2.9 – 35.6 acres; and

**Whereas**, the Final Map for the Morgan Subdivision – Phase 1, which created 4 lots, was approved by the Solano County Board of Supervisors, on May 4, 2021 through Resolution No. 2021-90 and recorded June 23, 2021 in the Office of the Solano County Recorder in Book 96 of Maps, Pages 01 – 06; and

**Whereas**, Phase 2 consists of subdividing approximately 254 acres of the remaining lands into 10 lots ranging from 6.7 – 21.3 acres, southwest of the intersection of Gibson Canyon Road and Cantelow Road; and

**Whereas**, as a Condition of Approval of Subdivision S-18-02, the subdivider shall execute and concurrently record a Private Road Maintenance Agreement for Gibson Canyon Court, a private road within a 60-foot Private Access Easement; and

**Whereas**, as a Condition of Approval of Subdivision S-18-02, the subdivider shall dedicate a Public Utility Easement within the 60-foot Private Access Easement; and

**Whereas**, the County Surveyor has determined the Conditions of Approval as set forth through said Resolution No. 2021-90 have been satisfied, furthermore the Phase 2 Final Map is in substantial conformance with the approved Tentative Final Map and is technically correct.

**Therefore, Be it Resolved**, the Solano County Board of Supervisors, approve the Morgan Subdivision – Phase 2 Final Map and hereby accept the dedication of the Public Utility Easements.
