Recommended Action Items

1. Consider approving a Supplemental Policy Document for the three districts;
2. Consider authorizing the County Administrator to appoint an interim chief;
3. Consider delegating the County Administrator authority to approve emergency purchases up to \$250,000 and to provide concurrence on personnel decisions;
4. Consider adopting resolutions establishing a 14-day work period; and
5. Initiate an audit process for the three Districts for financial statements from FY2023/24 and FY2024/25 and the addition of 2022/23 for the Vacaville Fire Protection District.



Supplemental Policy Document

- Recommends the Districts follow equivalent contracting and purchasing policies to the County, including a contract and purchasing approval threshold for the interim chief totaling up to \$74,999
- Approves emergency purchasing authority to the County Administrator, as deemed necessary, totaling up to \$250,000
- Establishes that personnel decisions be made by the interim chief with County Administrator concurrence
- Sets policy recommendations for the following:
 - Purchasing
 - Contracting
 - Conducting Audits
 - Impact fees
 - Training
 - Applying for grants



Interim Chief

- Staff recommends the County Administrator appoint an interim chief for continuity of operations while the Districts continue efforts on the development of a reorganization application for submission to LAFCO



14 Day Work Period

The resolutions will establish a 14-day Work Period:

- One for each District (Montezuma, Suisun and Vacaville)
- Required under the Fair Labor Standards Act (FLSA)
- Will allow the districts flexibility to operate extended shift hours for alignment of coverage



Annual Audit Process

As Dependent Districts:

- The three Districts will complete annual audits
- Audits will be completed by October 31st each year
- Audits will be reported to the County Auditor Controller's Office annually



Montezuma Fire Protection District



- Vegetation management and fuel reduction projects
 - Provided guidance to California Forever on installing disk lines along roads
 - Partnered with local ranchers on tracking of fireguards and summer fowl fields (disked fields)
- Public education on defensible space
 - Partnered with California Forever to remove vacant buildings and establish defensible space around remaining structures on their property
 - Education in the Collinsville area
- Coordination with partners: CalFire, State Fish & Wildlife, local RCDs, Fire Safe Councils, Solano County OES, Solano Fire Departments/Districts
- Incident responses total 294, including 111 total fire incidents including 6 vehicle, 23 structures, 70 vegetation, 6 debris, 1 boat and 5 OES assignments
- Burn permit education and distribution
 - 36 Permits issued for agriculture burns
- School visits with fire safety presentations
- Participation in community fairs and events:
 - Wildfire Preparedness Day
 - Rio Vista Airport Day
 - Rio Vista Bass Festival during prevention week
 - Open house at Station 51 during Fire Prevention week



Suisun Fire Protection District



- Vegetation management and fuel reduction projects
 - Partnered with Calfire & Solano RCD (Nelson RX)
 - Assisted with pile burns in Green Valley with Calfire
- Public education on defensible space
 - Blue Mountain Drive Subdivision Homeowners Association
 - Tolenas Homeowner Association
 - Station 32 Public education on Defensible Space
- Coordination with partners: CalFire, State Fish & Wildlife, local RCDs, Fire Safe Councils, Solano County OES, Solano Fire Departments/Districts
- Incident responses total 285, including 75 total fire incidents
- Burn permit education and distribution
 - 77 Permits issued for agriculture burns & fuels mitigation in marsh area
- School visits with fire safety presentations: Suisun Valley and Tolenas
- Participation in community fairs and events:
 - Wildfire Preparedness Day
 - Dixon May Fair
 - National Night out (Green Valley)
- Open house events, including Station 32 public education on Wildfire and a Pancake breakfast
- Fire Extinguisher training demonstration for Suisun Valley School, Citizen's Academy, Youth Academy, Wildfire Preparedness Day and County departments



Vacaville Fire Protection District



- Emergency Responses
 - 2024 Total Responses: 751 Fires 117
 - 2025 Total Responses: 383 Fires 50
- Permits & Prevention
 - Burn Permits: 742
 - Fuels Reduction: CMF, Nelson Rd, Cherry Glen Road
- Training & Personnel Development
 - Emergency Medical Responder (EMR) – 15 In-house
 - Solano Community College Fire Academy 7 Graduates - May 2025
- Grants & Equipment
 - \$67,000 – Extrication, \$32,000 – PPE
- Technology & Communications
 - Transitioned to Soft Paging System
 - 100% Firefighters have radio communications
 - Realtime 360-degree Camera Views - Any device
- Operational Improvements
 - Implemented Response KPI's – Adjust staffing by station call volume



Update on Unified Command

District Efforts:

- Districts have been meeting weekly to discuss and identify ways to strengthen operations, efficiencies and alignment to prepare for consolidation:
 - Training
 - Tablet Command
 - Response matrix
 - PPE and other purchase standardization
 - Telephone system integration and records system alignment
 - LAFCO Application
- Year two of the pilot seasonal wildfire program
 - 2:0 staffing of one engine for each district, eight hours per day and seven days per week, beginning July 1, 2025
 - This staffing will also support weed abatement efforts by utilizing the staffed engines in the community to conduct weed abatement inspections and other fuels reduction support



Fire District Consolidation – Next Steps

The LAFCO Process will require:

- Filing an Application for Reorganization, comprised of:
 - Application submitted by successor agency
 - A Resolution of Application from each district
 - A Draft Plan of Service
 - Response to Factors and Standards (legal requirements)
 - Request for change to Sphere of Influence of Successor Agency
 - Request for annexations into Successor Agency
