Except as set forth in this First Amendment, all other terms and conditions specified in the Contract remain in full force and effect.

CONTRACTOR SHALL BE RESPONSIBLE FOR THE FOLLOWING DUTIES:

1. Prepare four Medi-Cal Change in Scope of Services Requests (Form 3096), and a Medi-Cal Home Office. Report (Form 3089) for the year ended June 30, 2025, in accordance with the guidelines established by the Department of Health Care Services ("DHCS") based on information provided by you for the following locations:

- 2. Provide accounting and financial reporting support to assist you in compiling accurate data and analysis necessary for the preparation and presentation of the reports described above. This support does not ensure that there will be no material modifications that should be made to the reports for them to be in accordance with the guidelines established by CMS, and DHCS, as identified above.
- 3. Develop a productivity exemption request based on the large volume of homeless visits completed at your locations. This will include collaboration with your fiscal and medical leadership to provide the appropriate reports and supporting information, which will include an attestation from your Chief Medical Officer (CMO) expressing the challenges and barriers to meeting productivity expectations when caring for your vulnerable, homeless population.
- 4. Provide ongoing project management and administrative support to see that the triggering event is completed and that the necessary visits and established workflows continue as expected in order to strengthen your submission of the Change in Scope Service Request.
- 5. Other Ad-Hoc FQHC Strategic Advisory services as requested.
 Estimated time to complete Executive Audit is six months from the date of contract execution. Contractor shall provide monthly progress reports to County indicating activities from previous month and schedule of upcoming activities for the next 30 days.
