Water and Natural Resources Program Manager Misty Kaltreider introduced the item.

California Department of Water Resources (DWR) Manager Steve Rothert provided an overview of the Yolo Bypass Cache Slough Master Plan.

Central Valley Flood Protection Board Program Manager Kristyne Van Skike provided an overview of the Yolo Bypass Cache Slough Partnership.

In response to questions from Supervisor Brown regarding the potential impacts for Solano County of the Yolo Bypass Cache Slough Master Plan and Partnership, Chair Mashburn stated the primary intent of this project is to provide flood relief. Chair Mashburn further stated the plans proposed outcome will be restorative to local habitat in the area. Chair Mashburn further stated the impacts to Solano County are the possibility there will be a loss of agricultural land; however, positive impacts may include an improvement in local habitat and the potential for a new recreational area.

Chair Mashburn commented on issues Solano County has faced with the State imposing projects on Solano County that do not benefit the residents.

Chair Mashburn further stated as DWR begins to create a strategic plan for this project, it is imperative that the residents have a say in the process and that the County realizes some benefits for being the funnel for the flood waters from northern California. Chair Mashburn further stated at the project level there must be assurances that there is flood protection for the Solano County region.

In response to a question from Supervisor Williams regarding what potential flood mitigation tools will be put in place to protect Solano County, Mr. Rothert provided an overview of a potential project, that if approved, will improve certain levees to protect the Rio Vista area.

Director of Resource Management James Bezek introduced the item.

Associate Planner JT Lee provided a brief history of the Green Valley Open Space Maintenance District Assessment program and a brief overview of the Solano Land Trust Annual Report for FY2024/25.

In response to a question from Supervisor Williams regarding the City of Fairfield's assessment costs, County Counsel Bernadette Curry stated the City of Fairfield assesses only parcels that are within the boundaries of the City of Fairfield.

In response to a question from Supervisor Williams regarding if the \$2.50 annual increase is enough to cover costs, Mr. Lee stated the funding goes into an account for the Solano Land Trust to utilize as well as a savings account. Mr. Lee stated there has been no indication that the funding is not covering expenses.

Chair Mashburn opened and closed the public hearing with no comments from the public.

Director of Resource Management James Bezek introduced the item.

Principal Planner Narcisa Untal provided a brief overview of the process for identifying delinquent accounts and stated due to efforts of the garbage companies, many individuals were removed from the list prior to today's meeting.

In response to a question from Supervisor Williams regarding if there is a process to confirm if the individual who owns the property is alive and aware of the debt, Ms. Untal stated each garbage agency was asked to notify every property owner and she will confirm with them that they completed this process.

In response to a question from Supervisor Williams regarding if there is a limit to what residents will be charged, Ms. Untal stated Solano County requires residents to have garbage services, therefore they will continue to be billed. Mr. Bezek stated unpaid accounts will continue to have liens placed on their properties which will restrict the owner from being able to refinance their home or sell their property.

Chair Mashburn opened and closed the public hearing with no comments from the public

On motion of Supervisor Williams, seconded by Supervisor Brown, the Board:

Director of Resource Management James Bezek introduced the item and provided a brief overview of the Suisun Valley Strategic Plan.

Water and Natural Resources Program Manager Misty Kaltreider provided an overview of the infrastructure limitations of the Suisun Valley.

In response to a question from Supervisor Brown regarding the necessity to complete multiple comprehensive sewer studies before the Woodcreek 60 or Rockville Road parcels can be added to the Fairfield-Suisun Sewer District, Mr. Bezek stated there is only a need to complete one comprehensive study.

In response to a question from Supervisor Williams regarding the lack of stakeholder engagement, County Counsel Bernadette Curry stated the Board provided direction to staff to bifurcate the projects, noting staff went forward with the two separate projects as directed by the Board, with plans for a parallel track for stakeholder outreach. Ms. Curry further stated the Fairfield-Suisun Sewer District then refused to move forward with the projects until a comprehensive study is completed.

Supervisor Williams, referencing minutes from a previous meeting, pointed

out stakeholder involvement was supposed to be completed prior to starting the study, stating she will not support the recommended action due to a lack of stakeholder participation.

A lengthy discussion was held regarding stakeholder participation during the comprehensive study.

Chair Mashburn stated staff has no intention of not completing stakeholder outreach, noting they simply are planning on doing it as part of the comprehensive study instead of before.

Discussion was held regarding the parcels that have already been approved for connection, but are being held up by the Fairfield-Suisun Sewer District until a comprehensive study has been completed.

Fairfield Suisun Sewer District General Manager Jordan Damerel stated it is currently illegal for sewer services to be provided to the Suisun Valley because it goes against the Sewer District Enabling Act, which includes some of the Woodcreek 60 parcels and the 2280 Rockville Road parcel. Mr. Damerel further stated the Fairfield-Suisun Sewer District needs to look at these projects holistically instead of bifurcating them to better plan for the future.

In response to a question from Supervisor Brown regarding potential projects in District 2, Mr. Damerel stated the Fairfield-Suisun Sewer District is required by law to plan for areas that are already identified as part of the Fairfield's sphere of influence which could be annexed in the future. Mr. Damerel further stated the areas for today's item have not been designated in a city's sphere of influence. Mr. Damerel further stated the Fairfield-Suisun Sewer District needs to have a better understanding of what the County's plan is holistically for sewer service before they can evaluate what legislative options exist to change the Fairfield-Suisun Sewer District boundaries. Mr. Damerel further stated the Fairfield-Suisun Sewer District is only asking for a review of the areas that are going to funnel into Cordelia so they can ensure their planned upgrades will be adequately sized for future development.

In response to a question from Supervisor Williams regarding when the Fairfield-Suisun Sewer District advised the County it would require a comprehensive study, Mr. Damerel stated it was March 2025.

In response to Mr. Damerel's comments Supervisor Williams stated there was ample time to begin the process of working with the stakeholders and restated she will be voting no on this item because the stakeholders were not met with ahead of time.

County Administrator Bill Emlen stated after receiving the information from the Fairfield-Suisun Sewer District staff realized before spending time on this issue, it was necessary to return to the Board to receive further direction before engaging the stakeholders. Mr. Emlen further stated there are many dimensions to this issue; however, there is going to be an investment by the County in this process, so Board direction was necessary.

Chair Mashburn opened the public hearing and invited members of the public to address the Board on this matter and the following comments were received:

A) Duane Kromm commented in support of delaying the recommended study until the General Plan process takes place.

B) Jim Leland commented in support of delaying the recommended study until the Sustainable Agricultural Lands Conservation (SALC) Infrastructure Committee meets again in September 2025.

C) Cliff Howard commented in support of delaying the recommended study until the SALC Infrastructure Committee meets again in September 2025 and commented in support of staff utilizing the Farm Bureau and several other stakeholder groups for future outreach.

D) Lisa Howard stated there are no requests for sewer services in the Suisun Valley and commented in support of delaying the recommended study until the SALC Infrastructure Committee meets again in September 2025.

E) Don Hofer commented in support of the County moving forward with the comprehensive review.

F) Tamara Gerlach commented in opposition to municipal sewer services within the Suisun Valley.

Chair Mashburn closed the public hearing.

Supervisor Williams made a recommendation to delay the recommended study until the SALC Infrastructure Committee meets again in September 2025.

Supervisor Brown made an alternate recommendation to provide direction to staff to initiate engagement with the Fairfield-Suisun Sewer District.

In response to a question from Supervisor James regarding continuation of the conversation at the August cities summit, Mr. Emlen stated this is the kind of information that would inform the General Plan process. Mr. Emlen further stated timing-wise, it is up to the Board, but this is one piece of the larger process.

Chair Mashburn stated the infrastructure portion of the SALC grant is a viable place for this discussion to take place, noting, however, that the Suisun Valley area and the Suisun Valley Strategic Plan are a minuscule part of the entire project. Chair Mashburn voiced concerns over the potential to have the conversation surrounding the Suisun Valley derail the SALC Infrastructure Committee meeting. Chair Mashburn further stated he does not want to see a situation where the Suisun Valley Strategic Plan is the sole focus of the SALC Infrastructure Committee discussions.

Supervisor Williams requested consensus of the Board for staff time to devote to a town hall meeting prior to the SALC Grant Infrastructure Committee meeting.

Planning Program Manager Allan Calder recommended holding the town hall meeting just prior to the SALC Grant Infrastructure committee meeting.
