## **RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS RECOGNIZING JONATHAN WHITE, MEMBER OF BOY SCOUT TROOP 488 IN VACAVILLE, CALIFORNIA ON ACHIEVING THE EAGLE SCOUT AWARD**

**WHEREAS**, on August 3, 2015 Jonathan White attended the Eagle Scout Court of Honor to commemorate his Eagle Scout achievement. Eagle Scout is the highest award a scout can receive and represents many years of dedicated effort. Eagle Scout is a demonstration of leadership, citizenship and responsibility; and

**WHEREAS**, earning the rank of Eagle Scout is not an easy task. An Eagle Scout project must be completed. Scouts are required to earn at least 21 merit badges, including: First Aid, Citizenship in the Community, Citizenship in the Nation, Citizenship in the World, Communications, Environmental Science, Personal Fitness, Camping, Family Life, Personal Management, Emergency Preparedness or Lifesaving and Hiking. They must serve six months in a troop leadership position; plan, develop and give leadership to a service project for any religious organization or any school or community; and finally take part in a Scoutmaster conference and successfully completed an Eagle Scout board of review; and

**WHEREAS**, Jonathan built and installed four benches for Solano County Land Trust in Lynch Canyon for his Eagle Scout project. The benches were placed in key positions along the trails for hikers to take a rest and appreciate the beauty of their surroundings. Jonathan has spent 62 nights camping, hiked 106 miles, and served 110 hours of community service. Just six months into Jonathan's Boy Scout career, he served as Assistant Patrol Leader and Den Chief to Cub Scout pack 903. As a Troop Youth Leader, he has served in several leadership positions that include Patrol Leader, Assistant Senior Patrol Leader, Senior Patrol Leader and Jr. Assistant Scout Master. Jonathan has earned 40 Merit Badges.

**NOW, THEREFORE, BE IT RESOLVED**, that the Solano County Board of Supervisors does hereby honor Jonathan White for his personal achievements and for his contributions to the citizens of Solano County. In addition, we extend our appreciation to his family members, troop leader and community members that encouraged and inspired Jonathan's achievements.
