## **RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS HONORING PETER LINDEN, INFORMATION TECHNOLOGY ANALYST IV, UPON HIS RETIREMENT FROM THE DEPARTMENT OF INFORMATION TECHNOLOGY, WITH OVER 28 YEARS OF DEDICATED PUBLIC SERVICE TO SOLANO COUNTY**

**WHEREAS**, Mr. Linden began his distinguished career as a Programmer for the Assessor's Office working on Solano County Integrated Property System (SCIPS) on December 23, 1996; and

**WHEREAS**, Mr. Linden was promoted to Programmer Analyst in the Assessor's Office on May 14, 2000; and

**WHEREAS**, Mr. Linden was promoted to Systems Analyst in the Assessor's Office on April 1, 2001; and

**WHEREAS**, while he is working in the Assessor's Office, Mr. Linden facilitated and supported the internal staff with their designated application systems; and

**WHEREAS**, Mr. Linden's position moved from the Assessor's Office to the Department of Information Technology (DoIT) on July 1, 2007; and

**WHEREAS**, Mr. Linden's position was reclassified on December 17, 2017, to an Information Technology Analyst III, supporting Assessor/Recorder, Treasurer-Tax Collector and Auditor Controller's Departments; and

**WHEREAS**, Mr. Linden has built and maintained strong relationships with his business partners and other DoIT teams to foster collaboration and effective support for migration of County Integrated Property System (SCIPS) to Aumentum; and was promoted to an Information Technology Analyst IV on July 12, 2020; and

**WHEREAS**, Mr. Linden is retiring on June 12, 2025, after over 28 years of service and during his tenure, Mr. Linden consistently demonstrated a high level of service and dedication where his impact will continue to be felt for many years.
