RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS HONORING LEONORA W. SALET, IT ANALYST IV, UPON HER RETIREMENT FROM THE DEPARTMENT OF INFORMATION TECHNOLOGY, WITH 25 YEARS OF DEDICATED PUBLIC SERVICE TO SOLANO COUNTY

WHEREAS, Leonora W. Salet has provided 25 years of dedicated public service; and

WHEREAS, Ms. Salet began her distinguished career as a Programmer Analyst for the Assessor-Solano County Integrated Property System (SCIPS) on February 9, 1998, where she redesigned the Assessor Property Tax bill; and

WHEREAS, Ms. Salet promoted to Systems Analyst in the Information Technology Support Team supporting PeopleSoft Human Resources Enterprise Resource Planning (ERP) on January 9, 2000; and

WHEREAS, while working in the Department of Information Technology (DoIT), Ms. Salet facilitated and supported the internal staff with their designated application systems and liaised between Human Resources, Payroll, and IT for technology needs; and

WHEREAS, Ms. Salet promoted to Systems Analyst (Senior) in DoIT supporting PeopleSoft on July 20, 2003; and

WHEREAS, Ms. Salet administered the software application called Paybase/Web Series/C-Series for printing all County checks for payroll, accounts payable and Health & Social Services (H&SS). She worked closely with the IT Operations group, H&SS and Auditor staff to ensure consistent and appropriate use of the Paybase/Web Series/C-Series system to support County operations; and

WHEREAS, Ms. Salet worked on the PeopleSoft Human Resources ERP to implement system upgrades including a new Benefit Administration process, Administer Training Module, numerous County wide reports, queries, and processes; and

WHEREAS, Ms. Salet was reclassified on December 17, 2017, to an Information Technology Analyst IV; and

WHEREAS, Ms. Salet has built and maintained strong relationships with her business partners and other DoIT teams to foster collaboration and effective support for many county departments; and

WHEREAS, Ms. Salet retired on December 1, 2023, after over 25 years of service and during her tenure, Ms. Salet consistently demonstrated a high level of service and dedication where her impact will continue to be felt for many years.

NOW, THEREFORE BE IT RESOLVED, that the Solano County Board of Supervisors hereby recognizes Nora Salet for 25 years of dedicated and loyal service to Solano County and wishes her well in her retirement and future endeavors. She will be missed.
