**RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS  
RECOGNIZING PATRICK STASIO, HEALTH ASSISTANT, UPON HIS RETIREMENT FROM THE  
DEPARTMENT OF HEALTH AND SOCIAL SERVICES,  
FAMILY HEALTH SERVICES DIVISION, WITH 29 YEARS OF DEDICATED  
PUBLIC SERVICE TO SOLANO COUNTY**

**WHEREAS**, Patrick Stasio began his career with Solano County on February 5, 1996, as a Health Assistant in Family Health Services after retiring from the United States Navy with the rank of command master chief petty officer after 43 years of service; and

**WHEREAS**, as a Health Assistant in the Family Health Services clinics, Mr. Stasio utilized his diverse range of health care service-related skills to assist individuals in accessing resources, adopting healthy living behaviors, and navigating systems to improve health outcomes; and

**WHEREAS**, Mr. Stasio has demonstrated an unwavering commitment to improving the lives of underserved, uninsured, at-risk and homeless populations; and

**WHEREAS**, over the last few years, Mr. Stasio worked daily to help at-risk and homeless individuals access healthcare, food, jobs, and services through his role as a Health Assistant and patient advocate with numerous community-based organizations and homeless roundtables; and

**WHEREAS**, Mr. Stasio was a co-founder, former executive director, and longtime supporter of the North Bay Stand Down, a resource fair designed to assist homeless and/or at-risk veterans in Napa, Solano, Sonoma and Yolo Counties by providing a variety of social services, including health screenings, dental care, benefits counseling, and referrals to a variety of other services such as housing, employment, mental health and substance disorder treatment, and employment services; and

**WHEREAS**, Mr. Stasio served as a longtime organizer and committee member of memorial services for local and national homeless residents; and

**WHEREAS**, during the COVID-19 pandemic, Mr. Stasio worked with the COVID-19 response team, which included contact tracing and case investigations; and

**WHEREAS**, Mr. Stasio served as a community health educator, conducting "Opioid Safety and How to Use Narcan" classes; and

**WHEREAS**, Mr. Stasio performed his duties with professionalism, hard work, dedication to the County's service, and dedication to the community and those in need.

**NOW, THEREFORE BE IT RESOLVED**, that the Solano County Board of Supervisors hereby recognizes Patrick Stasio for 29 years of dedicated public service to Solano County and wishes him well in his retirement and future endeavors.
