

**FIRST AMENDMENT TO STANDARD CONTRACT
BETWEEN COUNTY OF SOLANO and SOLANO COUNTY RESOURCE FAMILY ASSOCIATION**

This First Amendment ("First Amendment") is entered into as of the 17th day of October 2025, between the COUNTY OF SOLANO, a political subdivision of the State of California ("County") and SOLANO COUNTY RESOURCE FAMILY ASSOCIATION, ("Contractor").

1. Recitals

A. The parties entered into a contract on July 1, 2025 (the "Contract"), in which Contractor agreed to provide enrichment activities to foster youth with Flexible Family Support AB 179.

B. The County now needs to modify the scope and budget of the Contract.

C. This First Amendment represents an increase of \$86,747 to the Contract.

D. The parties agree to amend the Contract as set forth below.

2. Agreement.

A. Amount of Contract

Section 3 is deleted in its entirety and replaced with: The maximum amount of this contract is: \$336,747.

B. Scope of Work

Exhibit A is deleted in its entirety and replaced with the attached scope of work incorporated into this First Amendment as Exhibit A-1.

C. Budget.

Exhibit B-1 is deleted in its entirety and replaced with the attached budget incorporated into this First Amendment as Exhibit B-1.1.

3. Effectiveness of Contract.

Except as set forth in this First Amendment, all other terms and conditions specified in the Contract remain in full force and effect.

EXHIBIT A-1
SCOPE OF WORK

A. CONTRACT DESCRIPTION

The Contractor shall provide community-based and stabilization services to support children and youth in out-of-home care and their Resource Families.

B. WORK ACTIVITIES

Under this Contract, the Contractor shall provide the following:

1. Respite care.
2. Support the costs to facilitate a foster caregiver's, relative caregiver's, or a nonrelative extended family member's (NREFM) and child's participation in child and youth enrichment activities that are not covered by the caregiver-specific rate or income that would stabilize the placement or enhance the child's well-being
3. Provide extracurricular and enrichment activities designed to enhance the foster child or nonminor dependent's skills, abilities, self-esteem, relationships, and overall well-being and healing, and include, but are not limited to, the following:
 - a) Lessons or time spent engaging in music, dance, or drama.
 - b) Summer camp attendance, including travel, supplies, and/or equipment.
 - c) Sports team or activity participation, including transportation, supplies, and/or equipment.
 - d) Community activities.
 - e) Trips and excursions.
 - f) Other age-appropriate activities, including hobbies and activities, chosen by the child or nonminor dependent that are provided in a formal or informal setting and provide healing and/or help the youth establish supportive relationships.
4. Facilitate group enrichment activities annually for youth and/or caregivers. Activities shall be designed to foster peer connection, build support networks, increase placement stability, and promote community engagement.
5. Support to enable or continue a foster child's relative or NREFM connections, which may include a child's tribe, tribal community, or tribal cultural events in the case of an Indian child.
 - a) It is important to maintain social and cultural connections to family and community, both when a child is placed with a relative or NREFM or when placed in another home-based setting. For example, support provided under this category may include transportation to enable the child or family member/extended family member to visit and participate in activities together.
6. Concrete costs associated with facilitating a placement with a relative or NREFM, or extended family member as defined in WIC Section 224.1 in the case of an Indian child, who otherwise would be unable to take the placement due to current housing arrangement limitations.
7. Concrete costs include the provision of financial assistance, including assistance needed to expediently resolve a Corrective Action Plan or other home environment assessment issues, including, when necessary for the well-being of the child, moving costs when the caregiver needs to move to a larger home, e.g., to take in sibling sets.

8. Provide Placement Stabilization Supports
Provide for urgent placement-related needs, such as safety modifications (e.g., pool fencing, locks) and other supports necessary to maintain safe and stable placements.

C. PERFORMANCE MEASURES

Contractor will:

1. Respite Support: Provide respite care for a minimum of 100 children in Solano County-approved resource homes.
2. Annual Foster Care Picnic: Provide food and supplies for up to 500 participants.
3. Resource Parent Appreciation Event: Provide rental event space and supplies for up to 100 participants.
4. Resource Family/Foster Youth Support: Provide supports and extracurricular/enrichment activities for a minimum of 80 foster youth annually, including individual and group-based activities that promote normalcy, connection, and well-being.
5. Placement Stabilization Supports: Provide urgent, safety-related placement supports (e.g., pool fencing, home modifications) as needed to preserve safe and stable placements, with documentation of type and frequency of supports provided.
6. Group enrichment activities: Facilitate a minimum of six (6) activities annually designed to foster peer connection, build support networks, increase placement stability, and promote community engagement.
