A) George Guynn, Jr. commented on the protection of 2nd Amendment rights and the June 4, 2024, presentation of a resolution for Gun Violence Awareness Month.

Supervisor Hannigan commented on the Gun Violence Awareness Month resolution that the Board presented on June 4, 2024, noting that she did not at any time advocate for the removal of the right to own a firearm.

B) Solano County Veteran Resource Center Coordinator Amy Kennedy provided an invitation to the Solano Community College Student Women Veterans Recognition Day Open House on June 12, 2024.

Principal Management Analyst Matthew Davis introduced the item.

Metropolitan Transportation Commission (MTC) Commissioner Jim Spering provided an overview of the Bay Area Housing Finance Authority (BAHFA) Bay Area Affordable Housing Bond measure.

Supervisor Williams commented in support of the BAHFA Bay Area Affordable Housing Bond measure. Supervisor Williams requested staff return with a presentation to the Board from BAHFA regarding this program.

Supervisor Vasquez commented in support of the BAHFA Bay Area Affordable Housing Bond measure.

Chair Mashburn commented in support of the BAHFA Bay Area Affordable Housing Bond measure.

Commissioner Spering provided a brief overview of the MTC review of Plan Bay Area 2050, the withdrawal of Senate Bill 1031, and funding issues for transportation throughout the Bay Area.

Federal legislative advocates Joe Krahn and Hassan Sarsour provided an update on information on federal legislation of interest to the County.

In response to a question from Chair Mashburn regarding a requested earmark for Markley Lane, Mr. Krahn stated the earmark for the Markley Lane Extension Project has been submitted by Congressman Garamendi in the amount of \$5,000,000 and it is currently with the Transportation and Appropriation Committee.

Supervisor Vasquez commented on the current Farm Bill, noting there needs to be a bipartisan solution to issues states are facing in agriculture.

Chair Mashburn thanked Congressman Garamendi and the City of Fairfield for putting forward the earmark request for the Markley Lane Extension Project.

State legislative advocate Paul Yoder provided an update on information on state legislation of interest to the County.

Mr. Davis provided an overview of CA Initiative 1935.

In response to a question from Supervisor Brown regarding what agency would be responsible for paying for elections that might be required as a result of CA Initiative 1935, Mr. Yoder stated the local agencies would be responsible for the required elections.

In response to a question from Supervisor Vasquez regarding the case before the U.S. Supreme Court on impact fees, County Counsel Bernadette Curry stated the Supreme Court has already ruled on that case issuing a decision requiring a certain level of analysis with regard to the impacts, noting local agencies will have to show the true impact of the nexus of what they are collecting as to the impact of the services provided.

Ms. Curry further stated CA Initiative 1935 is still pending before the Cal Supreme Court which has not yet made a decision on the argument of constitutional overreach. Ms. Curry further stated it is appropriate that the Board take action on the item today; however, there is a possibility it will not actually make it to the ballot.

Supervisor Hannigan commented in opposition to CA Initiative 1935 and recommended the Board send a letter of opposition to the initiative.

Chair Mashburn invited members of the public to address the Board on this matter and the following comments were received:

A) George Guynn, Jr. commented on various pieces of legislation related to increased taxes.

On motion of Supervisor Hannigan, seconded by Supervisor Williams, the Board approved a letter of opposition for California Initiative 1935, the Taxpayer Protection and Government Accountability Act (2024) (21-0042A1). So ordered by a 5-0 vote.

Director of Resource Management James Bezek introduced the item.

Senior Planner Eric Willberg provided an overview of the recommended action to approve a lot line adjustment application.

In response to a question from Supervisor Williams regarding why this item wasn't able to be heard at the Planning Commission level, Mr. Wilberg stated items like this would typically go before the Zoning Administrator; however, because this particular item involves Williamson Act contracts, it is required to go before the Board of Supervisors for approval.

In response to a question from Supervisor Hannigan regarding the division of sales tax when a portion of the property resides within the unincorporated County and a portion of the property resides in the city, Mr. Emlen stated taxes are decided based on the point of sale which would be on the parcel that is within the unincorporated County.

In response to comments from Supervisor Hannigan regarding the need for information on the division of taxes when a property is in both a city and the unincorporated County, Mr. Emlen stated staff can add that information to future reports.

In response to a question from Supervisor Hannigan regarding if this project will impact any of the current projects for Hwy 680, Hwy 80 and Hwy 12, Mr. Wilberg stated he will look into it and provide information to the Board.

In response to a question from Supervisor Vasquez regarding landscaping requirements, Mr. Wilberg stated a landscaping plan was submitted with the

application, noting drought tolerant and native species plants are in the landscaping plan.

Supervisor Hannigan recommended staff create a plan for the future regarding landscaping on County properties.

In response to comments from Supervisor Vasquez, Mr. Emlen stated based on comments by the Board staff will work with the applicant on putting in drought resistant landscaping.

Chair Mashburn opened the public hearing.

A) Representative for the applicant Robert Karn commented on the recommended action, noting it is a relocation of a current facility. Mr. Karn stated the applicant will be selling trucks only and all sales will take place on the parcel that is within the unincorporated County boundaries. Mr. Karn further stated the property within the City of Fairfield is for stormwater management only.

Chair Mashburn closed the public hearing.

Supervisor Vasquez commented on signage along the highway and the potential for revenue from advertising, recommending staff look into if there is a prohibition on signage along the highways in Solano County.

In response to Supervisor Vasquez's comments, Mr. Calder stated a proposal for a series electronic billboards along Highway 80 and Highway 505 was recently before the Airport Land Use Committee.

On motion of Supervisor Hannigan, seconded by Supervisor Williams, the Board: 1) read the proposed ordinance by title only: An ordinance amending Chapter 28 Section 28.32 of the Solano County Code (Zoning Regulations) to include automobile, mobile home, recreational vehicle, truck, or boat sales lot as a conditionally permitted land use within the Residential-Traditional Community Mixed Use Zoning District Application No. Zt-20-01; 2) waived further reading by majority vote; 3) adopted Ordinance No. 2024-1855 to approve Zone Text amendment ZT-20-01; and 4) adopted Resolution No. 2024-109 approving Minor Use Permit MU-20-05. Chief Information Officer/Registrar of Voters Tim Flanagan introduced the item and provided an overview of the importance of modernizing the current radio system, the County's VHF system, and the state of the County's current P25 solution.

Regional Services IT Manager Stuart Bruce provided an overview of the future of the P25 public safety radio expansion project.

In response to a question from Supervisor Vasquez regarding if the Southhampton Radio Shelter is anchored down with a foundation, Mr. Bruce stated he is uncertain; however, it would take hurricane force winds to move it.

Mr. Flanagan provided an overview of the opportunities that will be afforded to the County once all agencies are on a single network. Mr. Flanagan provided overview of potential future phases of the P25 public safety radio expansion project.

Supervisor Vasquez thanked staff for their efforts on the completion of the project, noting investment in this project is critical to making the system work.

Supervisor Hannigan stated this is a great step forward to the creation of a consolidated dispatch.

In response to a question from Supervisor Hannigan regarding coverage of Hiddenbrook and Lake Herman Road at Columbus Parkway, Mr. Bruce stated the Hiddenbrook area is covered by the current system. Mr. Bruce further stated there are possible gaps in coverage in the area along Lake Herman Road. Mr. Bruce noted that some areas might have limited coverage, but will not show up on the map because they don't meet the 95% success rate that is required for an area to be considered as having full coverage. Mr. Bruce stated he will provide the Board with maps that specifically show the Hiddenbrook area coverage.

Chair Mashburn invited members of the public to address the Board on this matter. There was no public comment.

On motion of Supervisor Hannigan, seconded by Supervisor Williams, the Board: 1) approved a contract with Motorola Solutions for \$5,547,613 for a term of July 1, 2024 through June 30, 2027 to complete the Solano South Simulcast P-25 public safety radio expansion; 2) approved an agreement with CellSite Solutions, LLC, for \$172,446 for purchase of a public safety radio shelter for the Benicia Southampton tower site; and 3) delegated authority to the County Administrator to sign the contracts and any subsequent amendments, with County Counsel concurrence, up to \$74,999 of the contract amount within annual appropriations. ## 16 **24-413**

Receive a presentation from recipients of American Rescue Plan Act funds to increase capacity to serve people experiencing homelessness

Principal Management Analyst Megan Richards introduced the item.

Assistant to the City Manager for the City of Vallejo Natalie Peterson thanked the Board for the allocation of funding for the two City of Vallejo projects. Ms. Peterson provided a progress update on the Broadway Homekey project.

In response to a question from Supervisor Brown regarding the disbursement of funding for the Broadway Homekey project, Ms. Peterson stated with the current funding projection, the additional funding provided by the City of Vallejo was an overestimate to provide a buffer for any potential time delays, noting the City of Vallejo wanted to make sure that there was more funding allocated than what was needed, with the intention of returning any unspent Measure P funds. Ms. Peterson further stated that all allocated ARPA funds will be expended by December 30, 2026. Ms. Peterson stated staff will continue to communicate with the Board if there are any issues or delays with the project.

Homeless Services Manager for the City of Fairfield Samantha Burrows thanked the Board for the allocation of funding for the Beck Avenue Navigation Center. Ms. Burrows provided a progress update on the Beck Avenue Navigation Center.

Ms. Richards provided an update on the progress and purchase of a house for My Friend's House, noting the goal of this project was to purchase the house, which has been met.

In response to a question from Supervisor Vasquez regarding if there was a deed restriction on the purchase of the house, Ms. Richards stated she does not know if there was a deed restriction placed on the house; however, she does know there was a contract restriction to be a shelter for a certain period of time.

Supervisor Hannigan thanked the agencies for bringing forward updates on the projects, noting that they will provide housing and services to those who need it most.

Supervisor Brown commented on the Beck Avenue Navigation Center Culinary Institute and requested updates be provided to the Board on services that are provided.

Supervisor Mashburn thanked the County's partners for bringing the projects forward, staff for ensuring the projects are moving forward, and the Board for approving investments in the community that will help people.

Supervisor Williams requested updates on the progress of the Beck Avenue Navigation Center.

Chair Mashburn invited members of the public to address the Board on this matter. There was no public comment.

Principal Management Analyst Megan Richards introduced the item and provided an update on projects with pending obligation deadlines.

Supervisor Vasquez commented in support of the Housing Trust Fund agricultural housing project.

In response to a question from Supervisor Brown regarding the eligibility of non-profit agencies that have already received funding, Ms. Richards stated the Board will be able to provide direction on the Request for Qualifications/Request for Proposals (RFQ/RFP) guidelines.

Supervisor Hannigan commented in support of all non-profits being eligible for funding but noted that she has concerns regarding the \$500,000 amount of funding that is being recommended.

In response to Supervisor Hannigan's comments, Assistant County Administrator lan Goldberg stated it was intended to be up to \$500,000 awards, depending on the applicants and the projects proposed, noting there may be several smaller requests or one large request.

In response to Mr. Goldberg's comments, Ms. Richards stated the reason why the amount of \$500,000 was chosen was because staff was aware of several projects that had been previously submitted that would be large one-time funded projects.

Supervisor Mashburn commented in support of releasing an RFQ/RFP. Supervisor Mashburn further stated he would like to see preference given for proposals that have public/private partnerships to leverage funding.

Supervisor Brown commented in support of allocating additional funding toward food security or rental assistance programs.

Supervisor Vasquez requested a spreadsheet at future presentations. Supervisor Vasquez requested the discussion be continued to June 25, 2024 so the Board has more information.

In response to a question from Supervisor Vasquez regarding if the funding that has been allocated to the Tabor Commons project must have Board approval to

be reallocated, County Counsel Bernadette Curry stated the Board will eventually need to take action on the funding because the Board did allocate those funds specifically to the Tabor Commons project. Ms. Curry further stated today staff is asking for Board direction on where to reallocate those funds, noting that staff will then bring back an item for the Board to take action on.

Supervisor Williams commented in support of allocating funding to nonprofit agencies, rental assistance programs and for the purchase of the Parkrose Gardens project.

Supervisor Mashburn made a motion to allocate \$1,000,000 to an RFP/RFQ for nonprofit agencies with no cap for the project amount.

Supervisor Hannigan made an alternate motion to allocate \$500,000 to an RFP/RFQ for nonprofit agencies with no cap for the project amount per the recommended action.

Ms. Richards stated the recommended action was for up to \$500,000 per project allocation over 2 years, with no recommendation on the amount of funding allocated by the Board for the RFP/RFQ.

A discussion period was held with no action taken.

Ms. Richards provided information on potential homeless prevention programs and on a potential permanent supportive housing project called Parkrose Gardens.

Chief Deputy of Behavioral Health Emery Cowan provided an overview of the current mandates that will require the County to provide residential and permanent supportive housing. Ms. Cowan stated the Parkrose Gardens project will provide 52 single unites or 104 double occupancy units. Ms. Cowan noted that ongoing costs will be covered by Prop 1 funding, noting that they are now required to use 30% of the Prop 1 funding for housing which will help sustain residential beds.

Chair Mashburn commented on potential staffing and funding issues with the purchase of Parkrose Gardens, requesting staff provide more information to the Board.

In response to a question from Chair Mashburn's comments, Ms. Cowan provided an overview of potential funding options to pay for ongoing expenses of the facility should the County purchase it.

Discussion was held with no action taken.

In response to a question from Supervisor Brown regarding potential fines if the County does not have residential housing, Ms. Cowan provided a list of mandates that will be going into affect that will require the County to provide housing.

Supervisor Hannigan and Supervisor Williams commented in support of staff returning with more information on the ongoing costs of purchasing the Parkrose Gardens facility.

County Administrator Bill Emlen provided options that the Board could vote on today, noting the Board could vote on reallocating funding into Revenue Recovery and provide direction to staff regarding the RFP/RFQ for nonprofits.

A discussion period was held.

Chair Mashburn invited members of the public to address the Board on this matter and the following comments were received:

- A) George Guynn, Jr. commented in opposition to the use of funds for homeless housing.
- B) City of Suisun City City Manager Bret Prebula made a request for ARPA funding for the refurbishment of the City of Suisun City Senior Center to be potentially used as a navigation center.

Supervisor Williams commented in support of Mr. Prebula's request noting that the City of Suisun City has not previously requested any ARPA funding from the County.

Supervisor Hannigan and Chair Mashburn withdrew their previous motions.

On motion of Supervisor Hannigan, seconded by Supervisor Williams, the Board reallocated \$1,620,929 in ARPA Coronavirus State and Local Fiscal Recovery Funds from the category of Administration to the category of Revenue Replacement. So ordered by a 5-0 vote.

On motion of Supervisor Hannigan, seconded by Supervisor Williams, the Board directed staff to prepare a Request for Qualifications directed to non-profit organizations for ARPA-eligible services according to ARPA Treasury Guidelines. So ordered by a 5-0 vote.
