I have read the board minutes for the last three years and two Civil Grand Jury reports relating to library system. As I suspected, based on my personal experience as a Vallejo resident since 2000 has been confirmed and the system is well run and contributes to the many different segments of our community. My goal would be to help this continue by contributing my perspective and experience as a library user, If I helped the library system achieve their mission and vision, it would be mission accomplished.

* As a member of this board/council/committee/commission, what do you think you might contribute to help it fulfill its missions and goals?

My main contribution to the board would be the perspective that I bring to it. I have been using libraries in Solano County since I moved here in 2000. I understand that a library is more than books and I and my wife had made use of many, though not all of the services available. (I will be checking out a ukulele from the Springtowne branch sometime.) I also understand that the library is more than a repository of knowledge and entertainment. It is also a place where the unsheltered can go during the day, especially in inclement weather, as well as a place where students can go after school before their parent(s) return from work. I especially appreciate the hanging out feature of the library and take advantage of it when I accompany my wife out of town when she is visiting with friends and my presence is not needed. I have never worked in a library, but I know that the role of the librarian has changed, with social worker being thrown into the mix.

Besides my decades of experience being a consumer of library services, my work experience would help advance the mission of the library. I have experience with budgets, I spent years developing goals for district offices and reviewed those goals, and I have served as a reviewer and been reviewed many times concerning the achievement of goals. I am concerned with diversity and inclusion, as the library is as outlined in their vision statement. During my work career, which is discussed in the attached resume. I am also used to committee work, having served on the High Intensity Drug Task Force Committee and committees that prepared training courses on basic supervision, advanced financial investigative techniques, and anti-money laundering. Of course, these are generally not topics of concern with a library system, but the skills learned and used on these committees are universal.

Finally, one of the Civil Grand Jury reports covered "book banning" which is a topic that I am very concerned with. From reading the report and the library response, it is apparent that there is a well thought out procedure to deal with this issue. If the library system is ever faced with controversy in this area, I would contribute by being supportive of the library so that they could continue with their mission to "spark curiosity, inspire creativity, and champion learning."
